11081 PRESIDENT'S REPORT

Discussion covered the following key points:

The parking lot on the north east corner of the campus is not available for parking over the summer months. Some trees were cut down out of necessity but the remaining trees will be kept in place.

11082 QUESTION PERIOD

Discussion covered the following key points:

- Question: Will the campus become non-smoking? Answer: This is a health and safety issue and is on the agenda of the health and safety committee. They are considering a phased approach with an education component at each phase.
- Student Senators advised that SMUSA supported this approach.
- Question: Does the new SMU Electric Car have a parking space set aside for it? Answer: Yes. It is a leased Nissan Leaf and it can be borrowed from the security desk in the McNally building. You must be 25 years of age or over and you will need a brief training session before you use it for the first time. It is charged overnight in the Loyola colonnade. The range is 209 km but in the winter with the higher energy demands this might decrease. It is a 240 volt charger so you have to have it back to the garage by the end of the working day.
