14058 SAINT MARY'S UNIVERSITY 2015-2016 OPERATING BUDGET

Presentation by Darrell Rooney and Gabe Morrison

Key Highlights:

- This budget will be submitted to the Board of Governors for consideration on March 25th. After approval, the presentation file will be made available to Senators
- This is not a balanced budget as required by our Board of Governors but is strategically aligned to what we have to achieve in the next year.
- External influences continue to play a significant role.
- Through various Senior Management initiatives and a hiring chill, we have been able to close the gap almost completely for the 2014-2015 year.
- We created a three-year budget recovery strategy that has been endorsed by the Executive Management Group. The University will returning to a balanced budget in 2017-18.
- Key Decision Drivers:
 - o Initiatives that drive undergraduate enrolment were given priority.
 - Ensuring the continuation of the AACSB Accreditation for the Sobey School of Business.

- Initiatives that assist students through their continuum with the university were a priority (recruitment, enrolment, student life and student success; providing funding for orientation activities for new students and other President's Council initiatives).
- The impact of proposed permanent reductions was weighted against the resulting benefit of strategic reallocations. Each unit contributed to solving the budget situation through reductions and/or new revenue initiatives.
- Budgets were adjusted to reflect the 'actual costs' of providing ancillary and auxiliary services. Budgets were reset for key areas that drive student enrolment.
- o Efforts were put into creating a sustainable budget model for athletics and recreation.
- o Budgeting for a contingency relating to risks on: Government grant, Fall 2015 enrolment, other unknowns).
- Presentation of budget details followed by an opportunity for questions and answers.

- Question: Concern was expressed regarding the challenges that interdisciplinary programs face. What is the university doing to address this issue? Answer: There are a number of interdisciplinary programs being reviewed this year. SMU has a great deal of strength in this area. Academic Planning will be taking steps to attempt to assess this issue in a more academic approach.

 - Senate discussion regarding an academic discipline case that involved a student paying another individual a significant sum of money to take a difficult course for them.
 - The hearing panel met and submitted recommendations. There
 were two options to dismiss the student or to allow some
 leniency if the student revealed the name of the student who was
 the deal broker.
 - This was a highly professional job and the student was very professional in their performance of this service. They had a false ID which was validated by the library and by SMUSA when they issued the student a UPass. The impersonator was able to get through the first term without being caught.

Moved by Patriquin and seconded, "that the Senate meeting be continued for an additional 15 minutes to allow for further discussion." Motion carried.

- The University Librarian advised that it would not be a significant issue to include photos on IDs. Library and SMUSA staff could also be trained to identify false IDs.
- o IDs are the property of the university and are confiscated when the situation warrants.
- Senate was asked to consider our approach to academic discipline.
