Dues Abolished!!!

At the Annual Meeting of the Alumni Association in April 1980, a resolution was passed directing the Executive to investigate the issue of Alumni Dues, including the possibility of abolishing dues and replacing them by some other more appropriate method of contributing to the Alumni Association and/or University.

A committee under the Chairmanship of Alumni Past President Pat Curran was established. The Curran Committee reviewed the practice of dues collection at other Maritime universities as well as a select number of universities from other parts of Canada.

Among the conclusions reached by the Committee were:

- (1) There is a need for larger Alumni contributions to the University.
- (2) The existence of dues can be a disincentive to make other gifts to the University.
- (3) Dues should be abolished and full membership should not be based on any contribution to the University.
- (4) If dues are abolished, permanent plasticized Alumni Membership Cards might be used.
- (5) If the Alumni Association is to operate without dues, there would have to be more contact and better public relations between the Association and the membership.

At a special meeting of the Alumni Association held January 15, 1981, a motion was passed stating "The Constitution of Saint Mary's University Alumni Association be amended to abolish dues and eliminate all references to dues."

The motion was adopted unanimously.

President's Annual Report 1980/81

I was honoured to have had the opportunity to be your Alumni President and have enjoyed the challenge immensely. I was also fortunate to have a co-operative and enthusiastic Executive who made the year a most rewarding experience.

Acknowledgements

I am pleased to say that the new members this year, serving on the Executive, Resident Members—Mary Jane Andrews, Richard Bishop, Jim Crane, Peter Halpin; Non-Resident Members—Bob Healy and Darrell Maxwell, and Board of Governor Representatives— Pat Curran and David Murphy brought fresh ideas and reinforced an existing sense of enthusiasm for Saint Mary's.

I would also like to take this opportunity to mention the names of our other Executive members and to publicly thank them for their continued support and involvement throughout this year. Resident members— Brian Donovan, Ed Fitzpatrick, Don Keleher, Brian O'Byrne. Non-Resident members—Aileen Carroll and Reg MacDougall and Board of Governor Representatives—Robert Napier, Nick Walsh, Joe Power, Pat O'Neil. I would also want to acknowledge our Moderator, Father O'Donnell, whose continuing support is of great personal satisfaction to all members of the Executive.

Alumni Staff

This past year has seen the recognition by the University of the importance of a strong and viable Alumni Association. Our strength comes from the increase in staff from two persons to four. Our Director, Laurie Smith, and his capable secretary, Paula McGrath, have worked beyond the call of duty to keep the Alumni Office and the Executive functioning. Their dedicated service does not go unnoticed. Recently the University made available two additional staff persons to help the Alumni office. Belinda Gallagher has been appointed Assistant to the Alumni Director and will be involved in special assignments covering the range of the Maroon & White, working with the recent Graduating Classes, and other special assignments. Heather Church has been added specifically to update our membership list. The two additional persons will significantly increase the effectiveness of our operations.

Dues Abolished

At the Annual Meeting in April 1980, a motion was passed calling upon the Executive to review the question of annual dues. A Committee headed by Past President Pat Curran presented a report to a Special Meeting of Alumni in January 1981 calling for the elimination of dues. The report was adopted unanimously.

The Curran report suggested the establishment of an

Annual Alumni Fund, permitting Alumni to designate their donation (tax deductible) to any sphere of university life—Library, Alumni Association, scholarships, Athetics. This new approach has now been implemented and I call upon all Alumni to contribute to Saint Mary's in this more flexible and appropriate fashion.

Alumni Chapters

This past year saw increased activities by our various chapters. Special Events were held by our Calgary group; a successful December Dinner held by our Toronto group; various gatherings organized by the Ottawa group; and evidence of continued loyalty and dedication from New England Alumni. As well, work commenced on establishing chapters in Saint John and Moncton, New Brunswick; Bermuda and Hong Kong. The number of visits to communities within Nova Scotia was stepped up.

Every effort must be made to continue the ties already established over the past several years with these Chapters. Certainly with our increased staff complement, we will be in a better position than ever before to respond to their many initiatives.

Social Events

As mentioned in my opening, there were many successful events carried out over the past year. Certainly the Golf Tournament, ably coordinated by Karl and Granville Kelly, was a great success. The large turn-out speaks well of the reputation gained by the event in previous years of providing a vehicle to renew friendships and comraderie which is so much a part of St. Mary's.

Our Annual Dinner focused on the International Year of the Disabled. The Alumni Association presented awards to individuals and organizations who have contributed to making Saint Mary's University an institution aware of the needs of disabled persons. Among those receiving awards were Robert Mercer, Executive Director of the Canadian National Institute for the Blind and a Saint Mary's Alumni; Don Curren of the Atlantic Division of the Canadian Paraplegic Association; the Community Resource Tape Library of Saint Mary's; the Provincial Department of Education accepted by the Minister of Education, the Honourable Terrence Donahoe, a Saint Mary's Alumni; and the Honourable Edmund Morris for his many efforts during his employment with St. Mary's, ensuring the physical plant facilities were appropriate for disabled students. The Honourable Gerald Regan, Minister of Labor and Minister Responsible for Fitness and Amateur Sport, was the Guest Speaker.

The Dinner was a class event, one which will be hard to top in the future. Much credit for its success goes to our Alumni Vice-President, Don Keleher, and his Committee for organizing such an eventful evening.

In the coming year, your new Executive will continue to face a number of nagging issues. These include the need for more volunteers to help the Executive organize and implement more functions for Alumni; continue to strengthen our existing Chapters and promote the establishment of new Chapters; encourage Alumni to provide the financial support to make the Alumni Association more financially viable; encourage Alumni to consider Saint Mary's for a yearly financial donation; informing Alumni of the excellent academic achievements of the faculty and students at Saint Mary's; promoting the idea of Alumni representation on the Academic Senate of the University. As well, a full overhaul of our present Constitution is a major initiative which should be undertaken in the very near future.

For my part, I have been honoured to have had the opportunity to serve as President of the Alumni Association. Unfortunately, the one year term has not permitted me to initiate and implement the many other measures I would have liked to tackle. However, it is my intention to continue to be involved in Alumni affairs and be a full-time Past President and help the new Executive in whatever way possible to continue the Association's growth.

Again many thanks for the opportunity to serve you. I hope my year has been beneficial in furthering the growth of our Association and emphasizing the fine alma mater we have and cherish.

Message From The President

Help Wanted:

In the last edition of the **Maroon and White**, I tried to develop the theme that as Alumni, we all have a responsibility to continue to support our alma mater. This support could take the form of financial contributions, recruitment of new students or assisting graduating students to find rewarding employment, just to name a few.

These areas of support relate back to a number of the objectives of the Alumni Association as stated in the Constitution:

- 1. to unite the Alumni and maintain an organization of Alumni.
- 2. to perpetuate the close and kindly ties of friendship formed during attendance at the University.
- 3. to foster these ties through all appropriate means including meetings, gatherings and an official publication.

It has become clear over the past year that we are only scratching the surface in meeting the stated objectives of our Association.

To emphasize the point, one only has to look at the makeup of the Alumni office and the Alumni Executive charged with the responsibility of carrying out the mandate of our Constitution. Until recently, the Alumni office consisted of Laurie Smith and our secretary, Paula McGarth. Both are truly dedicated individuals, working beyond the call of duty to keep the Association ticking. Your Alumni Executive consists of 15 individuals, six of whom are members of the Board of Governors of the University. Thus, to a large extent, the remaining nine members of the Executive must try to organize and implement Alumni activities. To be quite honest, it is a difficult, if not impossible, task.

Through the hard work of Don Keleher, Vice-President of the Alumni Association, and his committee, the best ever Annual Alumni Dinner was held in December. Our Golf Tournament was organized entirely by two dedicated alumni, Granville and Carl Kelly, who volunteered their time to make the event a success. Also this year, the volunteer work of Kent Ritchie helped to get the 1st Tennis Tournament off the ground.

However, we need more volunteers if we are to begin to come close to meeting our objective of "perpetuating the close and kindly ties of friendship". Our needs range from finding a part-time Editor of the **Maroon and White**, to a person to coordinate the Sunday skating sessions, to Alumni spending an evening or two reviewing membership lists.

Suggestions for social activities including a Fall Boat Cruise; Fall Corn Boil; Senior Class function with Alumni; Flea Market; Monte Carlo night; Varsity Club, etc. all had to be put aside because the people power has not come forward.

Perhaps Alumni are not interested in this type of activity! However, I maintain after talking to many Alumni throughout the province, seeing the enthusiasm of our Ottawa, Toronto, Calgary and Saint John Chapters, that indeed Alumni do care about Saint Mary's.

This is a request or plea to become more actively involved in your Alumni Association. If we are to meet the objectives of our Constitution, we must have more volunteers; we must have alumni committed to furthering the life of this institution.

I would certainly like to hear from Alumni, whether it be in a negative or positive vein. At least I will know that you have read this article and reflected upon the dilemna that your Alumni Executive finds itself in when it seeks to implement the objectives of the Association's mandate.

Annual Alumni Fund Established

Even though Alumni dues have been abolished, many Alumni may be wondering why we would give up the \$6,000 received through Alumni dues each year. Well, to be quite frank—it is not enough!

It is felt that a new system of contributing to Saint Mary's University is long overdue. It is time that our Alumni activity supported, in a tangible way, the many ongoing activities at this institution on an annual basis. The new format is no different than that which has been in place for the last several years at Mount Allison, Dalhousie and many other universities across the country. Indeed Mount Allison University requested that its Alumni Association establish as its target for raising funds in 1980/81, the sum of \$100,000.

While there is quite a difference between \$6,000 and \$100,000, it is certainly within the realm of possibility that St. Mary's Alumni could provide more financial support if required. To this end, the Alumni Executive recently established a new format for contributions—the Annual Alumni Fund.

Alumni wishing to contribute to the fund will be able to designate their fund gift into the following categories:

- (1) Scholarships—The University presently has a small scholarship fund and additional funds will make it possible for Saint Mary's to be competitive in attracting more quality students to the campus.
- (2) **Library**—There is always a need for more books and through designation of monies to the Library, the University will be able to increase the volumes of books available to students.
- (3) Athletics—In the field of athletics, it has been necessary for the University to freeze the Athletic Budget for the past six years. Funds designated in this area will be directed toward the recreational requirements of students.
- (4) Other [specify]—There are many other aspects of the University community which could use your financial support—the Atlantic Studies Program, the Asian Studies Program, the Debating Society, the Drama Society, the Art Gallery, one of the Faculties, perhaps an individual Department—to name just a few.
- (5) Alumni Association—And, oh yes, the Alumni Association itself to provide funding to establish Alumni chapters throughout Canada and the United States; to assist in the cost of producing and sending out the Maroon and White; to provide more social functions for Alumni.

Cheques should be made payable to Saint Mary's University and a tax receipt will be issued for any contribution of \$10.00 or more.

The Alumni Executive hopes Alumni at large will respond to this new means of raising funds for Saint Mary's University.

\$1.8 Million in Federal Aid
