The Reverend William A. Stewart S.J., Medal for Teaching

Saint Mary's University Alumni Association has established an award to recognize faculty members who have made an extraordinary contribution to the education of Saint Mary's students through teaching, in the Saint Mary's tradition of quality undergraduate education. The award is open to faculty members who have rendered at least five years of teaching service at the University.

You are invited to nominate a candidate. Each nomination must be supported by the names of at least ten persons from among alumni, faculty and students. The nomination must be accompanied by a brief statement concerning the faculty member in support of the nomination.

Nominations will be reviewed by a five member selection committee composed of three persons nominated by the Alumni executive, one member of faculty nominated by the Saint Mary's faculty union and one member of the student body nominated by the students representative council.

In making its recommendation to the Alumni Executive, the selection committee will have regard to the following factors in making its decision, as well as any other factors considered pertinent:

- 1. Teaching ability and classroom performance.
- 2. Interaction with students.
