

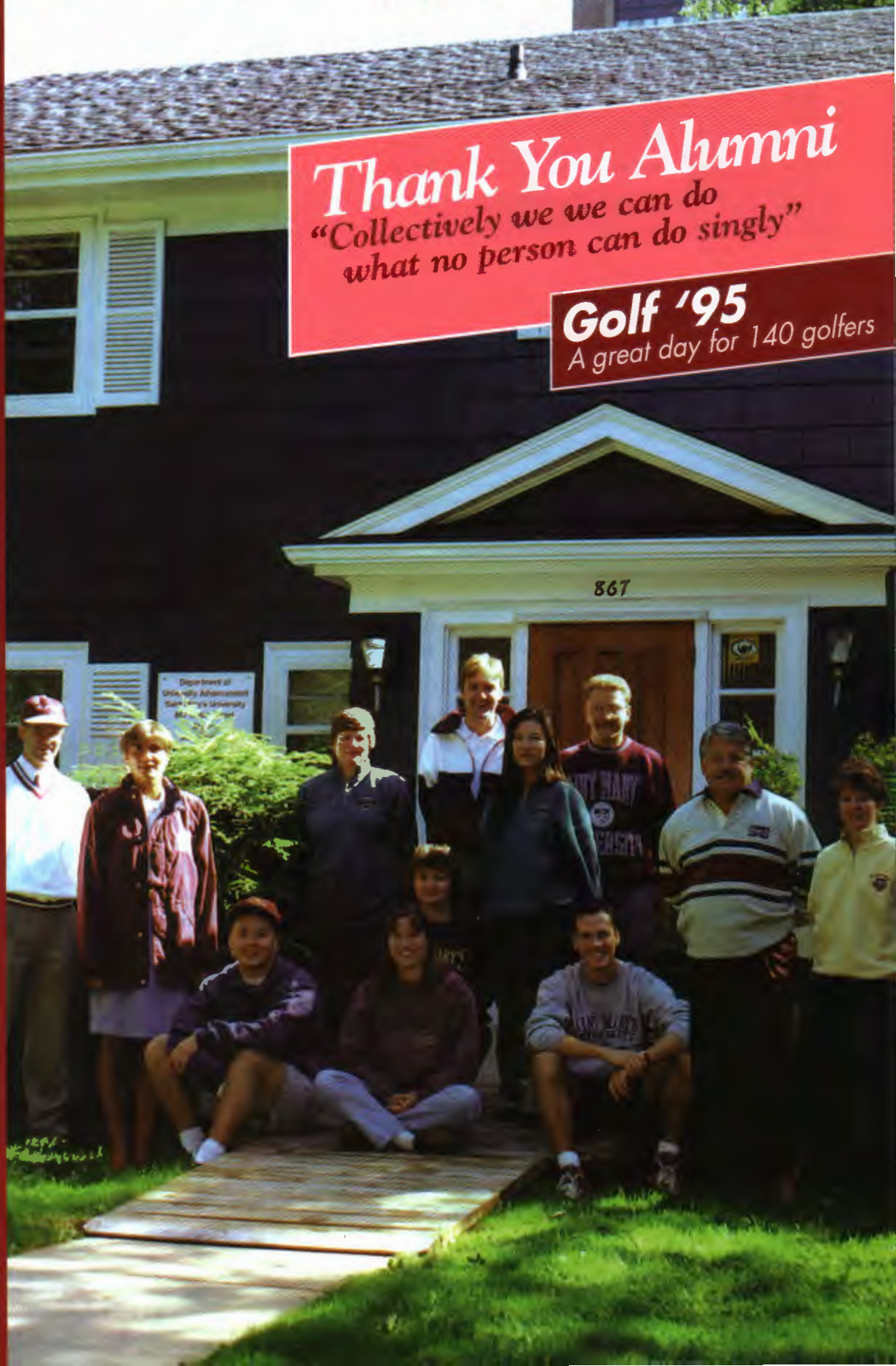

Alumni President's Message

The 1995-96 academic year is well underway. On behalf of the Saint Mary's University Alumni Association, we welcome to our University all students who are either beginning or resuming their course study. Higher education at Saint Mary's serves to provide students of all ages and groups with an academic experience which is vital; one which serves to prepare students to meet the technical needs of an ever-changing world.

This year will be one in which unprecedented requirements for change will continue to be exerted on the Nova Scotia university system. In a time of diminishing public resources it is said that the fiscal and other responsibilities of government, students and universities is expected to change. The Association has pledged its support to the University in pioneering the role of Saint Mary's in the Nova Scotia university system.

Saint Mary's University played a leadership role in May of this year in developing a "partnership" among four Metro Halifax universities. Dalhousie University had been advocating a consolidated university. The Technical University of Nova Scotia had been promoting a federation model. Dalhousie, TUNS, and Kings University agreed to move to a partnership with Saint Mary's University and the other Halifax universities. We believe that it makes sense to investigate the advantages of creating a Metro Halifax university consortium. However, to be seriously entertained any consortium must maintain the integrity and autonomy of the various partner universities. Further non-Metro universities must participate in their fair share of funding reduction.

A consortium of universities implies a relinquishment of some authority. What would be turned over to the third party consortium? The Association is concerned that in any workable consortium, meaningful control of the business of Saint Mary's University must be retained by the Board of Governors and Senate. Further,

a consortium implies rationalization of academic programs and services. There would be change and adjustment. However, on behalf of its almost 25,000 members, the Association expects that the academic

core of what is now provided at Saint Mary's University will be maintained and enhanced. From our standpoint, Saint Mary's University excels in the delivery of higher education and has always done so in a financially responsible manner.

The second major issue in a consortium is funding. The Association supports the University in taking a responsible position in relation to the public funding dilemma. At the same time, appropriate weight must be given to the historical unfairness in the allocation of public funds to Saint Mary's University. By way of background, currently Saint Mary's has the lowest reliance on public funds, expressed as a percentage of overall revenue, among all universities in Nova Scotia. The difference is somewhat shocking. For instance, the current level of support from government in respect of a student pursuing a BA at Saint Mary's is significantly lower than the support provided for the same program being offered at most universities in Nova Scotia.

We believe that the disparity among Nova Scotia universities in funding levels in respect of students in the same program must end. If disparities were increased then some universities which now receive greater funding for doing the same things as Saint Mary's will not be required to make the same expenditure reductions in the future. The Association supports Saint Mary's call for equitable core funding for all universities. In this way, all students would be treated fairly, regardless of the insti-

tution where they study. There must be an end to the system which provides proportionately greater funding to some universities for offering the same programs available elsewhere.

The present debate is one in which all alumni of Saint Mary's University have a stake. Maintenance of the academic core of what is provided at Saint Mary's University is vitally important to our members. The establishment of a single business school located on the Saint Mary's campus is a project we support.

Your Association is committed to providing constructive support to Saint Mary's University in reaffirming its role within Nova Scotia, within Canada and around the world.

Saint Mary's on the high sea

Take the largest ship in the fleet and put Saint Mary's alumni on board as the Chief Officer and Chief Scientist along with a couple of students and a professor and it becomes a University reunion. That's exactly what happened when Dr. Terence Day, Director of the Atlantic Canada Centre for Environmental Science at Saint Mary's was invited to participate in a mission with the Atlantic Geoscience Centre on board the C.S.S. Hudson, the Bedford Institute of Oceanography's (BIO) largest and most treasured vessel. "It's unusual to have a senior officer, chief scientist and guest scientist on board all from one university, plus two students. We covered the whole realm of management and had control over the scientific mission." says Gordon Fader, 47, Chief Scientist and a Saint Mary's alumnus. Fader knew he was scheduled for a mission on board the Hudson, but had no idea that the Chief Officer would turn out to be a friend he knew over 20 years ago. Once on board he took a long look at Andy Allen, the Chief Officer of the Hudson and they both recognized each other. When Fader attended the University in 1965, there wasn't much to the geology program. He had accepted a scholarship to attend and was told in his first year to concentrate on studying chemistry and physics. What he really wanted was geology. In second year, when he discovered the University only offered two geology courses, he persuaded the University, with the help of then Dean of Science, Dr. Hope Simpson, to allow him to take geology courses at Dalhousie University. This way Fader was able to concentrate his studies in geology while at the same time keep the remainder of his course work at Saint Mary's. In 1969, he graduated as the first Saint Mary's geology major. "I had 10 minutes to get between classes and we're talking about five

blocks from Saint Mary's to Dalhousie. Dalhousie was intimidating, but in the end I often got higher marks than most students," he says. During those good old university days and later, Fader played the keyboard in a band that used to perform at the Privateers Warehouse, in downtown Halifax, and Allen was the door man. Fader had no idea what had happened to Allen after graduating from Saint Mary's and joining BIO. Saint Mary's was a small stepping stone for Allan. He had big plans after he graduated with his Bachelor of Arts, political science major in 1977. It would be open waters and the high seas for this native Nova Scotian. Born in Lunenburg, NS, Allen decided at a young age that he would become a sailor and work his way up from crew hand to seaman, then to officer and finally Captain. And that's exactly what he did. "Back then that's where the money was to be made," says Allen. When Allen began his career he served on the Hudson as a seaman and spent time with other BIO vessels as a Deck Officer in the early 1980's. After working 14 years with a number of offshore drilling organizations, on semi-submersible drilling platforms

and having spent time in the North Sea, Indonesia, Singapore and New Zealand, Allen is happy to be back in Nova Scotia and working at BIO. Asked how his education at Saint Mary's helped him, he says, "When it came to doing my certificates it helped. Education broadened my scope of thinking and with a Bachelor's degree it has always been a bonus." Allan has completed all his mariner levels and today holds the Master's Mariners Certificate. He has been back with BIO for a year and a half now, but in that time he's only seen Fader a couple of times. With the mission concentrating on the potential offshore sand and gravel deposits that in the future could lead to offshore mining, there wasn't much time for chit-chat. Fader hopes that next year, he along with Dr. Day, can continue their research into the potential for offshore sand and gravel mining with another mission and maybe a bigger Saint Mary's reunion on board the Hudson.

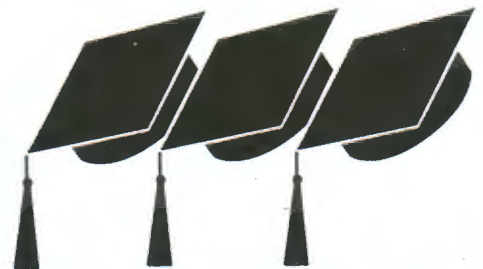

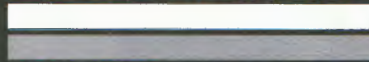

Student Alumni Ready For a Busy Year



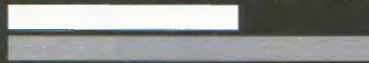
Left to right: Geoff Brown, Student Alumni President, Joanna Campbell, Student Alumni member & Fraser Gould, Student Alumni member

Ordering Transcripts

It is not nearly as difficult as you think to order copies of your academic record from Saint Mary's University.

Official transcripts are sent directly to third parties, i.e. other academic institutions or business/professional organizations. Unofficial transcripts are issued directly to you and are marked "Issued to Students".

Transcripts of records are considered to be privileged information and are not released to those outside the University without the written permission of the student or former student.

To request a transcript, you must complete the appropriate form, obtainable from the Registrar, or forward a letter of request to the Records Office at the University. Though the normal processing time is approximately ten working days, additional time is needed at peak periods, particularly at the end of each semester and around graduation time.

The cost is \$5.00 for each copy of the transcript. The University will fax transcripts upon prepayment as noted:

The goal was to make the site easy to find and user friendly, while providing the type of information that visitors seek. Halifax is a beautiful, friendly place of which all of you can be justifiably proud.

My family and I have come to know your wonderful city fairly well, as our eldest daughter has spent the last four years at King's College. To say she fell in love with her school, this city and the Maritimes during her time here is, undoubtedly, an understatement.

I think you are very fortunate here in Halifax to not only be a major business centre, but a major education centre as well.

Why? Well, because I think it gives you a unique opportunity to find ways for business and education to work more closely with one another, for the betterment of us all.

I am a strong believer in lifelong learning. I believe that the home, the school and the workplace are each, in their own way, a critical forum for learning ... and I believe that we, as Canadians, must ensure that we are preparing the next generation of Canadians to be able to compete successfully in what is going to be an ever more competitive environment.

Today, many Canadians are worried about what the future holds for themselves and for their families. We are anxious and apprehensive about our debt levels and our spending levels. In fact, we are anxious and apprehensive about our country itself.

The word "Global" now permeates our culture ... Global Marketplace, Global Economy, Globalization. In this Global envi-

ronment, countries are becoming increasingly interdependent and boundaries are blurring. One of the results of all this is that our policies and standards for just about anything can no longer be solely domestic ... they, too, must be global in nature. The reality is that there is only one world out there and everyone, including us Canadians, must compete in that one world.

It is in this context that we must look at lifelong learning. It is in this context that we must prepare ourselves and our children to survive and to thrive in the world of the 21st century. Why? Because I believe the only real legacy we can leave our children is the ability and the skill sets to compete with an succeed against the world's best.

As an aside, it's going to be critical for our generation that we don't tie one hand behind the backs of the next generation by burdening them with our profligate spending or a nation torn apart to serve the political ambitions of a few. To do that, we need to look outward, not inward. We must ruthlessly examine our ability to compete against the world's best and be prepared to make whatever changes are necessary to ensure that ability is continually enhanced ... never diminished.

Let me give you an example. For years, the philosophy at our organization was that if it wasn't made in London Life, it just couldn't

be any good. That's just not the case any more and today, we are spending increasing amounts of time and money looking for ways to improve our learning about what's going on in the world out there and then trying to adapt to and adopt better ways of doing things. Today, the reality is that other nations have done a better job of doing that than we have, and that must change.

The same can be said about our education system. For years, we've told ourselves that we educate our children better than anyone. Let's not be afraid to face the reality that this may no longer be the case. More importantly, let's not be afraid to help do something about it. The primary purpose of my remarks this afternoon is not to be critical of the past, but rather to encourage an even better partnership between business and education. We can both do much more than we're doing. The business community can provide many valuable resources ... money, experience and knowledge. We can help finance and implement innovative new programs so students are prepared for real world experiences when they finish their formal education.

In 1992, a group of very diverse Canadians came together to try to figure out what Canadians had to do if we wanted to maintain a prosperous Canada. It was called the prosperity initiative. That group made some interesting recommendations about lifelong learning I think the business community should embrace.

Prosperity Initiative Recommendations

- We can help develop curricula and qualifications related to employment
- We can build stronger links with the education system in general and with local schools and school boards.
- We can offer programs which encourage student participation in the work environment.
- We can enhance the training programs we offer our employees. Why? Because if we don't invest in our people, I doubt that people will continue to invest in us.
- We can provide technology training and equipment for use in the schools. In many cases, I would suspect the equipment we consider obsolete would be a welcome improvement over what is currently available in many of our classrooms.
- We can offer technology training for teachers
- We can create opportunities for teachers to familiarize themselves with our businesses
- We can encourage alliances between businesses so smaller companies can afford to participate in enhanced training initiatives
- We can encourage training in foreign languages and cooperative international research by developing and funding international exchange programs
- And we can encourage our employees to become more active participants in their own education and in the education system

Business leaders in this country need to dig deeply ... into our pockets, our imaginations, our experiences ... to help improve the performance and accessibility of this country's lifelong

learning systems. We must create and cultivate a learning culture, where education is seen as a lifelong process. If this great nation is to build on its legacy of accomplishment, affluence and compassion, we must foster a society truly committed to lifelong learning.

We have an urgent and crucial obligation to create opportunities for improvement in lifelong learning, in the same way we strive to

enhance our businesses ... through innovation, re-engineering, bench marking, partnership, vision, and focus on excellence and results. And, just as we do in our businesses, we must ensure that success is sustainable.

Nearly 30% of the students in our high schools today will not graduate. In fact, in the time it takes us to enjoy a business lunch like this one, over twenty Canadian students drop out of school. If you believe, as I do, in the concept and necessity of lifelong learning, their lives have been cut short.

If we cannot find a way to motivate young Canadians to stay in school, this entire nation will suffer ... individually and collectively.

Not surprisingly, the unemployment rate and the level of educational attainment are inversely proportional and the economic and social implications of this are staggering.

In its "Shaping Canada's Future Together" publication, the federal government states that "an enhanced private sector role in training and standard-setting will be critical to Canada's future competitiveness. In the future, training will

require full partnership of all the players in the economy." I believe they are right!

As major players in Canada's economy, the life and health insurance industry is well

positioned to help drive some major initiatives intended to improve the opportunities our young people have. We play a major role in the finances, future and fabric of this country and it's people. Over 20 million Canadians trust our industry with their futures and with the futures of their families. They have placed their trust in us for generations.

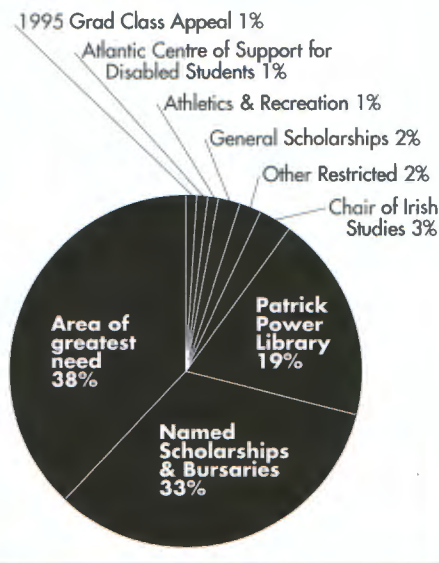

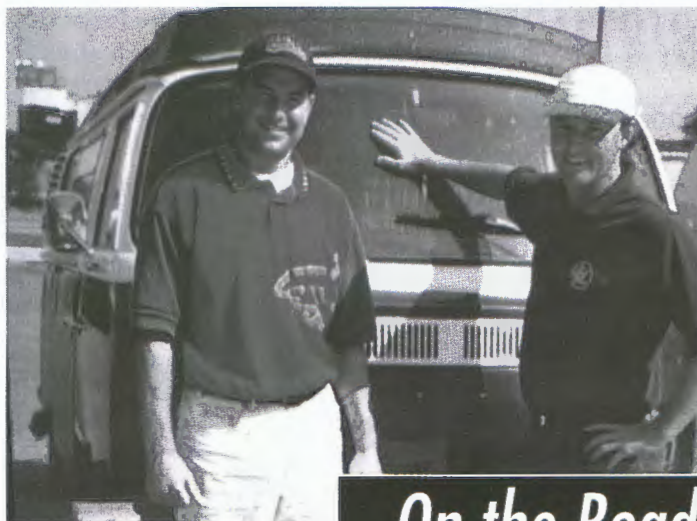

LEONARD RAMBEAU SCHOLARSHIP ESTABLISHED



**Leonard T.
Rambeau
1945-1995**

Leonard T. Rambeau was every inch a Maritimer. He was born in 1945 in Sydney, Nova Scotia, but spent most of his early youth in Smelt Brook, Cape Breton Island. When he was 10 his family moved to Dartmouth where Leonard went to St. Peter's High School.

Leonard went on to major in history and political science at Saint Mary's University. He was Council President and an early college profile lists no less than 53 organizations in which Leonard was involved during his years at University! Leonard received his Bachelor of Arts degree as well as the prestigious Gold "M" Award, given to students who not only excel scholastically, but who also take an active role in University activities. Upon graduation, Leonard went to work for the Department of Manpower and Immigration in Halifax, Nova Scotia.

A successful entrepreneur, Leonard first hired Anne Murray, then a schoolteacher, to sing at a benefit for a youth group in Dartmouth called Club'45 in 1968. She recalls telling him "If I ever need a manager, I'll call you". From that first concert their friendship grew. Leonard offered to help the fledgling singer with her business affairs, including answering fan mail. When Anne's music career started to take off, she decided to move to Toronto. Meanwhile, Leonard's position with the government had also elevated, to Executive Assistant to the Director of Manager Operations for the Atlantic Region. Leonard once recalled "I got a call from Anne in April of '71, asking me 'are you ready to come to Toronto?' I gave it some thought because I had this career of my own going, but I knew I would rather go through

life knowing I had given it a try, than wondering what would have happened if..." Leonard decided to give up his government career to form Balmur Ltd. with Anne Murray and her business consultant Lyman MacInnis. As general manager of the company, Leonard did everything from road manager to call the lights at shows before taking over Anne Murray's exclusive management in 1976. They traveled the world together as Anne toured Australia, New Zealand, Japan, Great Britain and across the United States and Canada. They never signed a formal agreement. "We never needed one," he once told The Toronto Star. "Maybe that's one of the reasons the relationship has lasted. Neither of us has a piece of paper we can throw at a lawyer. It's just mutual trust and respect and friendship."

In the years since, the company he, Anne and Lyman formed has become one of the most important management firms in the country. Leonard also managed the careers of Rita MacNeil and George Fox propelling them to numerous accolades awarded by the Canadian country music industry.

His family was a very important part of his life. In 1978, Leonard married Caron Hendershot. He was dedicated to his family and loved to talk of the accomplishments of Caron and children Derek, Scott and Julia.

Highly respected by music professionals in Canada as well as internationally, Leonard was awarded the Global Achievement Award by the Canadian Academy of Recording Arts and Sciences (CARAS) at the 1995 Juno Awards in March for his enormous contribu-

tion to the Canadian music industry. As the second president of CARAS, he was one of the visionaries who recognized the potential of the Juno Awards in its initial move to television. He also received the RPM Hall of Fame Award and was twice awarded the Canadian Country Music Association's Manager of the Year Award. Leonard served on the board of directors of the Country Music Association (CMA) in Nashville.

Leonard Rambeau died on April 13, 1995 in Toronto.

Leonard T. Rambeau Scholarship
