# SENATE MEETING MINUTES November 10, 2004

04235 CALL TO ORDER

Dr. D. Naulls, Chairperson, called the meeting to order at 4:34 PM.

04236 REPORT OF THE AGENDA COMMITTEE

Dr. Chard explained the process by which the list is compiled. An administrative check is done by the Assoc Registrar, after which it is circulated to the Faculty for an academic check. When both of these checks are complete, the list is returned to the Registrar.

Dr. Chard suggested the removal of one name off the BA list (M. Hamilton [3<sup>rd</sup> name on the 2<sup>nd</sup> page] who advised today his intention to pursue an advanced major). This change will be reflected on the last page. The total number of Arts Graduates will read 113 and the overall total will read 225.

Moved by Dr. Chard, seconded by Simon Partington, 'to confer distinction of those represented on the list at the Fall Convocation'. Motion carried unanimously.

Dr. Chard asked that the minutes reflect that there are increases in the number of graduates in Management Finance and the Certificate in H.R. Programs.

Except for the lists held by the Deans, the rest were returned to the Registrar.

Motion by Dr. Murphy, seconded by Ms. Lefebvre, 'that we reconsider the original motion of October 29<sup>th</sup> relative to starting the second semester on Jan 9<sup>th</sup>'. Motion carried.

Dr. Chard advised that she had received verbal and written requests to change the Calendar as presented at the October 29th Senate Meeting and acknowledged that, after thorough scrutiny, there were found to be more teaching days in the second semester. Dr. Chard also advised that there were operational guidelines that had an implication on development of the Calendar. An understanding exists within the University community that, whereever possible, metro universities would commence teaching in the second semester within 24 hours of each other. One option presented by Dr. McCalla in his written request, was to take the extra days off the end of the semester. This turned out to be in line with the calendars of other Universities. There are now 75 teaching days in the second semester.

Moved by Dr. Chard, seconded by Mr. Whalen, 'that Senate accept the draft Calendar of Events dated Nov 3/04'. Motion carried with one abstention.

In the last paragraph, Dr. Young expresses caution related to how the
Board will operate in the future. Dr. McCalla suggested that Senate
should review this situation. The issue is that ethical standards, with
which all Ethics Boards must comply, are strongly influenced by the
medical community in Ottawa. All groups are required to abide by the

same standard as medical groups. Dr. Murphy suggests we articulate our concerns and submit them to the granting councils with a voice in Ottawa.". This Committee is burdened by a significant volume of work. From a resource and budget perspective, this will have operational implications to SMU.

Moved by Dr. Bowlby, seconded by Dr. Murphy, 'that commendations be given to the faculty and other participants on this committee'. Motion carried unanimously.

## 04247 PRESIDENT'S REPORT

Dr. Dodds reported on the MOU process and balancing tuition and government grants. The negotiating group is close to getting an agreement. Meetings are scheduled for later this month (Nov 16 and 23<sup>rd</sup> and a codicil for the 25<sup>th</sup>). The Governor General indicated he wants a decision by the end of month. If agreement is reached, it will be good for all students in Nova Scotia. The Nova Scotia Innovation Trust Fund is empty. The Universities are asking for a top up to this fund of 5 million. Given the soft enrollments, if the agreement goes through it may help to balance the budget for next year. Dr. Dodds noted that if this does go through, it will be the largest single increase in University funding in the last fifteen years.

Dr. Dodds suggested both sides (Government/Cabinet) will have to review the agreement. If it doesn't go through, SMU might lose a significant amount of its funding. In the opinion of Dr. Dodds, the Boards are likely to approve the MOU.
