Stephen Harper Doesn't Like the Media

"I don't think he likes us, plain and simple," The Globe and Mail's Jane Taber says regarding Harper's feelings about the press.

That's true; Stephen Harper doesn't like the media so much. You may have noticed this because, well, he says so all the time. The problem being that reporters tend to ask him questions he doesn't like, and then... expect him to answer. Harper's latest media-centric move, discovered about a week ago by the Toronto Star, is a plan to create a new government owned press-theatre named "The Shoe Store Project." This plan would make the Shoe Store (so named because it used to be a shoe store,) the new venue for government-press interaction and make the decades-old National Press Theatre, -founded by Nobel Peace Prize winning PM Lester Pearson, obsolete.

The new media centre is cause for concern because of the power it would give the government. The National Press Thea-

tre is controlled by the media, so it is the media who decides who has access to the Theatre, and to a large extent, who gets to ask the questions. A government run media centre would allow the Prime Minister and his government to choose which reporters to allow into press conferences, as well as who gets to ask him questions. Government controlled video cameras in the new media centre rather than media controlled cameras would further the control the government would have over how its message got out.

A similar system to the Conservatives' plan is already in effect in the United States, where the results of government control have considerably weakened the press. American reporters have admitted to asking "softer" questions of officials, for fear that if they openly challenged something the President or another official had to say they would be banned from the press gallery or simply not called upon in subsequent press conferences. As a result the American press has

become a largely whipped and ineffective body for reporting on the Bush administration. Rather than receiving enlightening information about international relations, the press instead learns that Bush is looking forward to eating ham with Germany's Chancellor.

As much as I myself would be fascinated to learn what sort of foods our Prime Minister likes to eat with other world leaders, the idea of a hamstrung media is not something that Canadians should take lightly. An effective and independent media is a cornerstone of any working democratic government. Thankfully, the day after the media centre became public knowledge, the Government announced the project would not move ahead, but that they would try such a thing is troubling. For a Prime Minister who got elected on promises of Accountability and Open Government, Harper doesn't really seem too keen on either.

Letter From The Editor: W's are not as scary as they seem

For students who have been struggling with their courses, now that midterms are in the midst of being completed it's about time to get some feedback. With that comes the important decision of whether or not to withdraw from classes you aren't feeling confident about.

Some students might be fearful of this idea since you lose money, you lose credit hours, and you get a W on your transcript. Laurance Rose, a 4th Year Philosophy major said, "I would be worried to withdraw from a class at this point because I need the credit hours. However, if I was failing a class I would have no problem taking a W on a transcript over an F."

The concern over money is warranted. Tuition is not

cheap and if you drop a class at this point you will get none of your money back. Not to mention doing so means you will have to pick up an extra course the coming semester to make up for lost credit hours, thereby spending more money than expected. But if money is an issue, Saint Mary's provides financial aid opportunities to students. The deadline for the fall semester is October 31st, and applications can be picked up at the Financial Aid office on the 4th floor of The Student Centre.

To lose credit hours is crucial, especially for those students planning to graduate this year. One must decide what is more important-quality or quantity. Is it better to not risk a poor mark and withdraw, spend the extra money and take a summer course to make up for it, or to just

accept a poor grade which would plummet your overall average yet allow you to complete your degree when planned. AJ LeVine, a 4th Year Commerce student says, "I've already done it! I'll just take an extra semester. It's better to spend the extra time and money than to do horribly in a course."

To worry about the W on your transcript is not warranted. On this matter I spoke with John MacKinnon, the Chair of the Philosophy Deaprtment at Saint Mary's, and he sees a lot of students concerned about getting W's on their transcripts. He says, "Of course students should want to avoid being in the position of having to drop courses. Money will be lost and progress hampered, and there's lots to be said for hanging in there; overcoming obstacles, struggling with and coming

to understand the course material in a way that seemed impossible at the beginning of the semester." But he maintains that if, for whatever reason, students find themselves having to drop, they should be aware that, unlike a D or F, a W has no impact on your GPA. It simply records that you started a course and, for a number of possible reasons, dropped it.

On occasion, the reason for dropping a course is a derelict or incompetent professor. If students are contending with an absolutely dreadful professor, then they should take the steps of talking to the professor for clarification of the material, talking to classmates to see if they're just not missing something, and, finally, arranging to see the Department Chairperson. Students can write and submit a letter of complaint

to the Chair if this problem arises and persists. Students rarely seem to do this, even in really terrible cases, thereby passing on the problem to future students. But if they do, it increases the likelihood that one day, as complaints pile up, something can be done.

Therefore, if you have any reservations regarding a class then it is wise to think clearly about the options you have, even this far into the semester, and remember that withdrawing from a class is an option not to be afraid of.

November 9th is the last day for withdrawing from first semester classes with no academic penalty. You will get a failing mark in any classes you drop after that, except in full year courses.

Over 38.8 Million Stand Against Poverty

Close to 1 billion people live on less than \$1 a day. 72 million children still do not go to primary school. In 2006, 39.5 million people were living with HIV/AIDS, and in that year 4.3 million were infected with the virus. In response, "...tens of millions of people are making their voices heard by standing up and speaking out against poverty and for the Millennium Development Goals..." UN Secretary General Ban Ki-Moon.

To mark this year's International Day for the Eradication of Poverty, October 17, 2007, the United Nation's Millennium Campaign (UNMC), the Global Call to Action Against Poverty (GCAP) with many other partner organizations around the world, organized 'Stand Up and Speak Out' events. These events took place in 110 countries, starting on October 16, 2007 and ending on October 17, 2007. Over 38.8 million people were mobilized and stood up against poverty, breaking the 2006 'Stand Against Poverty' record, set at 23.5 million people. At Saint Mary's, 79 people, including both SMU and TESL students, staff, faculty, and other members of the Halifax community stood against poverty and said the Millennium Pledge. The event was held in the Husky Stadium on October 17, 2007, and was organized by the Saint Mary's WUSC society. A banner was also on display in the Loyola Colonnade at a WUSC table from October 16-17, 2007, and approximately 450 students, staff and faculty signed the banner. This banner will be attached to other banners signed across Canada, and eventually will be stitched to banners signed around the world. The banners will be shown at G8, United Nations (UN), World Bank, International Monetary Fund (IMF), and World Social Forum events.

So, what's the point of the 'Stand Up and Speak Out'? Though 168 developed and developing UN member countries signed the Millennium Declaration in 2000, very few governments in these countries have kept their promises. This declaration focuses on the reduction of poverty by

2015, using eight goals known as the Millennium Development Goals (MDGs). These goals aim to reduce poverty, hunger and gender inequalities. And improve health, education, environmental sustainability, and the global partnership for development; which includes the reduction or cancellation of Third World debt, and the improvement of trade rules and foreign aid. These goals are all connected, and once one is achieved the subsequent goals can be achieved.

So what can you do as a citizen of Canada, or as a citizen of another country to help achieve these goals? Canada promised to increase its foreign aid to 0.7% of Gross National Income (GNI). To ensure that Canada keeps its promise, Canadians can call on their local Member of Parliament to raise this issue in Parliament and enact Bill C-293 which would make the reduction of poverty Canada's number one focus when distributing foreign aid. On a smaller scale, all of us living in Canada can help improve trade through the purchase of Fair Trade Certified goods, such as Fair Trade coffee, tea, chocolate, flowers, rice, sugar and wine. Many of these Fair Trade goods have been bought from farmers living in developing countries at a fair price. And without the use a middle man, these farmers are able to receive a higher return for the goods that they sell on the international market. This in turn helps reduce the poverty a farmer in a developing country may face. Though 2015 is only a couple of years away, we can all take steps to help in the reduction of poverty; from exercising more ethical purchasing decision through the support of Fair Trade Certified goods, or working with groups who aim to help people living in poverty, to "...calling for the actions of citizens to be matched by the actions of Governments, in developing and developed countries alike, to demonstrate the political will required to end the scourge of poverty once and for all.", UN Secretary Ban Ki-Moon.

Working Toward an All-Inclusive SMU

Nova Scotia #1 Again: A Decade of High Tuition

It would appear Nova Scotia is engraved at the top of the university tuition costs list. The Province has held the title for the last ten years. By choosing to attend University in Nova Scotia students are paying \$1,354 more than the national average for tuition. The average cost of tuition full-time undergraduate Canadian students is \$4,524 a year. For Undergraduate tuition alone Saint Mary's students are paying over \$5,500. That is before factoring in compulsory fees for SMUSA, Health & Dental, Campus Renewal, The UPASS and other essential services. It makes sense that compulsory fees in N.S. are also the highest in the country.

In an attempt to offer aid to Nova Scotia Students the Provincial Government put in place a \$500 tuition credit. Unfortunately it is just a drop in the bucket for Nova Scotia students, and does nothing to help students from other Canadian provinces.

Tuition rates vary across the country and are lowest in Quebec (at \$2,025) and Newfoundland (at \$2,633). New Brunswick and Ontario are close behind the Nova Scotia average of \$5, 878. When you look at the numbers it is would be more affordable for a student to attend and live on campus at

Memorial University in NFLD or McGill in Quebec than to simply attend classes at SMU.

Enrolment at Nova Scotian Institutions dropped over 2% this year according to a report by the Association of Atlantic Universities. Students are getting discouraged by the lack of change and as a result they are looking into other options.

Even at the most affordable Universities tuition is not cheap when you consider few students graduate high school with thousands of dollars in their pockets to pay for their educations. But it would be possible for a student to work enough to cover \$2,000 in tuition costs. It is not however, possible for students to work enough to cover over \$5,000 in tuition costs while attending school. Many students at Saint Mary's are working two or more jobs in an effort to make enough to cover costs of their education.

There are many scholarships and bursaries to help students cover education costs but very few students receive enough in scholarship money alone to cover all their expenses. In addition to this there is a "catch 22" situation here as students are forced to work to help pay for expenses but are then denied Student loans or scholarships for making too much money.

One prominent source

accessible for students with high financial need. The Award was presented to a first year student for the first time this year.

SMUSA is also very involved with two student lobby groups, The Canadian Alliance of Student Associations (CASA) and The Alliance of Nova Scotia Student Associations (ANSSA). These groups lobby the Government on Federal and Provincial levels, respectively.

CASA represents over 250,000 students, and 19 Student Association and Unions across the country. CASA leaders have met with the many leading Government officials including the Prime Minister, and Opposition Leaderstodiscusswaystoimprove post-secondary education for students. Main goals of CASA are to create a Pan-Canadian Accord for Post-Secondary education and Dedicated Transfer Payment which would both serve to increase the amount of financial aid available to students. On the Provincial level

ANSSA, is working on behalf of over 33,000 students in Nova Scotia to help make postsecondary education accessible everyone. Emphasis is being put on establishment Low-Income Need Based Grants to help students from low-income families realize their academic potential. Mitch

Gillingwater, the President of SMUSA, expressed

the same opinions as students all over campus, that it is very disappointing for Nova Scotia to once again top the list, that the cost of education is too high. He reiterated what is apparent by SMUSA's involvement in CASA and ANSSA that SMUSA is working hard to help make education more affordable across the country.

Saint Mary's is also committed to helping students afford a University Degree. In a statement for The Journal, Public Affairs Officer Paul Fitzgerald said, "The University offers well over \$3 million in scholarships and bursaries for

students at the undergraduate and graduate levels of study. The

students at the undergraduate and graduate levels of study. The University also offers its students an abundance of employment opportunities." He went on to say that in addition to Scholarships, Bursaries, and employment opportunities the University also offers students access to a variety of research grants.

Students attending University in Nova Scotia need to demand a change be made, it is time to get involved and take a stand. It should be expressed that students are sick of paying the highest rates in the country. A decade is too long to be number one, it's time for a change.

Halifax Critical Mass Bike Ride

Being a bicyclist in Halifax certainly has its challenges. Aside from uncontrollable natural factors such as Halifax being a hilly city with its fair share of rain; cyclists in Halifax must deal with the fact that it can be dangerous, and even deadly. On October 11th, 19 year old Micael Brooker was killed on Barrington Street while biking, his death an unfortunate reminder of the HRM's virtually nonexistent network of bike lanes on the peninsula. It's well known among bicyclists that the only bike lanes you can find are the ones on Brunswick Street (which is often allowed to be used for car parking) and the guerrilla 'bike lanes' that have been painted on

several roads such as Windsor or Chebucto by some do- it-yourselfers. While Halifax's Regional Planning Strategy promotes active transportation and dedicated bicycle networks, there has been little to no action stemming from that because of the lack of political will from Mayor Peter Kelly's office.

David Bethune is a Dalhousie anthropology student has been a member of the Halifax Critical Mass bicycle group since last September and he wants to encourage SMU students to come out and join in the group bike ride on Friday, October 26 in an effort to raise awareness and to protest the very issue that led to the young man's death just a couple weeks ago.

"Everyone is welcome

to come out...people might be a little bit fearful of protests, they don't want to be seen, but it's not really a protest per- se. It's not like a march where everyone is chanting, it's a bike ride where everyone is talking" says Bethune. The idea behind Critical Mass is to have enough people on bikes that they can form a large enough group to take up road space otherwise dominated by cars. In Halifax, where the average turnout is in the 40 to 50 range, that means occupying a lane of traffic. If Halifax's recent high turnout of 67 people in May seems like a large group of cyclists; imagine Budapest where an average of 30,000 riders come out for each Critical Mass ride on the last Friday of every month. Critical Mass is a global

phenomenon with its roots in San Francisco and it is in its 15th year of existence. As the Halifax critical mass website states, "[we have] no organization, officials, or leaders. We're just a bunch of people riding

around together", and that's what

Bethune wants to encourage.

"We have to change the culture and get more people wanting to bike...if there was good, accessible bike lanes most people could all just cruise down the hill", he says, referring to getting more people out there commuting on a bike. As it stands now, there is too much risk involved in cycling a lot of Halifax's crowded and busy streets. "If more people cycle and more people feel like they can cycle to work and to school, then you get less people driving their

cars and I think that's a really great thing to try to do" says Bethune.

The Halifax Critical Mass bike ride meets at Victoria Park on the corner of Spring Garden and South Park at 6 pm on the last Friday of each month for a tour around the peninsula, usually the tours do not have a planned route Bethune says, rather, they are led by whoever is in front. The rides are a nice, slow pace and everyone is welcome. This Friday's ride will feature an opportunity to dress up in a Halloween costume, although it's not necessary to dress up to participate. SMUSA & CASA Launch Campaign to Save \$2.5 Billion in Student Financial Aid

SMUSA, in partnership with our federal lobby group the Canadian Alliance of Student Associations (CASA), has launched a campaign to save the Canadian

Millennium Scholarship Foundation, which provides \$350 million in student financial aid each year, \$2.2 billion since 1998.

The campaign is called *Grants Reloaded* and will be focusing on increasing both student and public awareness about the impending expiration of the foundation in 2009. The CMSF was established in 1998 by Jean Chrétien's Liberal government with the mandate of improving access to post-secondary education. Ninety-five percent of the scholarships that the foundation awards are based on financial need and 5% are based on merit. This foundation alone has provided over \$8 million in aid to students at Saint Mary's University.

As part of the campaign SMUSA will have a booth set up in the lobby of the Student Centre to promote awareness about the foundation and the crisis in financial aid that would occur if Millennium is not renewed during the 2008 budget process. SMUSA will have a video camera set up and is

looking for students to make comments about the benefits of the Millennium Scholarship Foundation, particularly those who have received Millennium Scholarships themselves.

The winning submission will be awarded a bursary in the amount of \$1,000.00 and the individual will also be brought to Ottawa to speak at a press conference for the Canadian Alliance of Student Associations on November 6th or 7th, 2007. Three runner-up submissions will be awarded a bursary in the amount of \$200.00. One prize will be awarded for each of CASA's three regions (West, Central and Atlantic). This booth will be in the lobby until Thursday, October 25th.

Dalai Lama Awarded Congressional Gold Medal, China Demands It Not Be Awarded

The 14th Dalai Lama, Tenzin Gyatso was awarded the Highest Civilian Honour by the U.S. Congress Wednesday October, 17th 2007.

Described by President Bush as a "universal symbol of peace and tolerance" the spiritual leader of Tibetan Buddhists was presented with the Congressional Gold Medal at a public ceremony in Washington. This is not the first time his work has been recognized. He also received the Nobel Peace Prize in 1989. The decision to bestow this honour upon the Dalai Lama outraged the Chinese Government who views him as a threat. They believe his work in Tibet is all a separatist effort to gain independence. The Government also warned the United States that honouring the Dalai Lama "gravely undermined" U.S. and China relations.

The Dalai Lama went on record saying "I have no hidden agenda." He also said he is seeking a "meaningful autonomy" for the people of Tibet and not independence. He is seeking the freedom to practise religion. President Bush and leaders of the Democratic and Republican parties all spoke out against China, urging the country to allow him to visit. They also praised his accomplishments and his commitment to peace.

LodiGyari, Special envoy of the Dalai Lama told reporters that the U.S. President standing next to the Dalai Lama would send the message to Tibetans that they have not been forgotten, and that people do care. He also said it would send a strong message to the leaders in China that the Dalai Lama is not going away.

A Member of China's Foreign Ministry expressed the opinion "U.S. leaders meeting the Dalai [Lama] seriously violate the basic principles of international relations." The Chinese Government feels the U.S. Honour given to the Dalai Lama was a political decision designed to add support to his Tibetan separatist agenda.

The Gold Medal which is awarded "both for singular acts of exceptional service and for lifetime achievement," has previously been awarded to Mother Theresa, Winston Churchill, Nelson Mandela, and Jackie Robinson among others. The President does

not make the decision as to who receives the award and chose to attend the ceremony because he admires the Dalai Lama and shares similar views about religious freedom. At the ceremony the Dalai Lama thanked George Bush for his "firm stand on religious freedom and democracy."

The Buddhist Monk and the President also had a private meeting Tuesday. In a rare move the media was banned from covering the meeting, and no press photos were released in an effort to prevent further infuriation of the Chinese Government. White House Officials did however decide to allow photographs of the Dalai Lama and President Bush at the ceremony itself.

China invaded the country of Tibet in 1950, and has since 1951 has claimed to be the legitimate governing power over the once independent state. There have been many allegations against the Chinese government arguing that over the years religious, as well as other freedoms in Tibet have been oppressed, at times by the use of violence.

Speech from the Throne: Conservatives Announce Plan For The Next Year

The Conservative's gave their second Throne Speech Tuesday October, 16th. This speech outlined Stephen Harper's plans for the next year. If the Bill does not pass Canadians will be forced into another Federal Election. The Speech presented five main priorities set by the Minority Conservatives for the next year should they remain in power. The first of these "strengthening Canadian sovereignty and place in the world" is actually a theme throughout the entire document: Nearly every priority presented ties in with the theme of Nationalism, an area usually best controlled by the Liberal Party. The Bill tackled two very touchy subjects in Canada today, Canada's mission in Afghanistan, and the Kyoto Protocol and the Environment. Also further tax cuts are a priority for the Government although the exact extent Canadians will benefit from this promise will not be known until the Budget comes out in early 2008.

The Conservatives also plan to introduce legislation to help curb violent crimes in the country. The proposed Bill aims to have stricter penalties for impaired driving, harsher bail conditions, mandatory prison time for gunrelated crimes and also a change in the age of sexual consent.

Also, it was proposed that Canada build a world-class research station in the Arctic. This station would be of benefit to environmental scientists as well as those interested in resource development. A map of the Arctic seabed could also be

developed as a result. Following under the sovereignty theme the station would increase Canada's claim on the Arctic region. Most controversial however were the decisions made regarding the situation in Afghanistan and also the Environment. Despite previous plans to end the Canadian mission in February 2009, officials are now saying the work of Canadians in the country will not be complete until 2011. Extending the mission would allow for further training of Afghan Military and Police, and would ensure Canadians do not abandon the people of Afghanistan. The Throne Speech is proposing a Preliminary vote to extend the mission as one of its major priorities.

The Conservatives also used the Throne Speech to inform Canadians they are abandoning

commitments the to meet the Kyoto Protocol. reason given is that cannot meet projected decreases in emissions by the set deadlines. Instead Governments plans"to help lead the effort" of addressing climate change globally. issues Instead of reducing Green House Gases through Kyoto efforts will be put in place to clean up Candada's polluted water ways.

The Great Lakes are a major focus as is providing clean water to First Nations Reserves across the country. It was also proposed that Canada attempts to reduce emissions separate from Kyoto, aiming for a 20% reduction by 2020, and a 50% reduction by 2050.

The Conservatives need the priorities of the Speech to pass or else Canadians will have to go to the polls. Both the NDP and the Bloc Quebecois made public their plans to vote against the Speech. The Liberal Party therefore is the deciding vote, and Leader Stephane Dion announced the Liberals will let the Bill pass.

The Bloc submitted a sub-amendment to the Bill but received no support. After going to a vote of 240-48 the amendments did not pass. The Liberal Party wrote amendments in a manner that neither the NDP nor the Bloc will allow them to pass, thus preventing a fall election. The Speech will still be subject to a Vote of Confidence motion this week and for the Conservative Government to survive it must pass something the Liberals are ensuring happens. Regardless of public opinion on the issues it seems Stephen Harper's conservatives will remain in power long enough to put their proposed Bills into use. If the Bill were to fail Canadians would be going to the polls for the third time in four years.

A Weekend of Music: Halifax Pop Explosion Review

The Moist Towelettes at the Seahorse: After the Celebrity iPod battle was postponed for half an hour, my best friend and I went to the Seahorse where we unfortunately positioned ourselves in front of a girl with a laugh that made you want to jam something down her throat. The Moist Towelettes had a lot to make up for, and boy did they ever. Two Canadian guys are on guitar and key-tar and two Japanese girls in toga-like dresses bounce onto the stage and a smile jumps onto my face. They play one adorably, un-ironically happy pop song before introducing themselves to the crowd. "We come from Tokyo Japan" the girls, Yuko and Emi, say in unison "we have come to make you dance and make you moist!" The crowd of hipsters instantly lose the pretense and loosen up, dancing along with the singers. They throw balloons into the crowd and keep the energetic pop flowing, adding a great new dimension to Sloan's "The good in everyone" as well as their own songs. When their set is up all too quickly, they sign off by chirping "We love you, stay moist!" I love you too, Moist Towelettes, and I will. (I bought a button saying "get moist" and one saying "stay moist").

Windom Earle at the Seahorse: From what I can determine, Windom Earle

named themselves after a character from Twin Peaks. would be pretty cool if it was a decent character from the first half of the series, but as they chose a hastily created, unmemorable poor substitute for the true villainy of Killer Bob/Leland Palmer, this did not bode well. The four piece local outfit takes the stage in front of a backdrop where they project home movies of houses and kittens; from what I can make out. I find screenings to be quite like the music; repetitive and devoid of any lasting impression or deep meaning.

My companion remarks that we've heard about three songs which he didn't enjoy and I agree, but I thought it was first played the Halifax Pop Explosion last year and I'm very glad they came back. They play a kind of slow, languorous indie rock. It's the kind of music that, if it weren't in a loud, crowded bar; might put you to sleep and make you dream happy, weird, maybe a little melancholy dreams. Guitarist and singer Elizabeth Powell (the rest of the band is bassist Tim K and drummer Bucky Wheaton) engages the audience in nice, shy but never boring conversation. When someone in the crowd boorishly shouts out for them to do WHAM's "Careless Whisper", they politely decline. Then they launch into a song that only Maritimers can grasp the true meaning of; "Magnetic Hill". Their music sends pleasant energy through you, making you feel creative and mysterious.

Miracle Fortress at the

Marquee: The name Miracle Fortress describes this band's sound very well; it's spiritual in a way, almost transcendant; guarded by heavy, steady beats. They dreamily play their own songs such as one dedicated to

the internet as well as a cover

of a song by Halifax band Jon

McKiel. They use a tambourine

Jessie Stein. For the last two songs Van Pelt and Stein switch instruments and prove themselves to be multitalented equally · proficient.
Eric's Trip at the

Marquee: Eric's Trip is truly a trip back in time to the grungie, indie early nineties rock sound. The band from Moncton, New Brunswick was originally active from 1990 to 1996 with great success. They were the first Canadian band to sign to Seattle's influential Sub Pop record label joining bands as era-defining as Mudhoney, Soundgarden and Nirvana. They played the very first Halifax Pop Explosion in 1993 and re-united last year for Sackville, N.B.'s Sappyfest and this year's fifteenth anniversary HPX. During the period in vocalist/guitarist Julie Doiron has played with Shotgun & Jaybird as well as a successful solo career; guitarist Rick White played in Elevator and drummer Chris Thompson busiedhimselfwithMoonSocket and The Memories Attack. Eric's Trip took their name from a Sonic Youth song, and their influence is readily apparent. Between songs you are hit with a wall of amp fuzz and the growling guitars make the pit of your stomach vibrate. White and Doiron share vocals much of the time; her sweet, vulnerable voice accompanying his harsh growl. The songs are short and raw, but filled with passion that hasn't faded over the years. They play two sets, carrying the show into the night but if the crowd is tired, they aren't showing it. Everyone cheers more enthusiastically on the last song as on their introduction. Eric's Trip is legendary not only in Canadian, but indie rock history and it's easy to see why. The Marquee show





An Inconvenient Truth: It's up to us to do Something about Climate Change

When the words "climate change" pop up, a lot of people often feel overwhelmed and helpless to do anything about it. What can any one person do?

This message of what one person can do was central to the theme of An Inconvenient Truth presented at St. Mary's Thursday, October Carl Duivenvoorden, a who was personally man trained by An Inconvenient Gore. Truth's creator, Al

The presentation of An Inconvenient Truth was held as a part of the sustainability series of talks that is being presented by the Climate Change Centre of Clean Nova Scotia, as well as by SMUSA. This talk was a part of the post secondary education public outreach program by The Climate Change Centre as they try to raise awareness on the issue of climate change. Also involved in Thursday's presentation was the St. Mary's University Environmental (SMUES). SMUSA Society president Mitch Gillingwater presented Mr. Duivenvoorden with a glass globe as a token of appreciation for his efforts. Duivenvoorden is a

top level toastmaster's speaker and his natural ability for presenting a subject as vast and misunderstood as climate change was appreciated by the crowd at the packed McNally Theatre. There were only a couple of empty seats as students and interested community members alike were drawn in by the presentation which addressed three main topics; What are the causes, symptoms and solutions to climate change?

The presentation is a modified version of the film of the same name, maintaining the same message of taking action on climate change and helping people to understand the threat of global warming but since it's a little more in depth and interactive, it allows for more local references and statistics. Since Duivenvoorden is from New Brunswick, he brought a maritime viewpoint to this global situation.

"Carl really made the speech his own, he made it more personal (than the film) by sharing his own experiences. He connected to his audience by putting a maritime twist on his presentation" says Laura Simms, the president of St. Mary's University Environmental Society (SMUES). There were numerous references to local stats; he pointed out for instance who the top emitters of CO2 in Nova Scotia are and discussed what the province's carbon footprint is. Perhaps unsurprisingly, NovaScotiaPower is the top emitter in the province.

"I don't put this (graph) up to implicate Nova Scotia power or the refinery but just to point out if our demand for the products produced by this refinery that leads to those emissions and if our demand for the electricity produced by these five fossil fuel fired power plants that drives these emissions because if we didn't need power, Nova Scotia Power would shut those down. This is where our biggest footprint comes from," Duivenvoorden explained. Many of the suggestions that he made for things you can commit to are oriented around home and car ownership, he several suggestions about retrofitting a home to make it more energy efficient.

For Laura Simms who, like a large number of students, doesn't own a car she says you have to find ways to make your own difference. "We have to look at how our individual lives have an impact. We need to decide what we can do and personalize our approach". Simms has personalized her approach to being environmentally aware and suggests SMU students do the same. "The main thing I want is for students to educate themselves on what they can do".

For those who drive, Duivenvoorden suggests that you "drive smarter". This can be done in a number of ways, from the big commitment of buying a newer energy efficient vehicle (if you are in the market for a car, of course) to the small things such as checking

your tire pressure to ensure you are getting the best mileage possible and adopting a zero-idle policy, which includes staying away from drive- throughs.

Really, if people want to make a difference, eating the type of food that is generally available from drive-throughs in the first place is not a good practice. Not only for your health, but for the environment's health as well. Choosing to eat locally produced and grown food can have a huge impact on reducing the amount of transportation and CO2 emissions drastically. A hamburger from MacDonald's or any other fast food chain has a larger negative ecological impact than you might think, from the cutting of rain forest so that beef cattle can be raised, to the amount of energy consumed by the amount of transportation needed to get the finished product to the restaurant.

So, what can you do? A list was handed out showing examples of simple things that can be committed to so that we can be proactive about making decisions in our daily lives. The list ranges from doing simple things such as composting so that organic trash does not take up space in expensive landfills, to doing things such as turning off computers and lights when not needed and installing compact fluorescent light bulbs for conserving energy.

Simms suggests making sure that recyclables, organic waste, paper and other waste are all sorted properly when being thrown out. She says that a recent waste audit conducted by the

Facilities Management department showed students are not putting things in the right place and that it's really important that people take the time to put their waste in the right place. She points out that Facilities Management, which is in charge of waste Management at SMU, has recycling and waste sorting garbages located all over campus, but it is up to each individual student to ensure they are putting the right thing in the

Duivenvoorden brought it all together with the message that any one person can make a change in the world, in this case against climate change. Duivenvoorden's website, www. changeyourcorner.com explains that the presentation is aimed at "explaining what each of us can do to prevent a climate crisis".

The topics covered by An Inconvenient Truth cannot be the answer to global climate change



right place. "Instead of extracting more raw materials from the earth we can reduce what we use, and reuse and recycle them, in that order, the three R's", says Simms. The SMUES has started the Green Campus Initiative with their immediate focus on recycling and composting. SMUES has teamed up with Facilities Management, the SMU administration and the Climate Change Centre of Clean Nova Scotia in putting together an upcoming survey to be conducted on campus about attitudes and habits towards recycling. As part of raising awareness in residence, they plan to hold contests and games.

unless there is action on the part of a large portion of the world's 6.7 billion people. The truth is that climate change is happening at unprecedented rates and the human race is responsible for it. As inconvenient as that truth is, the patterns can be changed for the better and it is up to each and every one of us to make an effort. Our schools, governments and other organizations, such as the Ecology Action Centre and Clean Nova Scotia can all make recommendations, but in the end as Simms puts it, "it is the individual who needs to change their own practices."

The Place of Organized Religion at Saint Mary's

Saint Mary's is not a secular institution. Our Chancellor, the titular head of our university, is, by the Saint Mary's University Act of 1970, the man who is the Archbishop of Halifax. Our Vice-Chancellor is the man who is the Vicar-General. The Chancellor and the Vice-Chancellor, by the Act, sit on the Board of Governors of Saint Mary's University. The Board of Governors is our university's highest authority. By the Act, four other members of the Board of Governors are appointed by Roman Catholic organizations. That means six people on the 33-person board that oversees our university were seated at the pleasure of institutions of organized religion.

One of the Objects of Saint Mary's, again by the Saint Mary's University Act, is "to give special emphasis to the Christian tradition and values in higher education." (See p. 2 of the Saint Mary's University Act or p. 8 of the 07-08 Academic Calendar.) The Board of Governors has, by the Act, the "powers necessary or convenient to ... achieve the objects of the university" (Act, p. 5). I, myself, have never

these values are, but I wouldn't

be surprised to learn that some of the values that inform my life as an academic are inconsistent with Christian values. My case cannot be unique. I suspect that very, very few professors at Saint Mary's care one way or the other whether their work is in line with Christian tradition and values. I suspect that the practice of at least a few of us would prove inconsistent with those values, were anyone to check.

Happily, nobody is checking. No one is looking to see whether any professor's research or teaching is consistent with Object (b) of the Act. Moreover, no decision by the Board of Governors of which I'm aware has been intended to promote religion or has had the effect of promoting religion.

Saint Mary's ought to be an entirely secular institution. No group other than staff, alumni, students, and faculty ought to be appointing members to our board of governors. There are two reasons for this. One is just prudence. The religious institutions that appoint members to the Board of Governors could use their appointments to further their interests. We don't want to have to bother resisting a movement to have Saint Mary's give special emphasis to the Christian tradition. The other is simply self image and aspiration. Our values are secular and we would like that to be acknowledged in our charter. We want to think of ourselves as masters in our own house, our

house being a secular university. There is as well, of

course, the strange deference to religion and religious sensibilities that continues to mark even many non-believers. This deference, I think, is at least partly responsible our administration's mishandling of the Peter March affair, back in 2006, and for its coddling of the students who charged that March harassed them or whatever. Were we officially and clearly a secular institution, perhaps we could more easily see that a person's religion and all that goes with it has no more significance for personal, social, or institutional relations than any other of a person's choices.

But that Saint Mary's ought to be a secular institution does not immediately imply that we should be working to make it a secular institution. We needn't attempt to create an opportunity to make it a secular institution. But certainly we should seize any opportunity that comes along.

Maybe, though, an opportunity to make Saint Mary's a secular institution has just now, out of the blue, fallen into our laps. Right now there's a proposal in the works to sever the tie between the office of Archbishop of Halifax and the positions of Chancellor and Vice-Chancellor. Soon, it seems, the decision who is to be our titular head will rest with Saint Mary's. The Saint Mary's University Act is about to come before the provincial legislature for amendment. My thought is this: If one or two of our ties to organized religion is to be cut, we might as well agitate to have all of them cut. Why not now?



The Business of MMA, From Past to Present

Mixed martial arts is currently the world's fastest growing sport and also becoming a very lucrative one. Let's look at what makes this such a promising business venture: and who better to start with than the MMA superpower, The Ultimate Fighting Championship.


The Ultimate fighting championship, more commonly known as the UFC, began in 1993. It was founded by Rorian Gracie and was produced by SEG Sports. It began as a low budget event that pitted 8 fighters against each other in a single elimination tournament. The event had little rules and appealed to bloodthirsty fans, and connoisseurs of martial arts. The first event was a financial success since it cost very little money to put on. Instead of paying each fighter a healthy sum, the winner won \$50,000 dollars and the losers were awarded small sums for their participations. The UFC continued to hold events like this under the ownership of Robert Meyrowitz and SEG for several years. In 1997 the UFC entered what was called "the dark ages". This was a time where they could only get sanctioning to hold their events in backwater locations away from the mainstream spotlight. The interest in UFC was declining and the company was losing money. Then, the best thing ever to happen to mixed martial arts occurred.

In January of 2001, Station Casino's owners Frank and Lorenzo Ferttita along with friend Dana White acquired the UFC from its previous owners for \$2 million dollars. The purchase of the UFC was a gamble for the Ferttita brothers since it appeared that the sport was headed for the grave. Zuffa sunk approximately 32 million dollars into the UFC to attempt to get MMA back on the North American map. With a new strategy focusing on effective marketing, corporate sponsorship, commission sanctioning, home video releases, and the return of cable Pay-Per-View; "The New UFC" began a steady rise in popularity. From 2001-2005, the UFC saw a steady rise in Pay-per view numbers and event attendances. But it would not be until 2005 that the UFC would see an explosion mainstream popularity. On January 18th, 2005, in cooperation with US television network"SpikeTV", the UFC launched revolutionary

reality series "The Ultimate Fighter". This television show put sixteen relatively unknown middleweight and heavyweight mixed martial artists into a house in Las Vegas to train with UFC fighters Randy Couture and Chuck Liddell. Each week two fighters would square off in the octagon and the winner would advance in the competition towards an eventual shot at a six-figure contract with the UFC. The program was an instant success showing ratings of over 1 million men, ages 18-35 (what television business moguls call the golden demographic). The show would go on to produce many new fighters and fans that would help bring the UFC closer to the mainstream glory.

Today, while profit margins are down substantially due to European expansion efforts; pay-per-view (the company's key revenue source) is actually up 35% through the first quarter of the year. It is important to note that last year's first quarter was the weakest quarter of the year, while this year's may end up being the strongest.

Furthermore, despite a dramatic increase in expenses the company remains profitable. It is believed that Zuffa grossed



\$190 million last year and posted a before tax profit of \$76 million. They are far off that pace this year thanks to a substantial investment in publicizing the UFC brand in the United Kingdom.

A 35% increase in payper-view revenue in the first quarter from the same period last year would translate to roughly 2,295,000 buys for the first four pay-per-views of the year. Estimates place the February 4th show headlined by Anderson Silva-Travis Lutter at 350,000-400,000. There is some confusion regarding the numbers for the May 26th show headlined by Chuck Liddell-Quinton Jackson however Dana White has publicly estimated one million buys, a figure corroborated by others in the company. As you can see, the numbers do not lie. While the UFC is spending exuberant amounts of money growing the brand, they are taking in much more than they are spending. The UFC continues to this day to be the forerunner in Mixed Martial Arts in both popularity and financial status. COMPU-CORNER:

Some Programs Handle Certain Files Better Than Other Programs

One day while sitting in class, a professor was trying to open a video file, but was unable to. The reason for this is because the file was being loaded into the wrong program. Eventually the computer was moving so slow, it basically crashed and had to be restarted. By looking at the file extension, I was able to know that the file should have been loaded in Windows Media Player. Some programs handle certain files better than other programs can, but the trick is to know which ones.

The computer is a machine that can process multiple forms of data, which includes text, audio, still images, and video. Each form of data has a different file type, so as, to be able to tell the difference from one another.

The file types mostly used for text data are DOC, DOCX, TXT, and PDF. The file types DOC and DOCX are short for document, and are mostly used in Microsoft Word, with DOCX being a new file type that can only be used in Microsoft Word 2007. The file type TXT is a text file that just stores text normally without any formatting; this file type normally is opened with notepad or VI text editor. PDF which is short for Portable Document Format is file type created by Adobe, the main idea behind this file type is the ability to be able to view documents on any Operating System whether it is Windows, Mac, Linux or any other OS. PDF files are opened up in Adobe reader which can be downloaded from the adobe website.

The main file types used by audio files are WAV, MP3 and M3U. WAV or sometimes WAVE, can be use with any media player like Windows Media, iTunes, Winamp and Real player. The main disadvantage with using WAV files is that the files can be very large. MP3 are better file format to use to store audio, since the files can be very small, and still have excellent playback. M3U files are playlist files where ou can queue a group of audio files together, and play them back in order. Both MP3 and M3U files can normally be played in any Media Player program, such as the ones mentioned above.

As digital cameras and flash memory have become cheaper, the use of still images has also increased. The main file types used for still images are TIF/ TIFF, JPG/JPEG, and GIF. After scanning a picture with a scanner or fax machine they are sometimes saved as a TIFF file. One of the drawbacks of TIFF files is that they are normally very large, so large that they cannot be sent in emails. TIFF stands for Tagged Image File Format. One reason why JPEGs are preferred is the quality of the picture is very good, while the file size can be very small; as a result more pictures can be stored on a disk or flash drive when using JPEGs. JPEG stands for Joint Photographic Experts Group. A GIF file is often not a single still image but a group of still images displayed one after the other so as to appear as an animation, they are widely used on the World Wide Web. Even though GIF files consist of more than one picture and they are moving, GIF files take up very little storage space. GIF stands for Graphics Interchange Format. If you just want to view a bunch of pictures, Windows Picture and Fax Viewer is a nice and easy program to use to do this. If you want to edit pictures, Google has a neat program call Picasa, that's easy to use.


The main file types used for video files are AVI and MPEG. AVI stands for Audio Video Interleave and MPEG stands for Moving Picture Experts Group. I normally use and recommend Windows Media Player for playback of these files. Different video file types require different codecs to run. Codec stands for Compressor-Decompressor Coder-Decoder. If you try to play a video that is coded in a particular codec and that codec isn't installed on your computer, the video will not play. A program to install that comes with a wide range of different types of codecs is VLC Media player.

Tip of the Week

To select which program a file opens in, right-click on the file, move to "open with" and select the program you want to use.

TV and film barely scratch the surface of businesses that have capitalized on aliens. Alien clothing, toys, novelty gifts, house wares, you name it, it's been alienified.

Huskies Clinch Home Field Throughout Playoffs

With a convincing 49-13 victory over the Acadia Axemen Friday night at Huskies Stadium, the Saint Mary's Huskies football team guaranteed home-fieldadvantage for the **AUS Championship** Game and clinched their 1st division title since their string of 6 straight Jewett Trophy's came to an end in 2004. The Huskies move to 6-1 on the season and should breeze to 7-1

Despite losing by a touchdown to Laval in Week 7, Saint Mary's national ranking jumped from #6 to #4 going into Friday night's game. Saint Mary's had everything working for them Fridaynightincludingquarterback Erik Glavic, who threw for 207 yards on 14-19 passing with two touchdowns. On the second drive of the game, the Saint Mary's coaching staff suffered a scare as Glavic left the game with an apparent wrist injury. Back-up quarterback Ted Abraham came in for one series, only to see Glavic return to throw a beautiful 25-yard play action touchdown

pass to Frasier O'Neill down the middle and give the Huskies a 12-0 lead. The Huskies made it 19-0 on a 15-yard touchdown pass from Glavic to wide receiver Darcy Brown. O'Neill was named the Player of the Game as the junior finished with 7 catches for 118 yards and a touchdown.

Turning "TSN Point" came in the second quarter after an Acadia 8-play, 85 yard drive was finished by a fake field goal that was converted into a touchdown. Acadia followed the impressive scoring play with a recovery on the ensuing kick-off to get the ball on the SMU 28 yard line. On 3rd and short, as Acadia attempted a field goal, a SMU offensive lineman went offside,

giving Acadia a 1st and 10 at the SMU 15 yard line. This penalty turned out to be a blessing in disguise because shortly after, Saleem Borhot, a DB junior from Calgary, intercepted Keith Lockwood's pass and returned it 102 yards for the touchdown, making the score 26-7 Huskies with just 1:38 remaining in the half.

As the rain started to pour at the beginning of the third quarter and the ball became harder to throw and catch, the Huskies rushing unit took over the game. The Huskies finished with 337 rushing yards on Friday night, 199 of them coming in the second half. They finished with two 100-yard rushers as running back Allistair Blair broke through

for a 67-yard touchdown with under minutes three left in the 4th quarter. Blair finished 120 yards, his highest output of the season.

4th year running back Jacques Lumbala finished with 11 carries for 132 yards including a 12-yard touchdown run, his 8th of the season. Lumbala will need 56 rushing yards in the final game of the season against Mount Allison in order to eclipse the 1,000 yard mark. The

last SMU player to gain 1,000 rushing yards was Luis Perez back in 2001 when he led the nation with 1,257 yards. Lumbala is currently 1st in AUS rushing and 5th in the country.

Late in the 3rd quarter, kicker Justin Palardy kicked a 12 yard field goal to make the score 39-7 Huskies. It was the first time this season that Saint Mary's settled for a field goal while in the red zone. Previously, SMU was 21/21 when it comes to converting touchdowns in the red zone. Palardy made all 4 of his field goal attempts, with his longest coming from 37 yards.

Quarterback Erik Glavic has been phenomenal this season and should be the Atlantic Conference's nominee for the

the Acadia defensive line Hec Creighton Trophy (CIS Football MVP). After leading the nation's top ranked offense with 1490 passing yards, 472 rushing yards, 15 touchdown passes and 4 rushing touchdowns through the first 7 games, Glavic is looking to become just the second Huskies player to receive the honor. Former quarterback Chris Flynn captured the award three consecutive years from 1988-1990.

> If Saint Mary's continues to win, they will not play a road game until the Vanier Cup. This Friday night at 7:00, the Huskies will host the Mount Allison Mounties. If SMU beats Mount A, then St FX and Acadia will play in the AUS Semi-Final game next Saturday, November 3rd. The winner of that game will travel to Saint Mary's to play the Huskies in the Loney Bowl, the Atlantic Conference Championship game, on Saturday, November 10th. The Uteck Bowl (Atlantic winner vs. Quebec winner) will be played on the afternoon of Saturday, November 17th at Huskies Stadium. The winner of the Uteck Bowl will travel to Toronto to play in the Vanier Cup. This year, for the first time, the CIS and CFL have come together to make the Vanier Cup and the Grey Cup be played on the same weekend. The Rogers Center in Toronto will host the Vanier Cup on Friday, November 23rd followed by the Grey Cup on Sunday, the 25th.
