



The Cranky Professor

Teaching political activism at a university

Dalhousie university recently approved a course, IDS 3102, in which students are taught how to protest ("These marchers deserve credit," Chronicle Herald, Sunday 12 December). The course, according to its syllabus, is for students who want to know how to change the behaviour of contemporary institutions. It was created in response to a demand from students seeking ways "to communicate their disapproval to people in power."

Courses such as IDS 3102 raise the vexed question of the relation between academic study and political activism.

Academic study is about understanding the world. Political activism is about changing it. The worry is that when activism comes first, and gets right into the point of the course, understanding will come second, if it manages to make an appearance at all.

IDS 3102 is hardly unique in advertising itself as about how to change the world. Take a look through any university catalogue and you will find a sizable minority of courses and programs that state that their mission is to promote social justice, to foster respect for diversity, to protect the environment, or otherwise to instil in students the right attitudes and to equip them with the skills and knowledge they need to right the world's wrongs.

The case against courses that take a side or promote activism is that taking a side and promoting activism are inconsistent with the university's mission to educate its students.

A student taking a course at a university should acquire knowledge of facts and theories in the subject matter of the course. She should also gain some of the skills needed to gather new facts and to construct her own theories. In short, each course in a discipline should help her to become a competent participant in that discipline.

When a course takes a side with regard to some live issue, it cheats students out of the experience of investigating the matter dispassionately, open-mindedly, with a concern to appreciate various perspectives on the matter. Or at least so goes the objection to courses about changing the world.

So, while a university course might well take as its subject matter the condition of women in Canadian society, or public policy with regard to worries about climate change, or, in the case at hand, the phenomenon of public protest in democratic nations—its sources, its tactics, its successes, its failures—it is no business of that course even to get students to care about gender equity or government action on climate change, let alone to prepare them to protest effectively in support of what they care about.

The objection to this view of university education is not that courses need to be relevant to real-world concerns if they are to be attractive to students. There's nothing more exciting than dispassionate inquiry, as all serious students will discover. And the objection isn't that creating people passionate about justice or the environment, and who have the correct views on these matters, is more important than stuffy old academic rigour. There's nothing more likely to help us identify the messes we're in and then to help us to get out of them than academic rigour.

No, the real objection is that university education is also about judgement, about drawing conclusions. Being a competent participant in a discipline of study involves being able to form evaluative opinions. A professor of women's studies is doing what he should be doing when he

pronounces that the plight of women in poverty will (or will not) be alleviated by some particular policy. A professor in an environmental studies program is doing what she should be doing when she endorses (or criticizes) nuclear power as a response to global warming.

Students need, one might argue, to learn from the example of dispassionate researchers who, on the basis of their studies, come to practical conclusions about how things are and what should be done. Seeing their professors draw conclusions will show students how to weigh evidence and evaluate theories so that they might come to a reasoned conclusion, while nonetheless remaining open to the possibility of contrary evidence and criticism.

The point is well taken. An educated person is not afraid to come to a conclusion and to propose a course of action whenever her research leads her to a conclusion and suggests a course of action.

And yet, the worry about the infusion of politics into university courses persists. It persists because a student's being educated consists in her coming to conclusions intelligently, not dogmatically. That is, she should come to them as a result of inquiry, not as a result of her prior commitments or, worse, of pressure from the professor. Many courses and programs, though, give the impression that dogmatism is the order of the day. Many give the

impression that conclusions that students might freely draw from their investigations are, instead, basic presumptions that students in the course must accept if they're to do well.

IDS 3102, the course on how to protest, certainly gives that impression. The instructor says he is trying to change perceptions and bust stereotypes. But which perceptions need changing and which generalizations are debilitating stereotypes is part of what a course on protest should investigate. It seems that the course begins with conclusions rather than reaches them.

There's absolutely nothing wrong with a professor being a committed activist, or even with a committed or activist professor who takes pride in the commitments or activism of her students. But education must come first and nothing should be allowed to get in its way.

Open-mindedness, circumspection, the ability to weigh evidence and reasons, the ability to notice when one's conclusion is sound and when it is speculative, the ability to admit that one's conclusion is merely speculative, and, above all, the ability to seek out and appreciate criticism of one's views—these are qualities a university professor must be concerned to instil in her charges. She cannot allow anything else she might want, including saving the world, to get in her way.

Program Profile: Environmental Studies

Dr. Tony Charles is a professor at Saint Mary's, and Coordinator of the Environmental Studies Program. His research focuses on interdisciplinary studies of fisheries, oceans and coasts. Dr. Charles works with First Nations, conservation and fishery groups, and leads the Coastal CURA project based at Saint Mary's, studying coastal issues in the Canadian Maritimes

Journal: Why should any given student take a class or classes in environmental

Dr. Charles: Any student with an interest in understanding and dealing with environmental problems, or managing human uses of natural resources such as fisheries and forests, may want to check out the Environmental Studies Program at Saint Mary's. This totally interdisciplinary program combines core sciences with management, social

sciences and humanities. It comes with a variety of options, all giving students a solid capability for studying and problem-solving on issues relating to the environment and natural resources, and also preparing them for a variety of job opportunities in environmental fields.

Students in Science can take a major or honours leading to a Bachelor of Science in Environmental Studies (which can be combined with other fields through a double major, double honours, or dual degree, or done as a cooperative education option). Students working toward a Bachelor of Arts or Commerce can combine a minor in Environmental Studies with their major, whatever it is. And starting next year, there will be a brand new degree program at SMU... the Bachelor of Environmental Studies (or BES) will be of particular interest to students in Arts who want to major in the area of environment and natural

Journal: What is one class you would recommend that all interested



students have to take and why?

Dr. Charles: There is a wide variety of courses students at SMU can take on environmental subjects. In fact, there is a special place on the university website with a full list of these courses. www.smu.ca/sustainability/ programs.html for details. If you have a strong interest in the topic, a great degree program can be built from the choices at SMU. If you don't want a whole degree in environmental topics, you may well want at least a bit of 'exposure' to SMU's courses on the environment and resources. So if you just want to try out a single course, you could look into "Environmental

Challenges" (ENVS 1200) or "Biology and the Human Environment" (ENVS 1203, for non-science students), or depending on your background, you can pick from many other options, ranging from "Green Chemistry" to "Ecology and Religion". There is no single 'best' course - it depends on each person's interests, and we really have a good choice here at SMU. In fact, any of the courses will help to give an understanding of how environmental problems are analysed and what knowledge is needed to make the right decisions. And since current issues so often relate to the environment whether climate change, the state of the ocean, forest biodiversity or the tar sands - taking environment courses (or degrees) at SMU will put you in a better position to talk to others about

Journal: What Career opportunities are available in your field and how do classes in your discipline benefit those intending to pursue careers in other fields (especially those opportunities that are interesting and obscure, that most people wouldn't think of)?

Dr. Charles: Studies of graduates with a BSc in Environmental Studies from SMU show they have done very well in moving ahead in their field whether that's to graduate studies or to employment directly after graduation. That's partly because there is such a range of different employers out there needing employees with a strong level of environmental knowledge - in government, industry, nongovernmental organizations (NGOs), consulting companies and elsewhere. It also helps that Environmental Studies is a truly interdisciplinary field of study, so graduates end up with the flexibility and broad understanding needed to handle a variety of work in the future. And added to that is the fact that the generally small class sizes in Environmental Studies, close connections with the profs, and opportunities for field work and research all make our graduates ready for the 'outside world'.

Irish PM Brian Cowen steps down as Fianna Fail leader

Irish PM Brian Cowen has said he is stepping down as leader of the ruling Fianna Fail party but will continue to run the government until the general election to be held March 11.

In a week of political crises, Cowen first survived a party leadership vote but was forced to call the election after a bungled cabinet reshuffle.

Cowen faced immediate criticism for his plan to stay on as PM with Labour leader Eamon Gilmore saying it was "simply not tenable" for Cowen to remain in the post.

Fine Gael leader Enda Kenny said that he would back a motion of no confidence in Cowen as PM unless there was dissolution of parliament.

However, Fine Gael's Michael Noonan also said it would stave off the vote, and help pass a crucial finance bill, if Cowen was prepared to dissolve parliament and move the election forward.

It is the first time since 1994 that a politician has been prime minister, or Taoiseach, while not leading the main party of government in Ireland.

Cowen has seen his ratings plummet amid Ireland's economic crisis that forced the country to seek a bail-out package by the European Union and International Monetary Fund last year.

After a tumultuous week, Cowen said: "Taking everything into

account, after discussing the matter with my family, I have taken, on my own counsel, the decision to step down"

He added: "I have been in touch with no senior party figures in relation to this decision."

Cowen said he had "deep affection" for the men and women who worked for Fianna Fail and wanted it to be in the best possible position to fight the election campaign.

"The focus should be on what policies the political parties are offering, rather than on the narrow focus of personality politics.

"I am concerned that renewed internal criticism of my leadership of Fianna Fail is deflecting attention from these important debates," Mr Cowen said.

The PM said: "My intention now is to concentrate fully on government business and on continuing to implement the recovery plan.

"The government will continue to govern the country."

He also vowed that the government would win the no-confidence vote on January 25. The coalition has a two-seat majority in parliament.

Fianna Fail has confirmed it will choose its new leader on January 26. Brian Lenihan, Micheal Martin and Mary Hanafin are among the leading contenders.

Cowen pledged his "full support" for whoever was selected.

However, opposition parties insist Cowen must quit as PM and



bring the election forward.

KennysaidCowen's "attempt to remain as head of government despite losing the confidence of his own party is another sad example of Fianna Fail putting their own survival ahead of the country's survival".

Sinn Fein president Gerry Adams said: "The government and Fianna Fail are in chaos. Their focus is not on the problems facing the country."

One of Cowen's own Fianna Fail MPs, Charlie O'Connor, also opposed his move.

"I say this with the greatest of respect for Brian Cowen, but what he's just done is pointless and counterproductive."

Criticism of Cowen has intensified this month following revelations he played golf with the former chairman of Anglo Irish Bank, Sean FitzPatrick, months before the bank was nationalised to prevent it from collapse. Cowen has denied any wrongdoing.

Duvalier in Haiti: 'Baby Doc' calls for reconciliation

Former Haitian leader Jean-Claude "Baby Doc" Duvalier has called for national reconciliation in his most extensive speech since he returned to the country on January 16 after 25 years in exile.

Duvalier said his surprise return had been prompted by last year's earthquake and his desire to help rebuild the country.

Duvalier has expressed "deep sorrow for all those who say they were victims of my government".

A lawsuit suing Duvalier for torture and other crimes against humanity was filed on January 19 by a former United Nations spokeswoman, Michele Montas, and three Haitians who were jailed during Duvalier's rule from 1971 to 1986.

Montas said she had lodgedlawsuits against Duvalier for arbitrary detention, exile, destruction of private property, torture and moral violation of civil and political rights.

Haitian state prosecutors have also charged Duvalier with theft and misappropriation of funds during his time as "president-for-life".

One of Duvalier's lawyers said he was planning to stay in Haiti despite the charges, and might also get involved in politics.

Speaking in French and Creole at a news conference in a rented guest house, Duvalier said he hoped



for a rapid resolution to the political crisis in Haiti.

Duvalier arrived on the day Haiti was supposed to hold a second round of elections to choose a successor to outgoing President Rene Preval.

That vote has been postponed because of a dispute over which candidates should be on the ballot paper.

Provisional results from the first round on 28 Novemberprovoked violent demonstrations when they were announced, and most observers said there was widespread fraud and intimidation,

South African flood deaths rise to 70

South Africa now joins the growing list of countries battling flooding from unusually large amounts of rainfall which include the Philippines, Germany, Brazil, and Australia.

The death toll from floods in South Africa's has continued to rise with a reported 70 deaths and more than 8,000 families forced to leave their homes following weeks of heavy rains that began in December 2010. South Africa has declared eight of its nine provinces disaster areas.

Co-operative Government Minister Sicelo Shiceka said the flood damage was estimated at \$ 51 Million. Five other countries in the region, from Mozambique to Namibia, are also on alert for further flooding.

Some of the biggest rivers in the region, the Zambezi and the Okavango, are at about twice their normal levels.

At least 10 people have also died in floods in neighbouring Mozambique and more than 10,000

Relief workers fear a repeat of the kind of disaster that struck Mozambique in 2000, when massive floods killed 800 people.

Botswana, Namibia, Zambia and Zimbabwe have also been affected by heavy rains, according to Elizabeth Byrs, of the UN's Office for the Co-ordination of Humanitarian Affairs.

The UN is warning that there is an increased risk of cholera, which is endemic in some countries. Meteorologists say southern Africa's floods are caused by a natural cycle called the El Nino Southern

Oscillation (ENSO), which has also been linked to recent flooding in Australia and the Philippines.

South Korea battles Foot-and-Mouth disease Outbreak Keimeko Scotland

About 134,000 South military personnel are involved in efforts to contain South Korea's worst ever foot-and-mouth outbreak according to Ministry of Agriculture officials.

Authorities have killed more than 2 million animals, and fear the epidemic could cost the country \$1.4 billion, the ministry said.

The country has lost millions of dollars in exports already from the 129 confirmed cases, according to the ministry for food, agriculture, forestry and fisheries. The \$1.4 billion cost takes into account vaccinations, culling and compensation for farmers.

Up to 22% of the swine population is being culled and almost 4% of cattle. Vaccinations are continuing across the country as the government tries to limit the number of animals that need to be destroyed. The government introduced travel restrictions for livestock and ordered cattle markets to be shut shortly after the latest outbreak in the southern city of Andong.

As a result, pork and beef imports are up and retail prices of both have risen almost 9% in just one month.

The spread of bird flu is also putting pressure on South Korean farmers, with almost 4 million birds being culled so far.

The U.S. Department of Agriculture describes foot-and-mouth disease as "a severe, highly contagious viral disease of cattle and swine." There are vaccines, but they must be matched to the specific type and subtype of virus causing the outbreak.

Southern Sudan referendum: 'Massive vote to split'

With most votes counted in Southern Sudan's referendum, 99% of people are reported to have opted for independence from the north, officials

Official results are due next month but correspondents say the outcome of the week-long poll is not in doubt.

However, the former rebels now running oil-rich Southern Sudan have urged people not to celebrate vet.

President Omar al-Bashir has said he will accept the result of the vote, which was held after years of

The BBC's Peter Martell in Juba says this is the news many in the south have been waiting to hear - that the number of votes cast in favour of independence has passed the required 50%

The results were published on a website published by the Southern Sudan Referendum Commission, and officials have confirmed they are genuine.

It says that 83% of votes in

the south have been counted, along with 100% of those in the north and the eight foreign countries where polling was held.

Just 1.4% of people have voted for continued unity with the north.

More than 3 million ballots have been counted so far with several hundred thousands more still to come

Southern Sudan Referendum Bureau spokesman Aleu Garang Aleu said counting should be finished on January 31 and final results announced on February 14, after any appeals had been dealt with.

If the result is confirmed, the new country is set to formally declare its independence on July 9.

The mainly Arabic-speaking, Muslim north has fought the south, where most are Christian or follow traditional religions, for most of Sudan's post-independence history.

In order for the referendum to be valid, more than 50% of voters must back secession and at least 60% of registered voters must take part. Election officials have previously said that the 60% threshold had been passed.

Cuba not accepting mail destined for the United States

On January 21 Cuba suspended delivery of mail destined for the United States, saying the letters were being turned back because of anti-terrorist measures in the United States

The U.S. Postal Service confirmed that there are "some issues" connected with the Transportation Security Administration that it said has caused mail to "accumulate."

The Postal Service is still accepting mail from Cuba, spokesman. Dave Lewin said in a written statement. But as airlines that carry the Cuban mail "were attempting to meet the TSA requirements the mail piled up. Air carriers ran out of space and began returning mail to Cuba," he said.

There is no direct mail service between the two countries, so Cuba sends mail through Canada and Mexico.

The Cuban postal service released a statement saying: "Until further notice, our postal offices cannot accept any kind of shipment to the United States."

It added that it was forced

to suspend service because the airlines that it uses to ship mail through third countries "have returned all of the correspondence" as a result of the new security measures in the United

"There have been some issues regarding some TSA initiatives implemented in November," Lewin's statement said, describing those initiatives as "post cargo bomb threat" requirements.


In late October 2010, bombs were discovered packed in printer toner cartridges mailed from Yemen to the United States. The packages were discovered on airplanes before getting to the United States.

Many Cubans use the traditional postal system to send messages to relatives in the United States, in part because phone calls are prohibitively expensive and the internet is not readily accessible.

The newest product in Nintendo's line of consoles, the Nintendo 3DS, has been announced for a release in the United States on March 27, 2011, for around \$250 USD. This price includes the 3DS, a charging dock, and a 2GB SD memory card, and the system will be available in two colors: Cosmos Black and Aqua

The 3DS will continue to use the touch screen technology made popular by previous releases of the console, but will feature a unique glasses-free 3D screen above the touch screen. The top screen is 10% larger than on previous systems, and the traditional directional pad will include an analog joystick-style button.

Some anticipated features will not be available immediately after launch, such as the downloadable games store, 3D movie viewing functionality, or an internet browser, and word has not been given for when these will be available via firmware updates. However, many features exclusive to the new system will be available directly after launch, including a notification light indicating whether data is being transferred to or from the unit.

According to President



and COO of Nintendo of America Reggie Fils-Aime, there will be "30+ titles" available at launch for the new system. These titles will include Zelda, Ocarina of Time 3D, Kid Icarus Uprising, Dead or Alive Dimensions, Pro Evolution Soccer 2011 3D, Super Street Fighter IV 3D, as well as a new 3D Madden game. The 3DS will be backwards-compatible with previous DS games, but will simply not have the 3D functionality available for those

Additional features for the 3DS include two outward facing cameras and one inward facing camera (to capture images of the gamer in action), a personalized Mii (similar to those found on the Nintendo Wii, only created to match your own picture), a pedometer app to track and encourage movement, and the ability to play back

Launch Date Named for 3DS iPod Touch Used in Surgery

German doctors have developed a system to allow an iPod Touch to assist with surgery, providing accuracy and precision that could only previously be provided by an entire surgical computer. According to a report on German website Welt Online, the iPod Touch could replace conventional computer-based imaging systems that are used in operating

The systems that are currently being used are bulky and cumbersome, as well as being inconvenient for the surgeon, who has to constantly look between the monitor and the patient to monitor the status. The iPod Touch is portable and compact, allowing the surgeon to have it directly next to the patient during surgery, and can be carried from operating room to operating room.

There is also a question of cost. Traditional operating room imaging systems normally cost upwards of 200,000 Euros (around \$268,000 CAD), while the iPod Touch system only costs the hospital about 50,000 Euros (approximately \$67,000

This system has been in use in a few hospitals by surgeons,

orthopaedist including Bäthisin. Bäthisin stated that "The joint anatomy is recorded, digitized, the data will go to the camera system - the calculations are in milliseconds to me via iPod. It works wirelessly with wireless, so no more tripping over here in the operating room. We have achieved excellent results."

This system isn't only being tested in Europe, however. An unnamed hospital in Nashville, Tennessee is currently using the iPod Touch in a pilot program in their surgical department. In addition to orthopaedics, this system could also be used in ENT (ear, nose, and throat) and facial surgeries, and even neurosurgery.

Judge Delays PS3 Hack Ruling

Twenty-one year old George Hotz was sued by Sony for posting code to crack the PlayStation 3, claiming that this information breaks the Digital Millennium Copyright Act's anti-circumvention provisions. United States District Judge Susan Illston, however, is unsure of the jurisdiction of such a crime, and without discussing the merits of the claim (amongst other allegations), is wondering whether this crime should be tried in Hotz's home state of New Jersey.

In addition to unspecified monetary damages, Sony is demanding that Hotz remove any code uploaded to the internet in the past week. The code being shared online is a way of accessing the "metldr keys" on the console, essentially tricking the PS3 into running software not approved by Sony. This allows the console to play pirated and "homebrew" software, and is already popular amongst many of the over 41 million PlayStation 3

James Gilliland, Sony's attorney, argued that the case could fall under San Francisco jurisdiction because the hack was shared on Twitter and YouTube, both based out of California, as well as the fact that Hotz received donations via PayPal, also based out of California, though

Hotz's attorney denied this allegation. Judge Illston argued this statement, saying that if using Twitter or Facebook is enough to bring a case to San Francisco, "the entire universe would be subject to my jurisdiction." However, according to Sony's terms of use agreement, all legal disputes must be settled in federal court near Computer Entertainment America's headquarters. Because of this discussion, Judge Illston said she will rule at an undisclosed time, stating that "Serious questions have been

Hotz says that this case has no bias, claiming that "I am a firm believer in digital rights. I would expect a company that prides itself on intellectual property to be well-versed in the provisions of the law, so I am disappointed in Sony's current action. I have spoken with legal counsel and I feel comfortable that Sony's action against me doesn't have any basis."

Video Game Sales for 2010 Total Over \$15 Billion

According to a recent press release and preliminary estimate from market research company the NPD Group, gamers are willing to spend money on their hobby - to the tune of over \$15 billion for 2010 in the United States alone. The final estimate for total consumer spending will be released in March of 2011. Surprisingly, this figure is smaller than the amount spent by consumers in 2009, by 5 percent.

Anita Frazier, industry analyst for the NPD Group, believes that with changes in the way software is being purchased, there was clearly going to be a change in spending on games. "The dynamics of games content purchasing changed dramatically in 2010 with options ranging from the physical product to digital downloads on connected devices as well as in-store digital kiosks. The increasing number of ways to acquire the content has allowed the industry to maintain total consumer spend on content as compared to 2009, and we should expect 2011 to be a growth year in the games industry as the consumer demand for gaming continues to evolve."

New physical retail software (those titles purchased instores,



instead of being downloaded) accounted for the largest portion of these figures, which is higher by 3 percent than in 2009. However, the total estimate for consumer spending on video games comes from more than just the new retail copies of the software; it includes used games, game rentals, subscriptions (such as those for MMORPGs), digital full-game downloads and downloadable content, mobile gaming apps, and social networking gaming - such as those games found on Facebook.

Despite the decrease in sales compared to 2009, December of 2010 showed promising numbers for the video game industry. "December 2010 represented one of the strongest

monthly performances the industry has ever had at retail. It was a robust finish to a year marked by innovation and engaging millions of consumers through a multitude of delivery models" said Michael D Callan president and CEO of the Entertainment Software Association, the trade group that represents U.S. computer and video game publishers. "Computer and video games led all other entertainment options as we responded to consumers' demands for creative content on every platform from consoles to smart phones to handheld game devices. I look forward to a strong 2011 with a great pipeline of titles, many of which will be unveiled at the global center of video games—the E3 Expo."



Kill Me Now: Roger Waters Amused to Death



Amused to Death...bored to death is more like it. Pink Floyd's ex-bassist and dictator, flushed with victory from his live performance of The Wall over the ruins of the Berlin Wall and embittered by his inability to prevent Pink Floyd from existing without him, decided to take on God, George Bush, and the Gulf War in his third solo album, entitled Amused to Death.

The album was originally meant to be a concept album centered around an ape randomly switching channels on a television set, hence the cover, which may be the best thing about the album; however, upon listening to the album, one soon finds that this theme is quickly abandoned. Also, the first single from the album, "What God Wants, Pt. 1", which was essentially an attack on God and religion, was refused airplay by British radio for obvious reasons, infuriating



Waters.

His vocal performances in The Wall and The Final Cut were eccentric but acceptable, Pros and Cons and Radio KAOS were tolerable, but this time, Waters finds himself propped up like a dead man by female background singers. The problem with this is that the singers are the ones pushing the album along, while Waters stumbles behind. In one instance, namely "Watching TV", Waters attempts a duet with Eagles lead singer Don Henley, who happens to be a very good singer; however, Waters' arrogance sabotages this by pushing Henley into the background, making him just another background singer propping up his mortal remains.

While one song one the album, "The Bravery of Being Out of Range", shows some merit, Amused to Death is a boring, self-indulgent, arrogant piece of drivel, and is not worth wasting the hour and a half that it demands to listen to it.

bring their merchandise to make a little extra coin, and Irish was not an exception. Paula Fredericks has headed the website aucousticroof.com for four years now, a service that provides connections and contacts for house parties. She places emphasis on local musicians. The service lists musicians, a group of fifteen or more people, a great idea for an event would be a house concert.

as well as homes that host open concerts. "If you have a group of fifteen or more people, a great idea for an event would be a house concert." Fredericks emphasized communication between the organizer and the musician, "you'll want to make sure you know what kind of event you want, be it a sit-down show or someone playing in the background. We have a lot of great artists available, and I challenge you to want to talk over them!" Acoustic Roof is not a money making endeavor, more of a communication tool. "Money would be nice," says Paula, "but that's not the way the site works right now, no fees involved." She encourages interested people to go to her site and go to an

existing house concert to see what's what: "The type of people who go to these shows tend to be very generous with their time and space, I wouldn't be surprised if students could get a lift to a concert that was outside of the bus route."

With the internet making readily available music from across the globe, this is a very effective way to support local music while getting a good show. In addition to that, it's one of many great ways to make a party at your place stand out in the mind of those who attend.





Google: As always, search engine giant Google has decided to make yet another change to their business. This past week Google announced their current long-time CEO Eric Schmidt will step down in order to allow one of the companies founders, Larry Page to assume the role. As such, Eric Schmidt will now assume the role of as executive chairman of the board. Google has said via their website that Mr. Schmidt new role will allow the company to "streamline decision making and create clearer lines of responsibility at the top of the company" according to their website.

As if N.S gas prices weren't high enough, they may be headed further North. This idea stems from the fact that The Retail Gasoline Dealers Association of Nova Scotia has applied to the Nova Scotia Utility and Review Board in order to be granted approval to increase their retail markups.

The Retail Gasoline Dealers Association of Nova Scotia is seeking approval to raise their markups as a result of having not seen any increases to their markups since July 2006. In this case, gasoline retailers claim the increased markups are needed due to several changes to their cost structure that have occurred over the last approximate three and a half years. According to The Retail Gasoline Dealers Association of Nova Scotia they have experienced increased costs of doing business, such as increases to minimum wage, credit card surcharges, insurance, security improvements, etc.

According to the proposal recently submitted retail gas

markups are not going to rise significantly. Instead the Retail Gasoline Detailers Association of Nova Scotia is seeking a small increase of only one percent. P.E.I Graduates Earn Less

If you are one of the lucky individuals in Canadian society today with a bachelor's degree, unfortunately you should expect to earn less, should you choose to seek employment in Prince Edward Island. These findings have been arrived at by results a recent survey, that was conducted using graduates from the class of 2007, of the Atlantic region. The studies findings have uncovered that persons residing in the Atlantic region have experienced reduced pay rates in P.E.I v. other Atlantic provinces such as New Brunswick & Nova Scotia. One might consider it unequal pay for equal work.

The survey was conducted by the Maritimes Higher Education Commission and used metrics such as where graduates work, how much they were paid, and their debt load in order to base their results.

The results were based upon 1700 people that took part in the survey. Of these 1700 graduates, 96 studied at the University of Prince Edward Island.

Some respondents identified that indisputably, rates of pay are less in the province of Prince Edward Island but they also feel in order to receive higher wages the pursuit of a graduate degree may be a necessity, more so in Prince Edward Island than

in other provinces. Ultimately what it boils down to is the rates of pay in which 2007 graduates received. The study

found that for people able to find a job in Prince Edward Island salaries for 2007 graduates were approximately \$37,000 v. \$42,000 for people that found work in New Brunswick & \$43,000 for those that found a position in Nova Scotia.

The study noted other factors that may be influencing these results. These results may be discouraging but they also shed light on the fact that wages in Prince Edward Island for post secondary graduates declined nine percent for 2007 graduates v. 2003 graduates. This may be one plausible explanation why wages for 2007 graduates have been so disappointing.

Furthermore, some find these statistics even more troubling as the average student graduating the in the province of Prince Edward Island have been seen to graduate with a debt load on average of \$27,000 in 2007. However, surprisingly this figure has dropped significantly to \$19,000 for 2009 graduates.

Going forward the survey is scheduled to be conducted again in

At Duke University condoms are available at vending machines on campus. However, what has been discovered is that while these condoms are able to generate a dollar or two each time they are purchased, they actually cost the university more money in total. Duke university estimates the opportunity cost to be roughly \$6 every condoms sold. That is to say, every time a condom is sold at a vending machine they actually lose \$6 they could have generated via selling more widely consumed snacks foods and/or beverages in their

vending machines.

As another example, Brown University has instituted an honor system where by they offer condoms to students and expect students to leave an amount they feel is fair for taking a condom. What has been shown is that students don't seem to feel condoms are worth what they cost. The numbers don't lie. Brown has discovered from a random single purchase of \$1500 worth of condoms students only left \$150 in return for taking these condoms. That's only 10%. Surely, one shouldn't have to pay full price but 90% off isn't correct either.

Off campus, the recent economic downturn also provides some interesting condom perspectives and sales numbers. It goes without saying, that in a bad economy people tend to stay home more and this have to find ways to entertain themselves. As such; many people choose to have sex. Call it cheap and fun entertainment! Not surprisingly condom sales saw an uptake during the current economic downturn. According to Nielson Co. U.S condom sales spiked 5% in the fourth quarter of 2008 and also saw a 6% increase the following January v. sales of the previous year.

One of the technology sectors most iconic figures announced he is taking a leave of medical absence. This figure is none other than Apple Inc. Steve Jobs. Apple's charismatic chief announced January 17th, 2011 that he is taking time off due to medical reasons. In doing so, Job's will relinquish his duties over day-to-day operations to now co-CEO, Timothy D. Cook. It has been said that Jobs will still be involved with key strategic decisions, whilst on leave.

With this in mind the market quickly took notice of this substantial piece of news, though not as greatly as had been anticipated. Once the markets opened the next day January 18th, 2011 following Apple's announcement, the market only bumped down Apple Inc. (AAPL) stock marginally. This may be rooted in the notion that many feel

the company has risen to a point above and beyond Steve Jobs' vision and should now be able to sustain their efforts in creating revolutionary products whether their very own version of a revolutionist in Steve Jobs, is seated at the top or not.

A quick look at Apple Inc. most recent results might also further support this idea. Based upon what has emerged as an insatiable demand for Apple's products such as the Mac, iPod, iPhone, and iPad in the last quarter alone the company generated a unprecedented USD \$26.74 billion in revenue earning the company a profit of USD \$6 billion or USD \$6.43 a share. These impressive 2010 fourth quarter results beat analysts expectations of revenue estimates of USD \$24.53 billion and with an expected profit of USD \$5.35 a share.

In the last quarter alone Apple Inc. sold 16.24 million iPhones, 7.33 million iPads, 19.45 million iPod and 4.33 million Macintosh computers.

It should be noted that when Steve Jobs last left in order to deal with health issues, he returned to launch the tremendously successful Apple iPad. Will this leave of absence result in such a stroke of brilliance too?

Whether or not that happens remains to be seen. For now, Steve Jobs was quoted as saying "I have great confidence that Tim and the rest of the executive management will do a terrific job executing the exciting plans we have in place for 2011".

Hoax: Facebook to close March 15th, 2011

Recently, rumours have been spreading around the internet that Facebook is shutting down effective March 15th, 2011. While the event itself is hoax it has caused some Facebook users to stop and think. For those bothered by the rumour, it has called to question, what would happen to their photos, friend lists, contact information and other content were the social networking giant to close shop?

This rumour is ill timed though, as Facebook has recently received a large investment by the prestigious investment bank,

Goldman Sach's. Their infusion of cash was an approximate USD \$500 million investment into the social networking site. Given the price Goldman Sach's paid for a portion of Facebook one can establish Facebook's value to be roughly USD \$50 billion. From a logical business standpoint then, it would serve to reason that shutting down Facebook is absolutely reckless & financially irresponsible.

In order to get a sense of the value of such a substantial valuation one might look to other internet leaders that are publicly traded. By comparison Facebook's current valuation of USD \$50 billion tops eBay.com current market value of approximately USD 36.88 billion.

As another quick comparison it is also larger than Yahoo.com with a valuation of approximately USD \$21.66 billion. What's even more impressive or shocking, is that as it stands now Facebook earned roughly USD \$500 million in net profit in 2010. Thus with simple arithmetic, one can see an investor is paying roughly 100 times earnings (profit USD \$500 million, market value USD \$50 billion, 50B/500M = 100 times earnings). Again, by comparison investors in eBay.com pay approximately 14.5 times earnings & for vahoo.com investors pay 21.5 times earnings. Using earnings or the P/E ratio often serves as a tangible and easy way to establish whether a company has been properly valued relative to comparable companies in their industry or market segment.

The primary reason the statement that Facebook is shutting down March 15th, 2011 should be considered a hoax is rooted in who the idea originated from. The story seems to have originated from the supermarket tabloid Weekly World News. According to their questionable news coverage they recently quoted Facebook's founder Mark Zuckerberg as saying, "Facebook has gotten out of control and the stress of managing this company has ruined my life". The Weekly World Press in the past has reported on stories such as alien abductions and the infamous "Bat

Boy"

Unfortunately, it appears many people have fallen prey to the rumour mill. Another social networking giant Twitter saw increased volumes of its users posting links to articles on the discussion as well as posting thousands of their own unique "Tweets" on the issue.

All things considered it would make absolutely no sense to shut down Facebook. Facebook has become such an integral part of modern socialization and communications methods that it would be absolutely absurd to shut it down. It should also be noted Facebook has not yet released an official statement.

We then saw it in Italy. One massive day of rioting where hundreds of students took to the streets. Students opposed the higher education budget cuts that its country's government proposed. We even saw a lot of it within the country. This happened in Quebec when 60,000 university and college students went on strike over tuition hikes; despite the first major snowfall of the winter season and the beginning of final exams. Nova Scotian students are now getting the chance to make their voices heard.

This past September, the provincial government released the Report on the University System in Nova Scotia, written by former Bank of Montreal Executive Vice-President Tim O'Neill which recommends that the government allow tuition fees to increase indefinitely, and that the government raise the amount of debt students can take on. This September, tuition fees could increase by hundreds or even thousands of dollars.

Tuition fees in Nova Scotia have been frozen since 2007, but this policy expires on March 31, 2011. Over the next few months our provincial government will be making some decisions that will impact the affordability and quality of Nova Scotia's university system for the next several years. It is imperative that students and our allies make our voices heard. On February 2, join students from across the province and take to the streets for the Reduce Fees - Drop Debt Student Day of Action organized by the Canadian Federation of Students-Nova Scotia.

It's also good to know that 83 percent of Nova Scotians support reducing tuition fees, not increasing them, according to a recent poll conducted by Opinion Search Research, for the Nova Scotia Post-Secondary Education Coalition. The poll questioned Nova Scotians about various issues regarding post secondary education. Some of the major issues were university funding, tuition fees, and government priorities towards higher education. The poll's findings show that 83% of Nova Scotians support reducing tuition fees and 88% believe that post-secondary education should be a high priority for the provincial government. One other interesting finding was that, when asked, 60% of Nova Scotians have agreed to pay higher taxes if that resulted in improved affordability at universities within Nova Scotia.

The SMU – NSPIRG team will have a meeting on Thursday January 24th at 4 in their office on the fifth floor of the SUB (room 504)

They'll be discussing strategies and other plans leading up to the big Day of Action. The plans for the day of action for Saint Mary's will be for everyone to gather at the student centre quad. From there we will march together to Victoria Park to merge with the other universities and colleges in the surrounding area for a Halifax-wide rally. The participating schools include Acadia, Sainte-Anne, Dalhousie, NSCAD, MSVU, and King's. We will then march to the Province House for 2 PM.

The Canadian Federation of Students unites more than half a million students from 80 student unions across Canada. The federation was formed in 1981 to provide students with an effective and united voice, provincially and nationally. It strives to provide students with a platform to make their voices heard and represents the collected interests of students nationwide.

The Decline of the Printed Word: Folly of the Book Industry or Child of Technology?



In the middle of a worldwide economic slump, in which individuals are tightening their purse strings on luxuries, book publishers are pumping out extravagant, overpriced volumes in an effort to compete with the new technologies of the 21st century. Most of the books printed are crap that litters the self-help and entertainment shelves, trivial matters that have long been replaced by the internet or other mediums. All books today are ridiculously overpriced, especially



here in Canada, where books cost almost twice as much as they do in the United States. In an effort to curb these ridiculous costs, many buyers turn to alternative sources: second-hand bookstores and online sources. Due to the popularity of these resources, especially online sources, the printed word may be declining and the book industry is certainly suffering.


Universities are possibly the biggest abusers of the printed word. An example: as a student in the English department in Saint Mary's University, books play an extremely important role in my education. In an English class, the textbook is the course, and usually more than one book is required for each course. A semester with three to five English classes requiring approximately four books per course equals... a lot of books.

The prices at the Saint Mary's University bookstore are absolutely ludicrous, as most of you are aware. Due to these outrageous prices and the fact that most books covered in the English are established classics, I have resorted to scouring

second-hand bookstores for alternative copies of the required books. I am not the only person to do this, I am sure. For the price of one book at the SMU bookstore, one can purchase the entire readings for a given course second-hand in other editions.

Of course, not every book I require is locatable at local bookstores. Therefore, I am than forced to use the resources of the internet. Various online resources such as Enotes and Project Gutenberg provide classic texts for little to no cost at all. This provides a prime example of an individual who is driven to abandon the printed text. It never fails to make me angry to see my classmates with their expensive textbooks, mindlessly throwing their money away. By forcing students to spend needlessly and wastefully on overpriced, useless books, universities are not creating an appreciation for the written word as many administrators probably would believe, but rather a disdain for the book industry. Universities also provide revenue and customers for online sources and second-hand bookstores, rivals to the book industry, through students who seek alternatives to university bookstores.

I remind you that what I have said must be taken with a grain of salt. I do not offer this as a definitive explanation for the decline of books, but rather a speculation based on common sense for as to why people may be turning from books to online resources. Nevertheless, the fact remains that the book industry is suffering, and there is some correlation between this and the price of books.

Are we Learning Anything in Here?

Is the system failing?

This question comes at a time when a lot of relevant things are going. One study on American students shows that students learn next to nothing in their four years at university. The report blames professors and students' lack of studying. Also, the ability to buy your lecture notes right off the internet isn't a good step forward...or is it? Some have also questioned the effectiveness on how students are assessed. Many argue that tests, the most common form of assessment, are a terrible way to make students learn the material of a course. A study published in the journal Science proves otherwise.

In a study, conducted by New York University sociologist Richard Arum and Josipa Roska from the University of Virginia, more than 3,000 students from 29 universities were surveyed in regards to their skills in writing and critical thinking. The studies showed that after four years in university, 36 percent of students had barely improved their skills. Another

interesting finding was that students these days only spent half the time studying than students a decade ago. Study time continued to decrease to what it is now, but the average GPA of students is a 3.2. One of the reasons for the results is that professors are spending more energy on research and less time on teaching. Is the system

Several websites have launched in the recent months within Canada allowing students to buy and sell their lecture notes online. Two websites, studymonky.ca and notewagon.ca, now allow students to make a business of their notebook scraps. They also make skipping class easy. The websites cover most of the big schools in Canada; Saint Mary's hasn't made an appearance on them yet. Will this help students more or will their laziness be the end of them? Is going to class even necessary at all if all the material can be found online? Some also argue that the lecture notes are the intellectual property of the lecturer and should not be up for sale.

I have always been a sceptic on the effectiveness of tests as a

method to make students learn the material of a particular course. A recent study published the journal Science has proved me wrong. The study shows that students who are given content to study and are then tested right after retain about 50% more of the information than students who used other methods. The report showed that students were better off quizzing themselves right after they studied than students who studied intensively or who used detailed diagrams documenting what they were learning. So those professors who repeatedly quiz you on course material might be a pain in the butt at first, but are ultimately doing the best thing for you. Still though, a lot more factors other than the ones I mentioned make me ask the question "are we learning anything here?"

Climbing Mountains of Foody Goodness

In keeping with my new year's resolution to not give a damn about the caloric value of the food I prepare and ingest, I give you Parmesan breaded pork chops, herb-mashed potatoes and Toblerone cupcakes! (Or for those of you on a budget, honey almond nougat-infused chocolate triangle log cupcakes!) Enjoy.

Breaded Pork Chops

This recipe may seem intimidating, but it's really just home-made Shake-n'-Bake. Adding breading is an easy way to dress-up simple cuts of meat. This recipe will work with chicken, pork and thick cuts of fish, just adjust-your cooking time accordingly. Why not just go out and buy some Shake-n'-Bake? So you can point to your roommate's rapidly disappearing dinner and go, "I MADE

4 centre-cut pork chops

1 cup bread crumbs (if you don't want to buy them, chop two slices of bread into cubes and bake them at 300 10-15 minutes stirring occasionally. Let cool and chop into fine crumbs.)

Pepper, thyme, oregano

½ c Parmesan cheese

2 Tbsp olive oil Preheat the oven to 350.

Mix the crumbs, cheese and as much

spice as desired in a freezer bag. In a shallow dish, stir the eggs with a fork.

Dip the pork chops in the egg. Drop the pork chops into the crumbs, shaking to coat.

Heat the olive oil in a large frying pan and fry pork chops 1-2 minutes per

Transfer to a baking sheet and bake at 350 20-30 minutes, or until done.

Herb Mashed Potatoes

4 Tbsp herb and garlic cream cheese

1 Tbsp butter

2 Tbsp milk

Peel and cook the potatoes. If you need instructions on how to do this, put the paper down and step away from the stove.

Drain well and mash in the cream cheese, butter and milk with a masher, whisk or electric mixer.

Toblerone Cupcakes

This recipe addressed a very important concern in my house. What in the hell do you do with all the leftover Christmas Toblerone?! The answer: these. This recipe uses two regular sized bars or 1 regular sized bar and 1/3 of a giant sized bar. The cupcake batter is thick, like a muffin, which helps balance out the sickeningly delicious sweetness of the chocolate. Makes 12.

Cupcakes:

½ c butter or margarine

3/4 c sugar 2 eggs

1 ½ c flour

1 1/2 tsp baking powder ½ c milk 1 tsp vanilla

1 c Toblorone pieces, coarsely chopped

Preheat the oven to 350 and line 12 muffin cups with paper liners.

Beat butter and sugar 3 minutes, or until light and fluffy.

Add eggs one at a time, beating well after each addition.

Combine the milk and vanilla.

Add the flour and baking powder, alternating with the milk mixture, to the butter mixture.

Stir in the Toblerone pieces.

Fill the lined muffin cups halfway and bake at 350 20 minutes, or until a toothpick inserted into the middle of a cupcake comes out clean.

Cool completely and frost with frosting...that's Toblerone Toblerone frosting.

Toblerone Frosting...that's right... Toblerone Frosting:

3 regular sized Toblerone triangles, or 1 of the big ones

1/4 c butter, softened

1 ½ c icing sugar

Combine the milk and Toblerone over low heat, stirring frequently to prevent the nougat from sticking bottom of your pot

Beat the butter for 30 seconds. Add 1 c of the the icing sugar.

Gradually beat in the chocolate-milk mixture and beat until you have a spreadable icing, adding more icing sugar if necessary.

The Calgary Stampeders drafted Steve in 2003 first overall. He currently plays for the Winnipeg Bluebombers. He has also

played for the Green Bay Packers, Seattle Seahawks, New York Jets and the Toronto Argonauts. One of the things that was most impressive about the way that Steve played the game is that he was so committed, I mean it was almost scary how committed this man was, and still is, to the game of football. He always put a hundred and ten percent into everything he did on the field; he was, and remains, the definition of a professional.

NFL Divisional Playoffs: Old Franchises, New Ways to Win

Four of the NFL's oldest and most storied franchises head into championship weekend looking to battle it out for a chance to play in Superbowl XLV. Pittsburgh, Green Bay, Chicago, and the New York Jets all advanced from the Divisional Playoff round thanks to solid defense and great games from each of the winning quarterbacks.

The Pittsburgh Steelers were able fight back from a 21-7 first half deficit to overcome the Baltimore Ravens 31-24. The Steelers' defense was able to force three Ravens' turnovers (two fumbles and an interception) which gave Ben Roethlisberger and the Steelers' offense the chance to score 17 unanswered points. The game was tied with just over two minutes left when Roethlisberger completed a nearly impossible 58 yard pass to Antonio Brown to put the Steelers in position for the go ahead touchdown.

In Atlanta, the Green Bay Packers were able to deliver the knockout punch long before the game even ended. Packers' rookie defensive back Tramon Williams intercepted Atlanta quarterback Matt Ryan twice in the last 2:30 of the second quarter, one of which he returned 70 yards for a touchdown to give the Pack a 21-14 lead going into the third quarter. The Packers' D shut down Atlanta's vaunted running game and quarterback Aaron

Rodgers completed all but five of his 36 pass attempts and threw three touchdowns to lead his team past the top seeded Falcons by a final score of 48-21.

The Chicago Bears scored their first touchdown on the third offensive play of the game 1:17 into the first quarter on a 58 yard pass from QB Jay Cutler to TE Greg Olsen, and they never looked back. The Bears defense didn't allow their opponent, the "Cinderella" Seattle Seahawks, to score any points until the end of the third quarter and didn't allow a touchdown until the fourth quarter, in which the Seahawks scored three. Bears' quarterback Jay Cutler threw for two touchdowns and ran for two more to account for 28 of the Bears' 35 points. The game ended with a score of 35-24, a total which makes the game look a lot closer than it actually

Finally, in a game in which many believed New England Patriots quarterback Tom Brady would be the player to make the biggest difference, second year New York Jets quarterback Mark Sanchez lead his team to a win over the heavily favoured Patriots. Although Sanchez did not have a great game, he played mistake free football and managed the game well enough to allow his defense to completely shut down Brady and the Patriots' feared offense. Brady looked uncomfortable most of the game. He was sacked five times and threw his first interception

since the sixth week of the season. However, the Pats were still in the game going into the fourth quarter, coming to within three points. Sanchez answered back 2:13 later completing a touchdown pass to Santonio Holmes, essentially ending any hope of a Patriots comeback. Both teams scored one more touchdown each for a final score of 28-21 Jets.

The final four teams left in the NFL's playoff tournament are some of the league's most historic. The Packers and QB Bart Starr won the first Superbowl ever. The Jets won Superbowl III, in which they were large underdogs, behind the unlikely guarantee by Broadway Joe Naimath. The Pittsburgh Steelers won four Superbowls in the 1970s and have two since the turn of the millennium. The Chicago Bears are the one of two remaining founding teams of the NFL, established in 1919, and have won 9 NFL championships since that time, the most recent coming in 1985.

The Packers' go to Chicago to play the Bears for the NFC title Sunday at 4 PM and the Jets head to Pittsburgh to play the Steelers in the AFC Championship game Sunday at 8:30 PM.


