## Saint Mary's University – A Leader in International Education

**S**aint Mary's University is recognized as one of the most internationalized universities in Canada. This is the result of years of dedication to international expansion through research, projects, programs and recruitment.

In the 1970s, Saint Mary's established the International Education Centre under the leadership of Dr. Bridglal Pachai, followed by Dr. Jim Morrison which made the University a leader in the field of development education. In the 1980s, Saint Mary's became active in international development projects, working mainly in China with the China Language and Cultural Project, and with Xiamen University to help establish their MBA program. Over these years a number of Saint Mary's researchers were very active, often sponsored by the International Development Research Centre, in a variety of overseas countries. Today, professors are conducting research initiatives in such diverse places as Chile, Mexico, China, Cambodia, and the United Kingdom. Saint Mary's has developed a number of international academic programs, such as International Development Studies, Asian Studies, Global Business and Environmental Studies, and many language programs taught at the University.

### MBA Games 2001



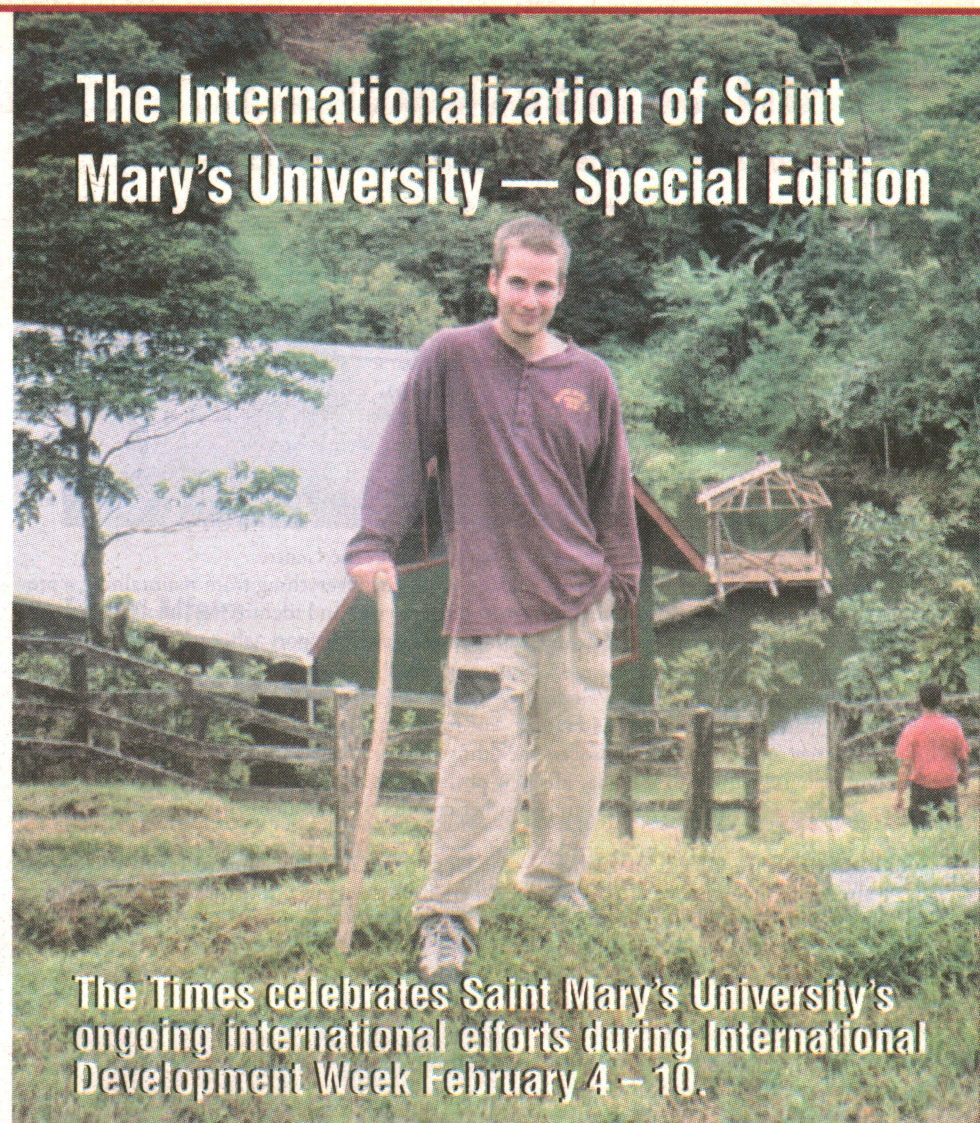

Saint Mary's University is taking a leading role in training students locally to assist information technology companies throughout the region meet their software development needs.

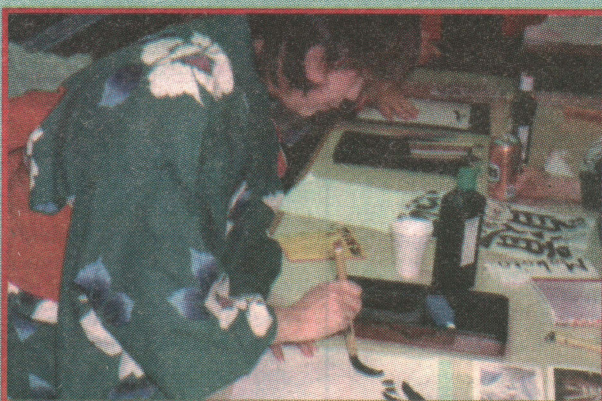

# Renovation and Renewal 2001

## Saint Mary's Unveils State-of-the-Art Residence

After a year of extensive renovations, Saint Mary's is reopening the Loyola residence this month. The renovated Vanier residence will open in September. The University's \$25 - million investment in the renewed complex will provide Saint Mary's students with high quality, community-centred residence life with all the 21st century conveniences.

The renovation and renewal project represents a significant upgrading of the University property. It also represents the University's dedication to making technology more accessible for Saint Mary's students. Each room has been fully wired for Internet hook up, telephone and cable television. Every student living in residence will now be able to plug-in to the Internet, Saint Mary's on-line courses and library services. This will add to the more than 1,000 Internet access ports located throughout the Sobey Building and the Loyola Academic Complex in labs, offices, classrooms and lounges, everywhere students work and meet.

The new \$18 - million Sobey Building has given students a state of the art learning environment that is among the most modern and beautifully designed in North America. The same care and attention to detail is being focused on the living environment of students.

The improvements have placed the residences in line with future standards and include new attractive exterior cladding and larger energy efficient windows to enhance interior light. Each room has a bright modern look with new attractive furniture including desks, beds and closets with convenient shelving units. The Loyola residence will also include student lounges with food preparation areas and new apartment suites for senior students.

The University's Rice Residence provides apartment style living accommodations in the heart of the University campus. It has been completely refurbished over the past five years, creating an architect-designed, fully-wired residence facility for 380 students. Each room has a cable television outlet and each bed has an Internet and telephone outlet. The 232-bed Vanier Residence will also be fully-wired and refurbished by September 2001.

The renovations are the latest in a series of projects that are being completed in preparation for Saint Mary's bicentennial celebrations in 2002. ♦

## Part-Time Faculty Contract Signed

Saint Mary's University and Saint Mary's Part-time Faculty Union represented by CUPE 3912 signed a new contract agreement on May 8, 2001. The University is pleased with the settlement in that it meets our goal of fiscal responsibility while recognizing the important role played by part-time faculty. The University ratified an agreement with the full-time faculty, represented by the Saint Mary's University Faculty Union earlier this year.

# The Office Next Door — A Distinctive Honour

Corporal Louis Godin, a Saint Mary's Commissionaire, received the Canadian Peacekeeping/Service Medal at a ceremony held at Shearwater on April 18 for his service in Cyprus in the early seventies. The long awaited acknowledgement of Godin's contribution to the peacekeeping efforts is a highlight in a distinguished career in all three elements of the Canadian Forces spanning over three decades.

"I joined the service when I was 17," says Godin who has been a Commissionaire at Saint Mary's University since 1995. "For me wearing a uniform has been my life." One part of that career included two tours of duty in Cyprus in 1969 and 1971-72.

Godin was only 19 years old when he arrived in Cyprus where tensions were heightened between the Turkish and Greek populations. He says that he didn't have a lot of experience or training at that point, "I had to be vigilant and always have my eyes open to make sure that the civilians were safe."

This year, a program was introduced to offer all peacekeepers the opportunity to receive the Canadian Peacekeeping/Service Medal. Godin says, "It means that we've finally been recognized for the peacekeeping all those years ago." He jokes that most of the recipients at the ceremony were being recognized for service in the nineties. "Everyone realized that in your 50s you are still young to be a soldier."

Godin served with the 22 Regiment from 1967 to 1980 and he sailed on Canada's last operational aircraft carrier, Her Majesty's Canadian Ship (HMCS) Bonaventure. After retiring from the navy as a Steward in January 1992, Godin joined the 12 Air Reserve Flight (12 ARF) and worked as a steward at the Warrior Block Accommodations office. In 1994, he was re-assigned to the Chief Warrant Officer's office where he has remained, performing administrative and logistics duties on a part-time basis in addition to his duties at Saint Mary's.

Warrant Officer Bob Grundy, says that Godin is an "extremely resourceful person who always finds a way to get things done". He is described as a morale builder among his co-workers who keeps spirits up during times of difficulty and stress. Godin's peers recognize him as one of the most experienced and diversified reservists.

"I am with the air reserves because of my love of the uniform", says Godin. He says that the satisfaction of serving in the military, along with the sense of camaraderie he shares with his fellow workers, can't be found anywhere else. ♦

## Saint Mary's Researcher Named One of Ten World Leading Ocean Champions

Dr. Tony Charles, a Saint Mary's professor of Management Science and Environmental Studies is a recipient of the 2001 Pew Marine Conservation Fellowship – the world's only prize dedicated to marine conservation.

Dr. Charles has been awarded US \$150,000 by the prestigious Pew Fellows Program in Marine Conservation, an initiative of The Pew Charitable Trusts operated in partnership with the New England Aquarium. This year's winners have been chosen from Canada, Italy, Spain, Russia, the Philippines, and the United States. Dr. Charles is the only Canadian to be honoured this year and only the third Canadian to receive the fellowship. Each year ten outstanding ocean champions are supported to undertake pioneering projects that tackle urgent conservation challenges in four areas: sustainability of marine ecosystems, fisheries management, marine contamination, and coastal conservation.

"It's hard to convey what an honour it is to be chosen for a Pew Fellowship. It's also a big responsibility, because the goal of these awards is ambitious - literally to help protect the world's oceans while supporting those who rely on the oceans for their livelihood," says Dr. Charles. "Fortunately, I'm working on this

as part of a team effort, together with wonderful Mi'kmaq and non-native colleagues in the fishery, so I have high hopes for a successful and very interesting experience."

Dr. Charles will apply his fellowship to provide a positive, conservation-oriented response to the 1999 "Marshall Decision" that recognizes native commercial fishing rights and is dramatically changing fisheries in Atlantic Canada. Working closely with native and non-native fisher organizations, he will develop capacity for community-based, ecologically oriented approaches that enhance resilience of the ecosystem and the fishery itself. Dr. Charles will be developing and promoting 'robust management' methods for the fishery and tools for sustainability assessment based on appropriate sets of indicators. ♦

# Saint Mary's Honorary Degree Recipients May 15, 2001

## MARY ASHWORTH

MARY ASHWORTH IS AN ACCOMPLISHED EDUCATOR WHO PIONEERED TEACHING ENGLISH AS A SECOND LANGUAGE IN CANADA.

Ashworth received a B.A. and M.Ed. from the University of British Columbia. As a professor of education at UBC, Ashworth got involved in training teachers to teach ESL which was in its infancy. She had been an elementary and secondary school teacher from 1955-1967 and was aware of the needs of non-English speaking children in the classrooms.

UBC became the only place training ESL teachers outside of Toronto. Ashworth traveled across Canada conducting workshops, making speeches, writing books and articles and acting as a consultant to school boards, departments of education and First Nations' bands. In 1988, She published a book about the state of ESL in Canada entitled *Blessed with Bilingual Brains: Education of Immigrant Children With English as a Second Language*.

Ashworth's contribution to the development of ESL programs was acknowledged by Teachers of English as a Second Language (TEAL) which held a conference in 1988 in her honour to mark her retirement. In 1989 she was made a fellow of the Ontario Institute for Studies in Education (OISIE). UBC has presented Ashworth with awards of merit and distinction and in 1993, granted her an honorary doctorate. Ashworth will receive an honorary Doctor of Education from Saint Mary's University at the convocation ceremony on May 15, 2001.

## A. GARNET BROWN

GARNET BROWN HAS HAD A DISTINGUISHED RECORD OF POLITICAL AND COMMUNITY SERVICE AND LEADERSHIP IN BUSINESS. Brown has been the President and Director of A.G. Brown and Son Limited for 45 years, was one of the two founders of Halifax Cablevision and one of the founders and Director of Dartmouth Cable Television.

He founded the brokerage firm, A.G. Brown and Son Limited with his father in the mid-fifties. A.G. Brown and Son remains one of Atlantic Canada's leading brokerage firms and the recipient of many awards from leading manufacturers. Brown has had numerous business affiliations including Director of the Investors Group. He has also been actively involved in elements of community life from a role as National Director of the Duke of Edinburgh Awards to a supporter of sports and business studies.

Brown served as a Member of the Legislative Assembly for the province of Nova Scotia in the Halifax-Eastern Shore riding from 1969-1978 with portfolios including Minister of Highways and Public Works, and Minister of Tourism. As Minister of Tourism, Brown purchased the Bluenose II, turned it over to the province and led a fundraising campaign for its restoration. He has received numerous awards for his government service, and is a member of the Nova Scotia Hall of Fame. Brown will receive an honorary Doctor of Commerce from Saint Mary's University.

## TERENCE RICHARD BOYD DONAHOE

TERENCE DONAHOE HAS DEDICATED HIS PROFESSIONAL LIFE TO PUBLIC SERVICE IN NOVA SCOTIA. The five time elected member of the Nova Scotia Legislature, key cabinet minister, and Leader of the Opposition and Interim Leader of the Progressive Conservative party has made a unique contribution to the political life of the province.

Donahoe, a devoted Santamarian has supported and continued his family's long-term connection with Saint Mary's. His late father, Senator Richard Donahoe, was also honoured with an honorary degree from Saint Mary's.

Terry graduated from St. Mary's High School in 1960, and then went on to receive a Bachelor of Commerce from the University in 1964. After completing his studies at Saint Mary's, he went on to receive an LL.B. from Dalhousie University in 1967.

His distinguished political career began when he was elected to the Nova Scotia Legislature in 1978. He was reelected in 1981, 1984, 1988 and 1993. During his days in public office he was appointed Member of the Executive Council, held various portfolios including Education, Tourism and Culture, Environment, Labour, Attorney General and Chair of the Management Board. Donahoe served as the Leader of Her Majesty's Loyal Opposition and Interim Leader of Nova Scotia's Progressive Conservative Party from 1993-1995.

He has played an important role at Saint Mary's as a prominent alumnus and terms as President of the University's Alumni Association and as a member of the Board of Governors.

In the spring of 1999, he received the Alumni Association's Distinguished Community Service Award. Today, Donahoe holds the position as Chair of the Board and Executive Vice-President of Gammon Lake Resources. Donahoe will receive an honorary Doctor of Laws from Saint Mary's University.

## THE HONOURABLE E. LEO KOLBER

SENATOR E. LEO KOLBER HAS CONTRIBUTED TO CANADA'S POLITICAL, BUSINESS AND CULTURAL REALMS. Senator Kolber was summoned to the Senate of Canada in 1983. He holds a B.A. and B.C.L. from McGill University.

A lawyer by profession, Senator Kolber is well known for having established The Cadillac Fairview Corporation which became one of the world's leading real estate developers responsible for landmark buildings such as Toronto's Eaton Centre and Vancouver's Pacific Centre.

For almost three decades, Senator Kolber was President of CEMP Investments. During his tenure, CEMP concentrated on the development of real estate in Canada, the United States and Europe.

Senator Kolber has served on numerous boards. He was a Director of the Seagram Company Ltd. From 1971 to 1999; The Toronto-Dominion Bank from 1971-1998 and Loews Cineplex Entertainment Corporation from 1998-2000.

Senator Kolber was Chairman of the National Revenue Committee, Liberal Party of Canada. He is active in community, social, cultural and philanthropic activities. In 1996, Senator Kolber was honoured by Concordia University with a Doctor of Laws Honoris Causa. He will receive an honorary Doctor of Laws from Saint Mary's University.

## SARA LEE LEWIS

SARA LEE LEWIS HAS BEEN DEDICATED TO ENRICHING THE CULTURAL LIVES OF CHILDREN FOR THIRTY YEARS. In 1971, the Montreal, Quebec native moved to Wolfville, Nova Scotia. Lewis has a BA in English Literature and Sociology from McGill University and was involved in journalism and theatre promotion.

A year after she came to Nova Scotia, Lewis co-founded Mermaid Theatre of Nova Scotia. She worked with the company in different capacities including her appointment as Managing Director in 1991. Under her management, the company has gained international recognition with performances on four continents. Mermaid Theatre is also well known for its work in Nova Scotia through its public and school performances. Lewis has also been a champion of the Nova Scotia arts community. She has contributed to cultural organizations, volunteer committees and boards of directors at the local, national and international level.

Lewis became a Member of the Order of Canada in April, 2000 and received the Canadian Progress Club Women of Excellence Award for Arts and Culture in November, 2000. Lewis will receive an honorary Doctor of Letters from Saint Mary's University.

## DAVID PETRIE

DR. DAVID P. PETRIE IS AN INTERNATIONALLY RECOGNIZED ORTHOPAEDIC SURGEON AND PROFESSOR OF MEDICINE.

He received a B.A. from the University of New Brunswick and studied medicine at McGill University. Dr. Petrie has practiced as an orthopaedic surgeon at Dalhousie University since arriving in August, 1970. He is a full professor in the Department of Surgery, Faculty of Medicine. He continues full clinical practice with a particular interest in joint arthroplasty (replacement) surgery, orthopaedic trauma, fractures and other injuries as well as an ongoing interest in sports medicine. His efforts in sports medicine have focused primarily on Saint Mary's University's varsity athletes.

Dr. Petrie is a member and served as President of the Canadian Orthopaedic Association. He is a founding member of Hip Hip Hurray, a charitable walk that the association holds every spring to raise funds for orthopaedic research. The event has raised over ten million dollars for research, education and patient care.

Dr. Petrie is active in a variety of research activities including working towards the establishment of a Canadian Joint Replacement Registry and presents at national and international meetings. Dr. Petrie will receive an honorary Doctor of Science degree from Saint Mary's University.

## Rigakos Named Law Commission's First Virtual Scholar In Residence

The Law Commission of Canada has named Dr. George S. Rigakos, a Saint Mary's professor in the Department of Sociology and Criminology the first Virtual Scholar in Residence.

The Virtual Scholar in Residence is a joint initiative of the Law Commission of Canada and the Social Sciences and Humanities Research Council of Canada. The purpose of the program is to promote multi-disciplinary research on issues surrounding law reform and to create alliances between academic disciplines, the Commission, and policy makers by providing support to individuals conducting innovative socio-legal research. The program provides funding for an individual to work with the Commission for a six-month period to advance its research agenda. "It's a great opportunity to connect with policy-makers and other academics across the country. I'm looking forward to the challenge," says Dr. Rigakos.

Since the scholar works 'virtually' with the Commission, making full use of e-mail, tele-conferencing, video-conferencing and other new technologies, the program provides the Commission with the opportunity to take advantage of the brightest scholars from across Canada.

Dr. Rigakos has conducted research on the emerging relationship between public and private security. His most recent book, *The New Parapolice: Risk, Markets and Commodified Social Control*, is forthcoming with U of T Press. The theme for this year's Virtual Scholar in Residence program is law and communities. The Commission is interested in examining how the evolving relationship between private security and public police responds to the order and security needs of different types of communities. Beginning in the Fall, 2001 Dr. Rigakos will play a leading role in advancing the Commission's research in this area. ❖

will be able to leverage other funding, increase contract research and develop more partnerships among our universities, research institutes, colleges, hospitals and the private sector. The resulting capacity building and research critical mass will permit Nova Scotia to remain nationally and globally competitive in the dynamic and exciting knowledge-based economy."

CFI was established by the federal government in 1997 to provide 40 per cent of infrastructure costs for research projects. A federal-provincial program which provided required matching funds is nearly fully committed. The new trust fund will ensure that Nova Scotia can match the foundation's investments.

The trust fund has been established by the Department of Finance with surplus provincial funds. It will be managed by an administrative body comprised of all Nova Scotia university and college presidents and three government representatives from the departments of Education, Economic Development and the Technology and Science Secretariat. ❖

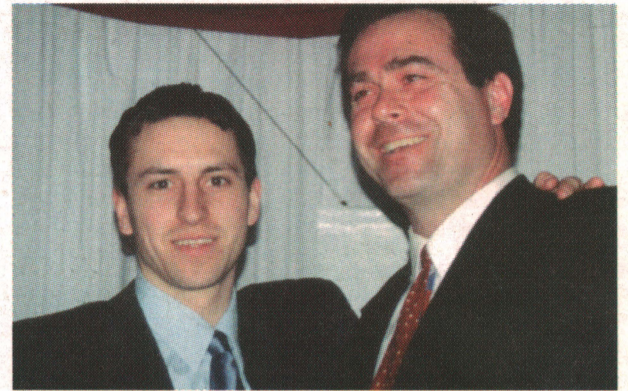

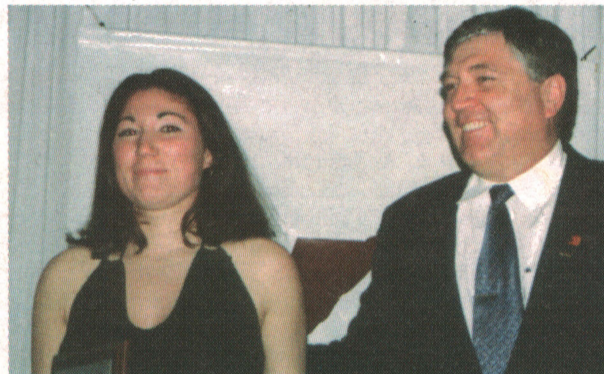


Jonah Taussig, Male Athlete of the Year with Basketball coach, Ross Quackenbush.

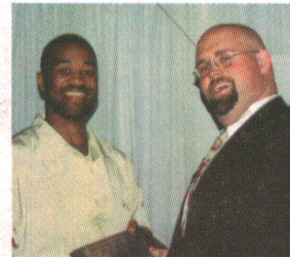

## Computing Science Grad to Develop Software for Microsoft

Cedric Davies, a fourth year computing science student has accepted a lucrative position with Microsoft. Davies has excelled at Saint Mary's and was captain of the University's computer programming team that won the Atlantic provinces title at APICS and advanced to the Northeastern regional finals for two consecutive years.

The job offer came after a February recruiting trip to Microsoft's headquarters in Redmond, Washington. "The interviews usually involved some brain teasers, some coding on the whiteboard and talking about how I would test my code," he says. "They are more interested to see how you think when solving the problems, than if you actually solve their brain teaser." After being offered the job, Davies was given a choice about what group of Visual Studio, a product developers use for writing software, he wanted as a work group. He chose to work on a new product called Visual Studio Frameworks and Tools, to be released in August. These are software components and other tools used to develop applications, such as e-commerce sites. "I chose my group because the technology sounded the most interesting and it was something new," he says.

Davies will "own" certain aspects of the project, learn everything there is to know about his elements of it and how they interact with the rest of the product. He will then develop and implement a test plan which will involve writing programs that will automatically run the product. He will test for bugs and performance issues and then work with developers to fix the problems.

"Microsoft strongly values their employees and promotes a good working atmosphere," Davies says. "I am really looking forward to working there." Dr. Pawan Lingras, a professor in Saint Mary's mathematics and computing science department who worked closely with Davies, co-published papers with him and was one of the coaches of the programming teams says, "The offer was especially meaningful because of the current economic climate."

During his years at Saint Mary's, Davies received a number of scholarships and bursaries, published and presented papers and last summer won one of the ten highly sought after summer research scholarships from the Department of Combinatorics and Optimization, University of Waterloo. The competition was open to students from any international university. Davies was recently awarded an NSERC postgraduate scholarship but has chosen to defer graduate studies. "His achievements have enhanced the reputation of our program and the University," says Dr. Lingras.

"From the start I set out to do the best that I could." Davies says. He adds that he was able to interact on a friendly and informal level with his professors in the C.S. department. "I think this kind of learning atmosphere was good for me." He says that the programming competitions were highlights during his time at Saint Mary's. "All the professors were very interested in our outcome and gave us a lot of support," he says. "Being able to compete in your discipline and win against neighbouring schools with much larger departments is really something."

As far as future plans, Davies says, "I'm not looking too far ahead at this point. My hope is just to enjoy myself at Microsoft, work hard and be the best I can be, the same goals I had coming to Saint Mary's." Davies is the second Saint Mary's computing science graduate to be recruited by Microsoft in the last year. ♦

## Jeffrey Named to National Basketball Coaching Pool

Saint Mary's women's basketball coach Jill Jeffrey is among a group of 18 coaches named to the Canada national program selection pool for this season. The women's program has three levels of competition this year to begin the new cycle toward the 2004 Olympics.

The senior women, under head coach Ben Smith, will compete in the COPABA world qualification tournament in San Luis, Brazil from September 6 to 11. There are three positions available from this tournament to compete in the world championships to be held next year in China. Canada Basketball will also be sending a squad to compete in the Francophone Games in Ottawa from July 14-24 and the World University Games are being held in China in September. The teams for these tournaments will be staffed from the coaching pool.

## Saint Mary's to Archive Unique Interviews

After documentary filmmaker John Houston completed his first film, *Songs in Stone* he was concerned that he may have lost valuable footage on the cutting room floor. He decided that archival material could be created while he made films. When he began to work on his latest film *Nuliajuk*, a research component was established that would ultimately be archived at Saint Mary's University.

Saint Mary's was the institution through which The Richard Ivey Foundation funded \$75,000. For a research component of the project. Saint Mary's was designated to provide the required support from anthropologists, namely, Dr. Michelle Daveluy, who became the facilitator between Triad Productions and the University. She has been studying language use and issues in Northern Canada for more than 10 years. "Saint Mary's Dr. Daveluy impressed us," says Houston. "In the end we agreed that Saint Mary's was the best home for the archives."

*Nuliajuk* is the second film of Houston's trilogy focusing on the people and traditions of the North. The film examines Nuliajuk, the goddess of the under waters in traditional Inuit religion. "It is important because it's a story that has changed a lot over the years," says Dr. Daveluy. "It's not clear what the original story was and what the influence of religion was on the adaptation of the story."

Dr. Daveluy says that it is very important to have as much information as possible from the Inuit elders. "Unfortunately, they are passing away so there is an urgency," she says. "Any occasion that we have to actually go and

listen to them and tape them is in itself worth all the efforts."

The process of paralleling the recording of the interviews for the film and research component required two separate crews to visit the communities in Nunavut, over a month last fall. The interviews were conducted by Birgitte Sonne, a Danish ethnologist with the aid of translators.

Saint Mary's will receive a complete set of the 35 interviews with 32 informants, mostly Inuit elders totally 27 hours of super-16mm film, approximately 30 hours of digital videotape and 10 hours of DAT-only recordings. The footage has been formatted and all the interviews have been translated and transcribed in their regions of origin for dialectic accuracy. The supporting text will be in English and Inuktitut with time codes so it can be used with the video footage.

Saint Mary's role will be in the archiving process and ensuring that once the materials are all received by the end of the summer that they are in a format that is usable. Dr. Daveluy says that the archive will be valuable not only for the anthropology department but for the University itself. She hopes that visiting scholars, faculty, Saint Mary's students, and visiting Inuit students will benefit from the archival materials. Future plans include the creation of a parallel archive in Nunavut.

Houston says, "I hope scholars will use the material as a jumping off place for further research, and that in time, an increasing number of those scholars will be Inuit." ♦

## NSERC Awards Almost \$500,000 for Research at Saint Mary's

The Natural Sciences and Engineering Research Council (NSERC) of Canada is awarding almost \$500,000 in new research grants to Saint Mary's faculty and students. This adds to \$350,000 in grants currently being provided by NSERC. Saint Mary's has the second-highest level of research funding in Canada for a university its size.

"I am thrilled to receive support for my research," says Dr. Colleen Barber, a biology professor who has been awarded \$15,000 from NSERC. "My research will examine mating systems in birds through behavioural observations and molecular genetic techniques with particular emphasis on female mate choice," she says. Dr. Zhongmin Dong, Biology, has received \$18,000 from NSERC to study hydrogen oxidizing bacteria in legume soils and plant growth enhancement.

Dr. Cory Pye, a chemistry professor, has been awarded \$20,000 from NSERC. "I will be studying what happens when substances dissolve in water. In particular, I will investigate what happens when electrolytes such as common table salt dissolves and predict how these solutions should interact with infrared and visible light," says Dr. Pye. "Comparison between predictions and experimental results allow then the characterization of the internal structure of these solutions."

His colleagues in Chemistry also received significant support from NSERC. Dr. Marc Lamoureux has been granted \$28,000 to study solid state chemical speciation of environmental samples under controlled and real conditions. Dr. Kathy Singfield will use her \$29,000 grant to research polymer phase behaviour.

Dr. Adam Sarty, an Astronomy and Physics professor, will research the structure

of protons. He has been awarded \$33,640 from NSERC. "At the heart of every piece of matter in the universe, is the atomic nucleus consisting of a collection of protons and neutrons. It is now well-established that the protons and neutrons themselves are comprised of smaller, more fundamental particles called quarks," says Dr. Sarty. "However, there is not yet a complete understanding of how these quarks interact to make up protons and neutrons that contain the proper observed properties. My research attempts to shed light on how quarks interact to make up protons and neutrons by making very precise measurements of the proton structure itself."

Dr. Gary Welch, Astronomy and Physics, will receive \$17,000 to study aging galaxies.

"Galaxies are vast collections of stars and gas; the one we inhabit is called the Milky Way," he says. "I am particularly interested in studying gas content, as this is the fuel for future generations of stars. I am using radio telescopes in Hawaii, Spain and the United States to map the gas in nearby galaxies, most of which is too cool to be visible in ordinary light." Dr. Philip Bennet has received \$13,000 to study chromospheres and winds of red super giants.

Dr. Jaroslav Dostal, Chair of the Geology Department, has been awarded \$28,000. In Mathematics and Computing Science, Dr. Bert Hartnell will receive \$15,000, and Dr. Norma Linney, \$11,000. In Finance and Management Science, Dr. Dawn Jutla will receive \$16,000 and Dr. Shyamala Sivakumar, \$15,000.

Students were granted almost \$200,000 to conduct research at the undergraduate and graduate level. ♦

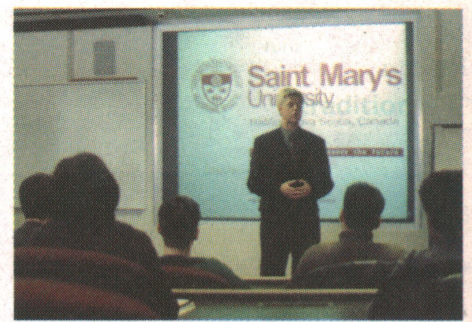
