



# The Role of the Alumni Association in University Government

The Alumni Association has a vital role to play in the government of Saint Mary's University, yet the alumni generally are not fully aware of their powers and responsibilities at this University. The purpose of this article is to briefly review the governmental structure of Saint Mary's and to identify the key role to be played by the alumni. My hope is that this exercise may lead to a greater interest and participation in university affairs by all alumni.

Any discussion of university government must commence with a look at the University's charter. For Saint Mary's, this charter is the Saint Mary's University Act, 1970, an Act of the Legislature of Nova Scotia which defines the membership in the University, its objects and powers and provides for its internal structure. While I have no intention of considering this statute in any detail, there are some parts of it which require careful examination. Clause 4 of the Act defines the membership in the university as consisting of the Board of Governors and the officers of the university and of all those who are entitled to elect members of the board. The Alumni Association is entitled to elect members to the board and therefore the alumni are members of this university. While this fact may not seem too significant, I would suggest to you that it is a matter of crucial importance. There is a lamentable tendency to regard a university as consisting of administrative officers, faculty and students and nothing more. This is a very narrow and confining view of any university and a totally mistaken view of this university, but if the alumni choose to abrogate their rights and responsibilities and fail to maintain a lively interest in university affairs, the words of the Charter will be just that — words lacking in any substance. We must realize that the Alumni have a deep and continuing interest which is different from and complementary to the interests of faculty, administration and students. While the three latter groups have what we may call "vested" interests in the operations of the university, the Alumni can bring to bear on university affairs, an informed yet impartial judgement. We are in a very real sense the guardians of the ideals and integrity of Saint Mary's University and that should never be forgotten. While we may lack the professional competence of those who teach and administer the university, we know very well and hold in high regard the ideals of our alma mater and we should not be reluctant to assert our rights to ensure that those ideals are maintained.

Fortunately the Charter of Saint Mary's recognizes the

importance of the Alumni's role and provides us with practical means to influence university decisions. The Board of Governors of the University is charged by the Act with the government, conduct, management and control of the University and has all powers necessary or convenient to perform those duties and achieve the objects of the university. Obviously therefore the composition of this governing board is of critical importance and it is here that the key role of the Alumni is brought home. The Board of Governors consists of some thirty members and fully one-fifth or six of those members are elected by your association. No other group has more representatives on the board and only one viz the faculty have as many.

The Board of Governors has constituted several committees to deal with special areas of university affairs and again, the presence of the Alumni is strongly felt. The following are the present committees of the Board with a brief description of their functions:

**Executive Committee** — This committee is responsible for the ongoing supervision of university operations. During the interval between full board meetings, this committee has all the powers of the board, although as a practical matter, major policy decisions

would be referred to the Board. There are at the present time two alumni governors on that committee.

**By-Laws** — This committee is charged with the preparation of rules and procedures governing such matters as appointment and promotion of academic and certain administrative staff, tenure, sabbatical leaves etc. There are at the present time two alumni governors on this committee out of a total of five members.

**Finance** — As the name implies this committee constantly monitors the financial operations of the university and is involved in the budget process.

**Property and Development** — This committee is charged with developing an over-all campus plan and will recommend on and supervise any building project e.g. the proposed new library building. Again there are two alumni members on this committee.

**Corporate Planning** — This is a long-range planning committee and will attempt to outline the general directions which the university should take in the future. This committee will of course work very closely with the President of the university.

The foregoing review will I hope make clear the important role which the Alumni play at Saint Mary's. If we are to justify the trust and confidence which is

reposed in us, we must make every effort to keep our association active and to secure the widest participation of our members in the association. One of our chief tasks is to elect six members to the Board and this is a process in which all Alumni should take part. While it falls to the executive of the association to nominate a slate of candidates, they would be more than happy to have your nomination for these important posts. Take the time to consider the matter and give the executive the benefit of your views. Above all, vote on the candidates proposed. There has been a regrettably poor

percentage of association members exercising their votes in recent years and this is hardly acceptable, in view of the influence we have at the university. In addition I would propose a revival of our semi-annual meetings to which the President and perhaps other administrative officers and the Alumni governors would be invited in order to report to the association on university affairs. Hopefully such meetings might generate useful discussion and give the association at large, an opportunity to participate more directly in the university community of Saint Mary's.

## PRESIDENT'S MESSAGE

It is with great pleasure and pride that I assume the duties of the office of President of the Alumni Association. I would like to extend my very sincere thanks to the outgoing President, Mr. Bill Gorman, and his entire Executive.

The new Executive will be meeting shortly and all concerned are looking forward to an interesting and successful year.

Those of you who have read my article in the University publication "The Times" are already aware of my attitudes and aspirations for our Association for the coming year. Many of us on the new Executive feel quite strongly that, with the introduction of a few new events and programs we will be able to contribute, in a meaningful way, to the life of our members and of the University.

One of the new departures that should engender a considerable amount of Alumni interest is the Summer Homecoming which will begin on the 5th of August and run for a full week. That week will culminate with a testimonial dinner to Father Hennessey and Father O'Donnell. That week will only be a success if many of our Alumni from the local area take part and I urge you to do so. Full details of the activities during

that week and registration forms are available at the Alumni Office at the University.

We will again, of course, have our Annual Dinner on December 8 and judging from last year's attendance this year's effort should be the most successful Dinner ever.

The Alumni Association at St. Mary's has, in the past, suffered from a rather discouraging degree of financial support from the members and we hope this year to initiate a raffle-type program to shore up our financial picture and to produce sufficient funds to enable us to make as substantial a contribution as possible to the University.

Your new Executive will investigate fully the possibility of the establishment of the office of Alumni Director at the University on a full time basis and we invite your comments and advice in that regard.

All in all I am personally quite excited about the prospects for the Association for the coming year and I encourage your interest and support for all of our activities and I hope to see many of you at the Summer Homecoming and all of our events through the year.

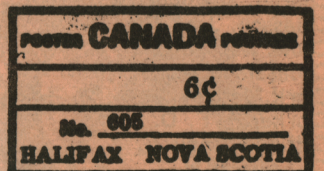

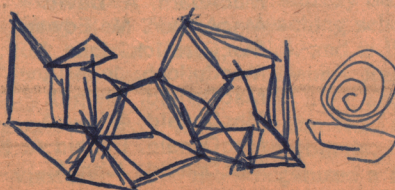
assist you in any way.

# "The Year of the Huskie"

For the past ten years St. Mary's Athletic Director Bob Hayes has been talking about the time when SMU teams competing in the three major varsity sports in the AIAA would some day dominate those fields. That day may have arrived during the 1972-73 athletic year.

It all started with Al Keith guiding the football Huskies to their third straight undefeated season in the Bluenose Conference. Keith and his team fell short of advancing to the National fields when they bowed to the Waterloo-Lutheran Golden Hawks in the Atlantic Bowl.

Then came Bob Boucher and the hockey Huskies, who before the season began stated that his ultimate goal was an undefeated season leading to a National title. That meant winning something like twenty-one games in the AIHL, an assortment of exhibition games, including two against the University of Toronto Varsity Blues and all the playoff games. Boucher ran into little

trouble in the early part of the campaign, in fact his club was averaging ten goals per contest. The Huskies had no trouble winning the AIHL crown, ousting the UPEI Panthers and the University of Moncton Blue Eagles. The Quebec champion Loyola Warriors were next and they went out two straight in the best-of-three CIAU Eastern final. That brought about a fourth straight National showdown between U of T and the Huskies, and once again the Huskies had problems in the first period of the nationally televised contest and that was the difference, the Varsity Blues won the game and the title 3-2. That loss is the most important game of the season was the Huskies first in thirty-two hockey games.

In retelling the athletic success story of SMU for 72-73 the best is yet to come, the first National sports championship in the school's history. It began in the fall of 1972 when coach Brian Heaney began assembling his basketball team. Heaney a young

club quite capable of putting the ball in the hoop but one that needed experience on defence. They got that experience as the season progressed leading to a one game sudden-death showdown in Wolfville against Gib Chapman's Acadia Axemen for the AIBC title and the right to advance to the Nationals in Waterloo.

The Huskies defeated the Axemen and then gained a berth in the National finals by ousting the University of Windsor Lancers in overtime. The nationally televised final pitted SMU against the more experienced Lakehead University. The game started badly for the Huskies and at one point they trailed by nine but in the second half the

discipline and poise that Heaney had worked so hard to perfect came through and St. Mary's had its first National crown. Adding to the sweetness of victory two members of the Huskies team were accorded All-Canadian honors, rookie Lee Thomas and two-time AIBC scoring champion Mickey Fox.

In the space of seven months one of the smallest schools in Canada and certainly one with the smallest athletic budget had reached two National finals. . . one semi-final and won Conference honors in three major varsity sports.

That was the story for 1972-73 what does it look like for 73-74, in one word, "excellent". Boucher loses only two key players all-Canadians Tim Ripley and Chuck

Goddard.

## Dr. J. B. Owen as Dean of Arts

Dr. D. O. Carrigan, President of Saint Mary's University announces the appointment of Dr. J. B. Owen as Dean of Arts, effective July 1, 1973.

Dr. Owen is a native of New Zealand and attended the University of Otago. Following service with the New Zealand Air Force during World War II he returned to university studies, taking degrees in history and mathematics.

In 1950, he entered Balliol College at Oxford University, England, and was awarded the degrees of Master of Arts and Doctor of Philosophy. He was elected a Fellow of the Royal Historical Society and served as Chairman of the Tutorial Committee of Lincoln College. He

Dr. Owen is recognized as an outstanding authority on 18th century British History. He collaborated with the late Sir Lewis Namier in introducing a definitive *History of Parliament*. Several of his books on British history have received international acclaim.
