FAMED SANTAMARIAN DIES

Rev. Ambrosius Czakó, former professor of history of art and Professor Emeritus at Saint Mary's University passed away in Owen Sound September 27 at the age of 87.

Father Czakó was born in Hungary when it was still part of the old Austro-Hungarian empire. He studied at four universities and later taught at the Training College for Secondary Teachers in Budapest.

In 1918, Dr. Czakó worked with the leaders of the October Revolution and helped to establish the short-lived Hungarian Republic. After its collapse, he was persecuted and fled to Vienna where he lived in exile for three years. He came to Canada as a political refugee in 1928 and for a number of years edited a cultural periodical in Hungarian. He also had several books published in Hungarian, German and English.

He was a member of the faculty of Saint Mary's from 1951 to 1967 when he retired and moved to Owen Sound, Ontario.

Funeral service for Father Czakó took place October 1 with burial at Saint Mary's Cemetery, Owen Sound.

ALUMNI DINNER SEASON HIGHLIGHT

The 1974 Alumni Dinner expects to welcome more women than ever this year due to the increasing numbers graduating from Saint Mary's University.

The old time 'stag' affair is a thing of the past. This year, the event will be graced by the presence of Alumni wives and friends as well as women members, and an invitation will be extended to all faculty members, wives and husbands.

Bob Rutolo, Alumni vice-president and chairman of the dinner committee, considers this extension will add color and variety which has been lacking in the traditional event of past years.

The Alumni Dinner goes back more than 22 years, but holding it on December 8th does not. Prior to 1952 the dinner was usually held immediately following spring convocation. According to an unidentified alumnus, this was done to save the extra cost of bringing in a special guest speaker. The guest who delivered the convocation address was simply asked to stay over an extra night to speak to the alumni as well.

In 1952 a group of enthusiastic grads considered it was time to give the annual dinner some special significance and so it was decided that it would in future be held on December 8, the feast day of the University's Patron Saint.

The dinner that year featured the Archbishop of Halifax, Gerald Berry, as guest speaker. A case of the area's finest 'spiritual refreshment' was raffled off to finance the night's activities, movies of the 1952 world series were shown — and a tradition began. Guest speakers since that time have included provincial premiers, prominent statesmen and even an occasional sports celebrity.

Through the years, the annual dinner has been distinguished by its culinary excellence. Those attending in the past are aware that the menu is one in which the chef takes particular pride. This year, to accommodate the greater numbers expected, he has arranged a special buffet.

It will be on the 7th instead of December 8th this year, because of a prior university commitment. Dinner is planned for 7:30 p.m. in the academic complex and will be preceded by a reception starting one hour earlier.

A limited number of tickets are available through the Alumni office on a reserved basis at \$7.50 each or \$15.00 a couple. Anyone planning a private table or interested in hosting a table should contact Krisha Capstick in the Alumni office.

He also was assistant professor of accounting at Northeastern University and was an instructor in accounting at the University of Maryland.

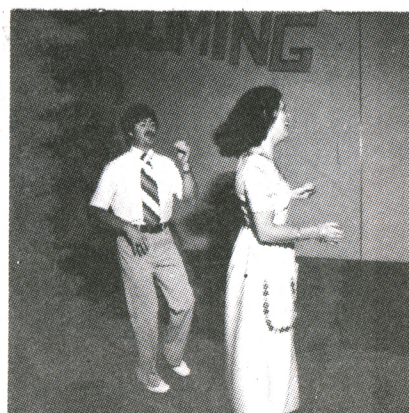

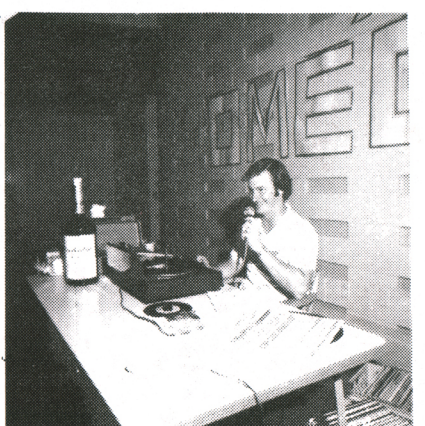

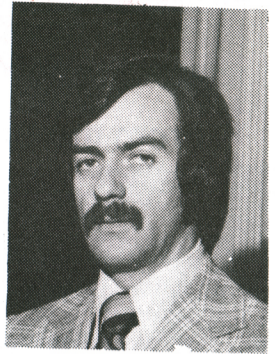
