Alumni Establish Irish Christian Brothers Scholarship



Alumnus Appointed To Diplomatic Post in Bangladesh

"Fr. William Wamboldt, B.A. '66, a priest of the archdiocese of Halifax, left Head of Chezzetcook in March to become attache to the apostolic nunciature, the Vatican's embassy in Dacca, on April 1, 1978."

The post is the first for Father Wamboldt since he was received into the Vatican's diplomatic corps in February, after three-and-a-half years of intensive study in Rome. Father Wamboldt is one of seven candidates to join the corps this year and the second English-speaking Canadian priest to become a career diplomat for the church. The only other Canadian now in the service of the Vatican's secretariat of state is Archbishop William Carew of St. John's, Nfld., who is apostolic delegate to Jerusalem, pro nuncio to Cyprus and apostolic visitor to Greece.

Father Wamboldt was in the archdiocese of Halifax for a two-week holiday after obtaining the requisite doctorate in cannon law for his present diplomatic post. Although Bangladesh is considered the most densely populated country in the world, and also among the poorest, by standards of individual income and economic resources, Father Wamboldt said he felt "a certain sense of excitement about going."

Father Wamboldt said he expects one of the priorities of the delegation is distributing international aid, especially money flowing from papal charities into the country for development projects.

Bangaladesh, viewed in Christian terms is "in its infancy—a germ of the church"—with an approximate Christian population of 0.3 per cent. Eighty per cent are Moslem and about 10 per cent of the people are Hindu.

Because the Christian church is comparatively small, he said it means more work for Nuncio Msgr. Edward Cassidy, an Australian, in his role of apostolic delegate. As apostolic delegate, he is responsible for providing a channel of communication with representatives of the "local church" and the Holy See, and for assisting the church's work and growth. In addition, he must institute the canonical process by recommending candidates to the pope to fill vacancies in the episcopate.

Vatican delegations he said "are not only concerned with Catholics. The Holy See is concerned with any kind of religious or human rights problem."

Unlike conventional diplomatic missions he said the object is not better trade or defense. The diplomatic corps is an instrument of the church that allows it to be heard at the highest eschelons of government in more than 100 countries where diplomatic relations with the Vatican are maintained. He said the presence of the church at the diplomatic level in international affairs provides the church leadership in Rome with

useful information about the church's welfare. In the face of adversity, he said, the information can be used "to marshall the moral and religious force of the Holy See to international issues." Contrary to some opinion, he said, the weight of the church can be significant.

"I don't think people realize the value of diplomacy in general because it is done in secret and things done in secret cause two reactions. One is (persons) impute sinister motives to the activity, or else they think because diplomacy is carried on in secret, you don't do anything." They get this image of people having a good time at cocktail parties . . Diplomacy isn't the most important work of the church but it certainly is important."

Without the liaison provided by the diplomatic corps he said it would be more difficult for the pope to give credible leadership to the world's Roman Catholics.

"In order to speak for the whole church, the pope is aided by knowing what is happening to the church internationally," he said.

In the face of a severe priest shortage in the archdiocese of Halifax he said it is significant the church's leadership is generous enough to recognize the needs of "the universal church," at Page 2

a cost to itself.

"I am in the (diplomatic) service because of the wish of the Archbishop (James M. Hayes) for me to give this witness to the universal church."

It is the same kind of thinking, he said, that has sent needed priests to Peru for the mission there sponsored by the archdiocese. These expressions of international concern show an understanding of the true mission of the church, he said, and they are demonstrative of the belief in the principle, "if you give, you get."

Traditionally, new graduates of the Pontificia Academia Ecclesiastica, the school in Rome for the Vatican's diplomatic candidates, are sent to third world countries. Of the six other priests who entered the diplomatic corps this year, three were posted to Asian countries—India, Korea and Indonesia—one was sent to South America—Brazil—and two went to African countries—Uganda and Ghana.

Besides Father Wamboldt, two other graduates this year had connections with Halifax. Rev. Gino Pezzuto, an Italian, now posted in Ghana, was assistant at St. Mary's Basilica last summer, at the invitation of Archbishop Hayes. Rev. Emil Tscherrig, a Swiss priest who is to take up a position with the nunciature in Uganda, was a former visitor in Halifax as a guest of the Archbishop.

Father Wamboldt, a son of William Henry and Mary (Burke) Wamboldt of Head of Chezzetcook, has been on loan to the secretariat of state in the Vatican for the last four years.

Since his ordination May 30, 1970 in St. Genevieve's Church, East Chezzetcook, he served the archdiocese in the Parishes of St. Patrick's, St. Stephen's and St. Joseph's, Halifax before travelling to Ottawa to continue his studies in canon law at St. Paul's University. While in Ottawa he acted as secretary to the papal pro nuncio before he was requested to continue his studies in Rome. He is a graduate of St. Francis school, and St. Patrick's High School and received his B.A. with a major in Philosophy at Saint Mary's in 1966.
