Annual Meeting 1980

The Annual Meeting of the Alumni Association was held on Wednesday, April 30, 1980 in the Private Dining Room. The President, Pat Curran, B.A.'65, B.Ed.'66, LL.B. (Dal) '69, presided. The attendance, again, was small but slightly larger than that of past years.

After presentation of committee reports, financial statement etc., the meeting heard a report of a committee, headed by Rick Butler which had been established to review the notice of motion tabled at the annual meeting in 1979, which would make full or part-time employees of the university ineligible for appointment to the Board of Governors as alumni representatives. The report, which had executive approval, recommended the developing of guidelines to ensure that alumni representation on the Board came from the widest spectrum of its constituent groups. The report called for the creation of these guidelines within three months and a special meeting or general vote shortly thereafter. The report was not discussed as a request for discussion of the

original motion tabled at last year's meeting was upheld. The original motion was approved by the meeting by a vote of 34 to 16. Kevin Cleary indicated to the chair that in view of the action taken, he felt that it was mandatory that he resign as an alumni representative on the Board and that it was his intention to do so as of July 31, 1980.

A motion presented by Brian O'Byrne and Bob Hayes, which directed the executive to examine the dues structure with a view to increasing the contributions of alumni was approved. The motion directed the executive to prepare a report preparatory to a special meeting to be held before the end of 1980.



A native of Sydney he came to Saint Mary's in 1967 and was a resident student throughout his university years. His don for one year was this years alumni president, Rick Butler.




