The Multi-Purpose Room at Saint Mary's was once again the scene of this year's (1981) Annual Dinner. The affair was real last year's match in attendance, but it was still mode successful. Last year in his post dinner report, the organizing Chairman, Don Keleher, put forward three recommendations: 1. Start organizing early.

2. Hold the dinner in late November. 3. Schedule the dinner for a Friday or Saturday.

Each above was followed by this year's Chairman, Peteralpin. Planning started early and Saturday, November 28, was the date chosen. What then went wrong? Why were there so many disgruntled Alumni by the end of the evening?

To answer these questions we should take a look at the evening as a whole: Beginning at the Reception before the Dinner, held in the Colonnade of the Loyola Building, everyone had a grand time. Old acquaintances were renewed over a few social drinks, long-lost school friends were comparing stories, and an overall atmosphere of enjoyment prevailed.

At the Dinner upstairs in the MPR this same atmosphere kept up. Good food, conversation with old and new friends and a jovial, joking banter was kept up.

Then, as though a shroud had been cast on the assembled, conversation ceased and the speeches began. And went on, and on, and on... The shroud took on the guise of a wet blanket.

At first, the speeches were light and witty, but as the procession went on, they became more and more serious Here's how the program read: The Chairman, Peter Halpin, had a few remarks to make. They were short, funny and to the point.

Peter was followed by the presentation of Associate Memberships of the Alumni to former University President, Dr. Owen Carrigan and to current President, Dr. Ken Ozmon.

That was followed by the Toast to the University, a well-done and light hearted presentation given by R. Gerald Conrad, BA'56. The '56 Class, along with that of 1931, were the Alumni selected to be honoured at this year's dinner.

With the inclusion of a recognition of the Jesuit community at Saint Mary's, the speeches could well have ended there. That, however, was not the case. A lengthy Response to the Toast was given by University President, Dr. Ozmon. A brief "Thank you" would have sufficed.

Still the main address had not even been given. The Honourable Edmund Morris delivered that capping speech to the now restless assembled.

There were still the special prizes to be given and the Thanks and Conclusion to be dealt with.

As you might conclude from my remarks about the Dinner, I was not pleased with the whole affair. The Reception and Dinner, itself, were very enjoyable. Most of what followed could either have been severely shortened or dispensed with all together. It was a valiant attempt at success, but the evening fell short of the mark. I am speaking not only for myself, but for the many to whom I spoke afterwards. The overall complaint was that it was too long and too dull.

In discussing the matter since with Alumni Director, Laurie Smith, he explained that the format of formal speech-making has been a tradition at Dinners. The older graduates, he stated, enjoy that aspect of the evening. Such may be the case, but the time may have come to change the tradition. By comparison, where we were once turning out 20 or 30 graduates per year, now the totals are in the 100's. These multitudes of new graduates are expected to go along with norms set for earlier Alumni with the result that they're being put off. We can not expect them to come to functions like the Dinner to be inundated with speeches.

Let's make future Annual Dinners fun. People come to socialize and enjoy themselves. If we want our Alumni to grow and become a viable part of Saint Mary's, we shouldn't be smothering it with formality.

Committee Holds First Meeting in Quest of an "Official" University Tie

In an effort to come up with a design for a university tie which, if not "official", will be destinctive, a committee of interested alumni been established under the chairmanship of the tant Registrar, M.J. Wilson. Other committee members include Paul Lynch, Robert Hayes and Alumni President, Don Keleher.

The issue of an "official" university tie has been much discussed over the past number of years. Action has replaced discussion thanks to the fairly recent decision of the University bookstore to include a "university" style tie among its inventory. In my opinion the bookstore version represents an admirable attempt to design a university type tie. Unfortunately the color combination suggests a merger between Saint Mary's and Saint Francis Xavier; the tie being basically navy blue with the Saint Mary's University shield in contrasting maroon. It is bad enough that we have blue and white as the predominant color in the Alumni arena; surely we can come up with a more appropriate color for a university tie than blue and maroon.

At any rate the dye is cast (or will be if you will excuse the pun)! The results of the committee's efforts will be seen in due course. At our first meeting which was held on Thursday, 4 February 1982 design ideas and color combinations highlighted the discussions. It was decided to leave the question of fabric selection until design and color scheme are known and both ideas are discussed with a possible manufacturer.

The committee also decided to try to aim for two possible design alternatives; one which could be described as an "athletic" motif, and another as a traditional "Harvard" design. The committee felt that to try to formulate a one and only "official" tie design would be a waste of time and effort. The possibilities would be as endless as the number of people who thought that they had a better design suggestion.

At the moment Paul Lynch is having various design possibilities made up. When these models have been prepared the committee will have its next meeting. Depending upon the results of Paul's labor we will either proceed with discussions with possible suppliers or we will go back to the drawing board.

Rest assured that the Committee in all its deliberations will always bear in mind the motto of Saint Mary's University, "Age Quod Agis".

The decade of the seventies saw the containing a variety of facilities which included a bank, barbershop, beauty salon, swimming pool, cafeteria, and convenience store. This same period also brought the transition of the University from the Roman Catholic Archdiocese of Halifax to an independant Board of Governors! Saint Mary's began a new phase as a public coeducational institution functioning within its tradition of Christian values and maintaining its committment "to foster the intellectual growth of its students." In keeping with this philosophy, today's residences offer a friendly, enjoyable setting with a coordinated program of discipline, recreation, and study.

Our Residences accommodate 1000 single students as well as 105 apartments for married students. The role of student housing within the educational community is one that contributes to the total learning experience of today's student. Students are, therefore, participating members of a community based on a variety of educational, ethnic, cultural, and international backgrounds. As a result, the residence student community is diverse, creating a rich learning experience on campus and consequently having a broad social economic and cultural impact on the University. Diversity creates a wide range of housing needs and therefore requires a variety of options for students. Saint Mary's University offers apartment style living arrangements in its Edmund Rice Residence, as well as the traditional dormitory setting in its Vanier and Ignatius Loyola complexes.

Apart from providing a roof over its students' heads, the Residences offer a complete range of diversified services and activities for its students. The Residences provide an environment to study, develop friendships and the opportunity to become involved in University activities. Each Residence has a staff of senior students called Dons who, under the direction of the Director and Assistant Director of Residences, maintain the quality of student life and act as resource people to their fellow students. Activities range from spontaneous discussions to casual parties, sports, coffee houses, and various cultural events.

The Residence programs that have been developed offer an opportunity for students to grow intellectually, physically, and socially. During this present academic year our Residences have experienced full occupancy which we hope will continue and which we hope is a response to the degree of satisfaction our students have for the programs and services available to them.

Saint Mary's Loses Two of Her Finest

Msgr. Gerald B. Murphy, B.A. '31 and Lt. Gen. Edwin M. Reyno, B.A. '36, two distinguished Alumni of Saint Mary's University, have died recently.

Msgr. Murphy, 72 passed away January 19 in the Halifax Infirmary. In his distinguished life of dedication to the Church, he served in many parishes, became an Armed Forces chaplain from 1940-44, was named Chancellor of the Archdiocese, secretary to Archbishop J.T. McNally and served as a leader in the ecumenical cooperation initiated by Pope John XXIII at the Second Vatican Council. For his ardent concern in these affairs he was named Prelate of Honour to His Holiness.

Msgr. Murphy was recently saluted at the Alumni Annual Dinner at the University as a surviving member of the Class of '31. All who knew him mourn his passing.

Lt. Gen. Reyno, 65 died February 10 in hospital in Dallas, Texas. He had distinguished himself as an expert Airman and was named to the post of Deputy Commander-in-Chief of NORAD. Along the way, Lt. Gen. Reyno held many positions, among them, Base Commander of RCAF Station Greenwood and Senior Personnel Officer of Western Air Command. His connection with Saint Mary's University extended beyond the attainment of his B.A. In 1965 he was awarded an honorary doctorate of Civil Law. Until shortly before his death, his distinguished career led him to Texas where he taught a post-graduate course at the University of Texas in Arlington.
