## The Reverend William A. Stewart, S.J., Medal for Teaching

Saint Mary's University Alumni Association has established an award to recognize faculty members who have made an extraordinary contribution to the education of Saint Mary's students through teaching, in the Saint Mary's tradition of quality undergraduate education. The award is open to faculty members who have completed at least five years of teaching service at the University.

You are invited to nominate a candidate. Each nomination must be supported by the names of at least ten persons from among the alumni, faculty and students. The nomination must be accompanied by a brief statement concerning the faculty members in support of the nomination.

Nominations will be reviewed by a five member selection committee composed of three persons nominated by the Alumni Executive, one member of the faculty nominated by the Saint Mary's faculty union and one member of the student body nominated by the students representative council.

In making its recommendation to the Alumni executive, the selection committee will have regard to the following factors in making its decision, as well as to any other factors considered pertinent:

- Teaching ability and classroom performance.
- Interaction with students.
- Extra-curricular contributions to the life of the university community.

Nomination forms are available from the Alumni Office, third floor, O'Donnell-Hennessey Student Centre. Nominations must be received by APRIL 15, 1984.

The award will be presented at Spring Convocation.

# President's Annual Report 1983-84

It is hard to believe another year has gone by so quickly but despite the brevity of the year, your association was very active and continued to make its presence felt on and off campus.

The first business of the year was the presentation of plaques to all graduating athletes, and awards to the outstanding academic male and female resident students.

During Convocation exercises in May '83, I had the honor of making two presentations. The medal for highest standing in Science went to Mr. Wayne Cox who, I am happy to say, combined varsity hockey with his academic achievements. The Father W.A. Stewart medal for teaching, initiated by the association in cooperation with the faculty union to promote recognition of superior teaching in the Saint Mary's tradition of quality undergraduate education, was awarded to Mr. David Hope of the Department of Commerce. This being the initial award, the presentation could not have occurred on a more appropriate day as Father Stewart also received an honorary degree and presented the Convocation address.

An alumni sponsored reception was held at the Nova Scotian Hotel prior to the graduation ball and was thoroughly enjoyed by alumni and graduates. Too bad some of the older couples were unable to stand the pace on the dance floor.

On June 8th, an alumni reception was held in Ottawa, hosted by Honorable Gerald A. Regan and Mrs. Regan. Approximately 65 alumni representing classes from '28 to '82 attended. Thanks to Darrell Maxwell and Patricia Smith for their assistance in organizing this event which was thoroughly enjoyed by all.

The 4th annual Tennis Tournament was held on Saturday, June 25th at the Burnside Tennis Club. Kent Ritchie and Paula Glencross were the organizers for this day of fun.

The annual barbecue for executive families and special guests was held in early July on the lawn of the Stanfield property. Once again we were blessed with great weather and a good time was had by all. Our chefs, Don Keleher and Brian Smith, did a magnificent job.

The 7th annual Golf Tournament was held August 29th at Oakfield Golf and Country Club. Granville and

Carl Kelly have made this event so successful, we regret now having to put association members on a waiting list. The popularity of this event is such that we have an application from California for '84.

After many hours of planning, the weekend of October 7th-9th was one of the most exciting events ever held by the association. Classes of 20's, 30's and 40's gathered for a weekend of reminiscing, campus tours, a football game, a dinner and dance and a Mass followed by a brunch hosted by Dr. Ozmon. Very special thanks to Larry Murphy and his committee of Ed Boyd, Hugh MacDonald, Bernie Kline and Laurie Smith. Those assisting in the preparations were Bill Barton, Paul Lynch and yours truly from your executive, as well as David Hendsbee, President of Student's Representative Council and Dave Zareski.

On November 19th the Southwestern Ontario Branch held its annual dinner at the Trillium, Ontario Place, Toronto. The enthusiasm of the approximately 150 in attendance augurs well for the future. Credit for the event and continuing growth of the branch is due in no small measure to David Gray ('75), Dan McCarthy ('76), Brian Cooper ('77) and Mike Baker ('74).

On November 26, 1983 we had the most successful dinner ever, both in terms of numbers and financially. Paul Lynch and his committee are to be congratulated for such a tremendous job.

This year the format was changed somewhat in that we did not have a guest speaker. Instead the association made presentations to various departments and activities throughout the university from the unassigned portions of your contributions to the annual fund. A highlight of the presentations was one received by the association in the amount of \$4,000. from the Residence Society designated for the Father Hennessey fund. With this contribution we have now reached the amount of \$28,201. for the fund to set up the Father J.J. Hennessey Scholarship Trust. From the favourable response to these presentations we are very hopeful a larger number of members will show their support by way of contributions.

On February 1, 1984 a wine and cheese reception sponsored by President Ozmon was held to honor scholarship recipients and pay tribute to the donors. Laurie and I, on behalf of the alumni, along with the other donors, presented certificates to the scholarship winners.

The Education Committee, chaired by Fred Crooks undertook a major task in preparing an alumni submission to the Royal Commission on Post Secondary Education. We are very appreciative of the contribution made by Father Stewart in our submission. The verbal presentation was made by Fred to the Commission on February 17, 1984.

The Athletic Committee, with David White as Chairman, was instrumental in setting up Leadership awards to commence in the fall of '84. These awards will be to assist athletes having successfully completed at least one full year of studies as well as meeting academic conditions in the year of the award.

Other events carried out during the year may not have had the overwhelming crowds as those previously referred to, nonetheless, they were very worthwhile and hopefully will grow in the future. Such events were: football brunch, family skating and receptions at varsity games.

Another very encouraging note worthy of mention, when we talk about alumni support of our university, is the statistics indicating approximately one thousand of current students are alumni related.

The spirit shown by so many and the number of events taking place in a short time as evidence by the turnouts at Ottawa, Toronto, "Old boys reunion", annual dinner, golf, etc. makes our association perhaps the most active alumni group in the country. The Growth and participation in the past ten years has to be very gratifying to our director, Laurie Smith, who can relate to a struggling period when we had to beg twenty people to take part in the first golf tournament. Thank you Laurie for making our association the envy of so many. Special thanks also to Paula Glencross, who not only manages to keep the office organized but spends so many extra hours at meetings and assisting in coordinating most events, and to Pamela Turnbull for her support in the office.

Finally I would like to thank the executive and President Ozmon for the tremendous cooperation and support throughout the year, without which such an exciting year would not have been possible. To those members, including our representatives on the Board of Governors, whose term of office expires this year, I sincerely wish you will continue to give the association your very valued support in the future.
