## Laurie Smith: A Remarkable Man

Past and present members of the Saint Mary's University community were deeply saddened by the death of Laurie Smith on August 15th. Laurie died at his home of a heart attack. He was 64.

Laurie left behind a legacy of hard work and impressive accomplishments. He graduated from Saint Mary's College in 1943, and went on to complete his B.Ed. at Dalhousie and his Masters of Science in Educational Psychology and Guidance at Fordham. He was editor of the Saint Mary's Journal in his senior year.

Laurie taught, and was Vice-Principal and hockey coach at Saint Pat's High School for many years. His teams won 15 consecutive High School hockey titles during that time.

Following his years at Saint Pat's, Laurie was Chairman of the Halifax School Board and Director of Guidance for Halifax City schools from 1963 to 1966. Laurie joined the Administration at Saint Mary's in 1966.

The school system's loss was the University's gain. Laurie went on to assume the posts of Director of Administration and Scholarships, Dean of Students, and Director of Student Affairs. He became Vice-President, Administration, in 1968, and in 1979 took over the office of Director of Alumni. It was in that

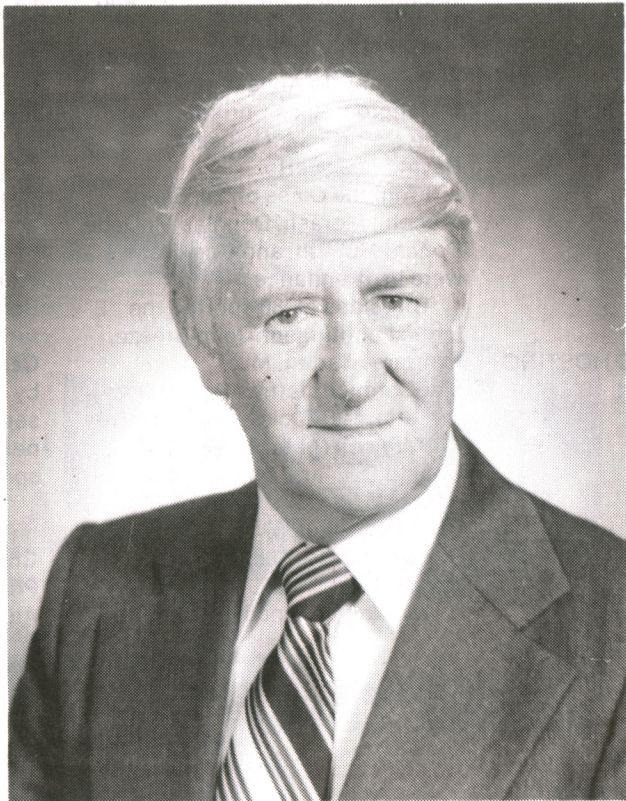
capacity that many of us came to know him best. At the time of his death, Laurie was Special Assistant to the President, a position he had been appointed to during the past year.

Laurie is survived by his wife, Kay, and six children: David and Brian are currently attending Saint Mary's, while two daughters, Patricia and Cathy, and two other sons, Larry and Stephen, graduated previously from the University.

As President Ken Ozmon said of Laurie, "Many people lost a good friend; he was considered a father figure for many, myself included!" Those who were fortunate enough to know him well will not soon forget his kindness and humanity, his smile, and his willingness to lend a helping hand. The alumni will miss Laurie more than words can say.

Addenda: The Alumni Association is planning to establish a memorial scholarship in Laurie's name. Details should be finalized within the next couple of months.

## Laurie Smith: The True and Finished Man of Character

Everyone in our Saint Mary's Community who knew Laurie Smith was touched by him in a very special way. Each of us has very personal remembrances of him... from presidents who were in need of his wise counsel to the member of our support staff who was in need only of a cheery "Good morning"... from the Professor on sabbatical who ran into a peculiar problem in a foreign country to the blind first-year student taking his or her first steps into university life. All of these memories are of a wise, honest, friendly, and, most of all, quietly helpful person.

However, Laurie Smith was much more than the sum total of our individual experiences of him. He was a true Santamarian who was a splendid example of the efforts of the Saint Mary's of 1943 to graduate the classical "Supernatural Man" — namely, one who thinks, judges, and acts consistently and constantly in accordance with right reason illuminated by the supernatural light of the example and teaching of Christ. In other words, Laurie Smith was a true and finished man of character.

In 1966, Saint Mary's was in need of additional human resources to help cope with the stresses and strains of moving from a small, Jesuit-administered university to the public institution we know today. The President, through Dr. William Dalton, prevailed upon Laurie to accept an appointment to the university staff. It was a measure of Laurie's total commitment to the ideals of Saint Mary's that he agreed to join us.

The transition was carried out with a great deal of difficulty, and its success was due in no small part to the efforts of Laurie. Through student sit-ins, food demonstrations, bomb threats, debates on open residences, downtown marches, and what-have-you, Laurie's wise counsel served the university admirably. On one particular occasion, his excellent rapport with our football team served as a more than adequate foil to chairman Mao's little red book when local Maoists attempted an incursion onto the campus.

Laurie's next task at Saint Mary's provided him with what I suspect were personally his most rewarding years at the university: namely, the establishment of a counselling service to fit the needs of our expanded student body. His efforts were again highly successful.

In addition, he was able to set in place special services for the physically disabled. The success he achieved made Saint Mary's a household name in regards to its

concern for the special needs of these students. He was also one of the prime movers in the establishment of the Community Resources Tape Library for Blind Students. Our present-day expanded services for disabled students have been built on the foundation which was well and truly laid by Laurie.

With the Counselling Programme underway and a philosophy of assistance to disabled students well founded, Laurie was ready for another challenge. It was to come in the guise of work with alumni.

In 1979, Laurie accepted the post of Director of Alumni Affairs. This area of the university had long been in need of attention, and Laurie was just the man for the job. His ability to work with people, especially young professionals, enabled him to channel the youthful enthusiasm of more recent alumni into solid programmes which benefited both them and the university. At the same time, he was able to maintain a harmonious balance between alumni and alumnae of all decades within the association.

With the putting into place of the mechanism to enable the alumni to participate in our National Capital Campaign, Laurie completed the work he had been asked to perform in that field and moved to the position of Assistant to the President.

This new task, which he took up early this summer, gave promise of a less hectic pace for Laurie, but was certainly a job of great value to the university in developing our relations with the wider local community. However, it was not to be. Laurie was once again called, this time away from Saint Mary's. The reason we know not, for in the words of Holy Scripture, "My thoughts are not your thoughts and my ways are not your ways, so sayeth the Lord God."

In speaking of Laurie Smith this evening, I have tried to portray him in light of what he meant to our Saint Mary's family. We must not forget that he had another very personal family that was most precious to him.

Laurie was an exemplary husband to his loving wife, Kay, and a wise and judicious father to their six children. His work at Saint Mary's was overshadowed only by his success as husband and father. His family was a constant source of pride, pleasure, and solace to him, as he was an inspiration to them. Indeed, their family life was an inspiration to all who knew them.

Laurie Smith has left Saint Mary's for the last time, but the (continued on page 2)

work he completed and the successes he achieved will remain for the good of future Santamarians.

It is significant to note that Laurie's last hours at the university the day before he died were spent in counselling an alumnus whose child was experiencing some academic difficulties. Had Laurie been able to choose his last task at the university, it would be the same: "Helping someone else was typical of him."

In the words of the Psalmist:  
Mercy and truth have met each other  
Justice and peace have  
kissed . . .  
Justice shall walk before him  
and shall set his steps in  
the way.

So walked Laurie Smith.

## Report from the University President

Dear Alumni of Saint Mary's University:

I am pleased to provide the latest update on the results of our Financial Campaign. As you will note, there is much to be positive about, especially as we launched the campaign only in March, 1984.

The fact that we have reached the 60% mark, of course, does not mean that we are resting on our laurels. Our very capable staff and many volunteers continue to assist me in contacting prospective donors. The fact that we generally have received a very positive response gives us courage to continue our efforts.

Some areas, as you will note, have done better than expected. Who would have thought, for example, that in a time of restraint we would have more than exceeded the goal we set for donations from the Federal and Provincial Governments?

Other sectors which have given us special satisfaction have been the Board of Governors' response and the response of our staff members.

While the alumni campaign has been slow in developing, the first-rate team of volunteers led by Jim Crane will, we are confident, take off in the fall. They are gearing up for a big push at that time.

We have reached close to the halfway mark with the foundations and with the national corporations. The fact that some potentially large donors have not been canvassed leads us to the conclusion that we will do quite well once we have had the opportunity to present our case to them.

In all, we have done well in our first year and a half. We are certainly satisfied with our progress to date, although we hope to be considerably further advanced this time next year.

In October, we will be breaking ground for the new Fitness and Recreation facility — something that Saint Mary's has desperately needed for the past fifteen years. This very tangible result of our canvassing will, I am sure, spur us on to even greater efforts.

Many thanks to all those who have assisted with the campaign in the past. You may be certain that the campaign committee and all our dedicated volunteers will continue to concentrate their efforts on reaching our \$13 million Capital Campaign objective. We will succeed!

## New Appointment for Bob Hayes

Dr. Kenneth Ozmon, President of Saint Mary's, announced July 3rd the appointment of Robert Hayes as Executive Assistant to the President, effective September 1st.

Bob, who served as Athletic Director for 27 years, will be involved in planning and development. His new duties will involve all aspects of fund-raising and developing stronger relationships with members of the business community and government.

Dr. Ozmon indicated that maintaining and strengthening community support has become an increasingly important function of university administration. He said, "No member of our administration is better acquainted with a wide cross-section of the community; I'm delighted that Bob has agreed to work with me in these important areas."

Bob Hayes began his employment at Saint Mary's in 1958 as Athletic Director, Hockey Coach, and Football Coach, after an illustrious playing career with the Shearwater Flyers. He can boast no fewer than 30 Atlantic intercollegiate championships in men's football, hockey, golf, and basketball, plus women's basketball and field hockey. Equally impressive are four Canadian intercollegiate titles in football and men's basketball.

The successful Camp of Champions program, which has

grown to include hockey, football, basketball, soccer, and power skating, was also developed by Bob. Over 12,000 youngsters have participated during its 22-year existence.

Bob was also instrumental in the acquisition of the artificial track and field in Huskies Stadium, the Alumni Arena, and the successful bid to host the first Canada Summer Games in 1969. He has played an integral role in the proposed Fitness and Recreation Centre, slated for construction in October.

Bob was inducted into the Nova Scotia Sports Hall of Fame as an athlete in 1980. At the 1981 Grey Cup Dinner, he received a Canadian Amateur Football Association/Canadian Football League Builders Award in honour of his outstanding services to football in Canada.

Bob Hayes brings to his new position impeccable credentials and accomplishments, as well as valuable experience that will be utilized by Dr. Ozmon. Above all, Bob has a special way with people; his first consideration is Saint Mary's, not himself.

## Tom McDonell Named Alumni Director

Tom McDonell has been officially appointed the new Director of Alumni, effective September 23rd.

Tom, a native of Ottawa, graduated from Fisher Park High School. He came to Saint Mary's in 1977, graduated with a B.A. in Geography in 1980, and went on to acquire his M.B.A. in 1982.

Tom should be no stranger to sports fans. He was a centre for the Varsity Hockey team from 1977-82, during which time he garnered his share of scholarships and awards. Tom was Rookie of the Year in 1977-78, Saint Mary's Athlete of the Year in 1979-80, and MVP of the Hockey team in 1980-81.

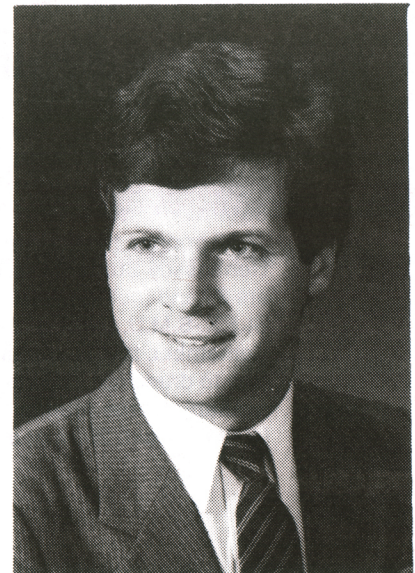
Tom also made the Dean's List his rookie year, won an Achievement Scholarship in 1978-79, and was a recipient of the Godfrey Award for combined Academic and Athletic Achievement in 1981-82.

Since 1982, Tom has worked for Computerland in Halifax; he has been Manager the past two years. Tom and his wife Joan are the parents of a two-year-old daughter, a future alumna of the Class of 2005.

Tom has been involved in the ongoing Capital Campaign, and has participated actively in past alumni

events. He is looking forward to meeting fellow alumni in his third-floor office in the Student Union Building. Tom is setting as one of his major priorities the strengthening of Alumni chapters across Canada and the New England States.

The Alumni Association will certainly continue to function smoothly under the capable direction of Tom McDonell.



## Fitness and Recreation Centre Ready to Roll

The sod will be turned in October, 1985, for the new \$6 million Fitness and Recreation Centre on the Saint Mary's campus. The expected opening of the Centre is the spring of 1987.

This exciting complex will house all recreation functions under one roof in a structure located along Tower Road, to the east of Huskies' Stadium. The Centre will be open to students, faculty, and staff, as well as to members of the general public with individual memberships. The design emphasizes the accessibility and availability of all facilities to the physically disabled and other community groups with special needs.

The Centre's architects are C.E. Davison and Co. Ltd. of Halifax. Mr. Dave Rickard is acting as chief design consultant.

Upon completion, the Centre will provide an urgently needed facility on the Saint Mary's campus. Included in its design are a large gymnasium with retractable seating, which will allow for several cross courts, an indoor track, a multi-purpose fitness room, a physiotherapy/training area, an equipment distribution centre, central locker rooms, sauna and whirlpool, storage areas, administrative and athletic offices,

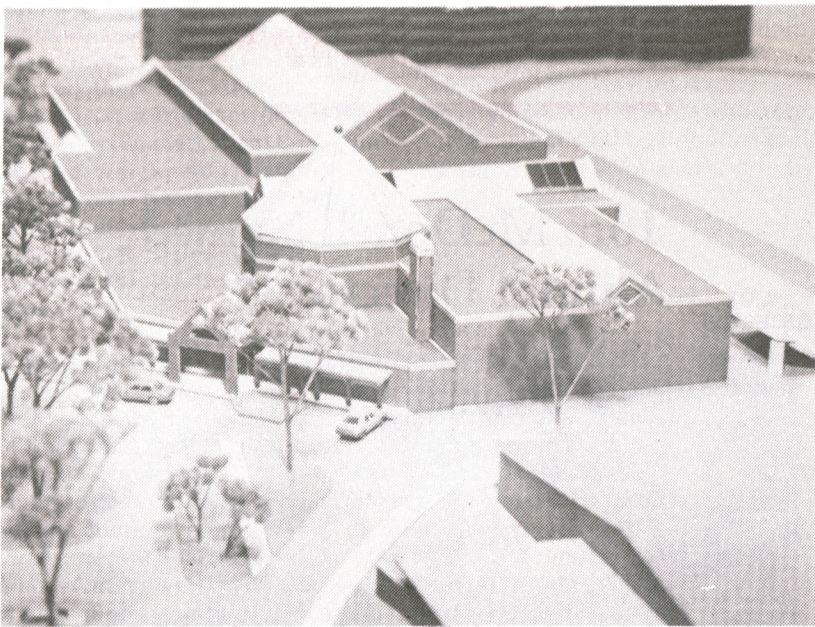
a pro shop, a licensed lounge and dining area, and building services.

An ambitious \$13 million Capital Campaign was launched at the University in March of 1984, with funding for the Fitness and Recreation Centre a major focal point. Generous commitments have been pledged by the Province of Nova Scotia, the Windsor Foundation, and many national and international corporations, as well as Saint Mary's alumni, faculty, staff, and the Board of Governors.

Mr. Robert Hayes, Executive Assistant to the President and former Director of Athletics and Recreation, has accepted as a first duty in his new position the supervision of the final stages of the Centre.

All Santamarians and friends can share in the enthusiasm that has been generated for this new facility, and look forward to the Centre's opening in 1987.

## McGregor New Athletic Director

Dr. Ken Ozmon, President of Saint Mary's, is pleased to announce the appointment of Dr. Ian McGregor as Director of Athletics and Recreation, effective November 1st.

Dr. McGregor, 39, was born in Scotland, and moved to British Columbia in 1968 after completing his undergraduate degree at Aberdeen University. He studied at Simon Fraser, finishing his Ph.D. in Chemistry in 1973.

Dr. McGregor has been extensively involved with campus recreation and intramurals, acting as Recreation Director at Simon Fraser from 1977 to 1983, and serving for several terms as President of the Canadian Intramural and Recreation Association. His publications include two books and numerous papers on intramurals, fitness, and recreation. He is currently Assistant to the Vice-President, Administration, at Simon Fraser.

Dr. McGregor has also enjoyed a lengthy association as a volunteer fundraiser with such organizations as the United Way and Salvation Army. He runs, and plays soccer and squash.

Dr. McGregor remarks, "I'm looking forward to providing opportunities for the total university community to participate in a variety of activities, both competitive and non-competitive, and I am particularly excited about the role of the new Fitness and Recreation Centre as a focal point for campus life."

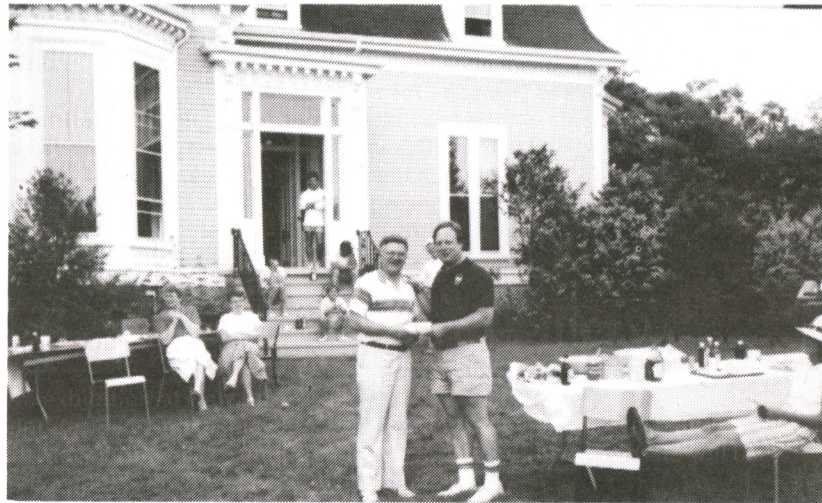
