
Welcome, new alumni!

The Saint Mary's Alumni Association welcomes its new members, the Class of '86, and congratulates them on making history not only for the University, but for the Association as well.

The Saint Mary's Alumni Association experienced the greatest growth spurt in its history this May when over 650 students graduated at Convocation. The Class of '86 not only made history by being the largest the University has seen since starting to award degrees in 1841, but also because it was the first to attend Convocation ceremonies in the Metro Centre, the downtown-Halifax sports and convention facility.

This year's Convocation featured several highlights besides its sheer size and new location, however. The newest class of alumni included three distinguished honorary degree recipients, 11 medal winners, three physically handicapped students, and the first students to receive Master of Arts degrees in Atlantic Canada Studies. The Reverend William A. Stewart, S. J., Medal for Teaching was also awarded, and Professor Allan Sabean, who retired last year after 53 years of association with Saint Mary's, was awarded the rank of professor emeritus for his distinguished service to the University.

Saint Mary's recognized three valued friends of the University with honorary degrees. An honorary Doctor of Civil Law was conferred upon Edmund Morris, member of the the Nova Scotia legislature. Stephanie A. Cleary of the Class of '86 read the citation, and Dr. Morris addressed convocation. The late Lawrence (Laurie) Smith, who was formerly Director of Alumni Affairs, received an honorary Doctor of Letters, posthumously. Mrs. Kay Smith, Laurie's wife, accepted the degree. An honorary Doctor of Letters was also conferred upon Professor Sun Weiyan, president of the University of International Business and Economics, (UIBE), in Beijing China. Mr. Chen Quan Yuan, Vice-President and Senior Administrator at UIBC, accepted the degree for Dr. Sun, who was unable to attend due to illness.



Martin Gill, a Saint Mary's student who was left a quadriplegic after a swimming accident in 1983, returned to the University to accept his Bachelor of Commerce degree, which he had recently completed. Two visually handicapped students also received their degrees on May 12. Victor Fraser and Bradley Power both credited the facilities of the Ferguson Tape Library for Print Handicapped Students with helping them successfully complete their studies.

Degrees in Arts, Science, Education and Commerce, diplomas in Engineering, and Master's degrees in Arts, Science, Education and Business Administration were awarded during the Convocation ceremonies. Among the Master of Arts degrees were the first to be awarded in Atlantic Canada Studies. Ms. Michael Smith and Mr. Terrence White were both on hand to receive their degrees.

Eleven of the University's outstanding scholars were honoured with medals and awards, as





Nesbitt named new hockey coach

Randy Nesbitt is the new head coach of the Saint Mary's hockey team, Dr. Ian McGregor, Director of Athletics and Recreation, announced recently.

"Mr. Nesbitt has a proven playing and coaching background in college hockey, as well as extensive qualifications in the field of sport camp administration, strength training and elite player development," says Dr. McGregor.

A native of Burlington, Ontario, Nesbitt, 31, spent the 1985-86 season as assistant coach at the University of Waterloo. His team qualified for the Ontario University Athletic Association playoffs for the first time in eight seasons.

Prior to the Waterloo coaching assignment, Nesbitt was head coach of the Centennial College hockey team, which went from a 1-22-1 record in 1983-84 to a 10-12-2 record in 1984-85 under his tutelage.

His other coaching assignments have included the Ontario Hockey Association Thornhill Thunderbirds, Brantford Alexanders and Guelph Platters, Sheridan College and Val Pellice in Italy, Division I.

Randy Nesbitt played for McMaster University when he was a student. He has a BA in Sociology and Physical Education from York University.

"I am committed to building a strong competitive team for Saint Mary's University," says Nesbitt.

"My plan calls for work to begin in three areas: first, recruitment of student athletes throughout the Maritimes, Ontario and Quebec; second, to organize and administer all areas of the hockey program here at the University to ensure that our student players receive personal assistance with respect to both their academic and their athletic pursuits; and third, to create an exciting summer hockey program as part of the camp of champions which encourages and ensures both fun and improvement for the minor hockey participant."

"Nesbitt has directed and worked at hockey schools since 1978," says Dr. Ian McGregor. "His camp credits are impressive, particularly

Alumni plaques were presented to the University's newest alumni who were also active in varsity sports, including: Darrell Cormier, Men's Soccer; Lisa MacKenzie, Kelli Richardson, and Alice Verran, Field Hockey; Damian Byrne, Peter Curwin, Tom Daley, Shane Doyle, Darrell Gaudet, Danny Lawson, John Lukan, Dale McClare, Alex Russell, and Jeff Watson, Football; Mike Magee, Hockey; and Michele Gaunce and Tracy Vanier, Women's Basketball.

Senior athletes Michele Gaunce (basketball), from Perth-Andover, New Brunswick, and Jeff Watson (football and track and field), from Lower Sackville, Nova Scotia, were also named Athletes of the Year. Both students graduated from Saint Mary's this year, Gaunce with a Bachelor of Commerce degree and Watson with a BA in Sociology. Watson was one of only 14 college players invited to the CFL draft this year. He was selected in the First Round by the Hamilton Tiger-Cats.

Special recognition was given to Mr. Frank Baldwin and Mr. Tom Sweet, both retiring this year from their respective positions of Development Coordinator/Provincial Coach for Basketball Nova Scotia and Resource Officer for the Nova Scotia Sport Heritage Centre. Baldwin is a former head coach of the Basketball Huskies, and Sweet is the Founder of the Basketball Huskies Booster Club.

The announcement of a new annual award was also made at the dinner. The Robert Gerald Hayes Award will be presented for the first time in 1986-87, and will each year go to the individual from the community who has made the most outstanding contribution to the varsity athletic program at Saint Mary's. Greg Ferguson (B.Comm., '74), Director of Admissions, travels to high schools throughout the Atlantic Provinces, Quebec, Ontario and New England, promoting the many benefits of an education at Saint Mary's.

Once a student decides to attend Saint Mary's and is admitted, his or her contact with the University's alumni continues at registration. Murray Wilson (BA, '65, B.Ed., '70), Assistant Registrar, Theresa Brennan (née Beaton, BA, '75), Assistant to the Registrar, and staff member Chris MacDonald (BA, '83) are always on hand to help with the confusing little details of getting enrolled.

One important step in the enrolment process is paying tuition. Students making a visit to the Business Office for that purpose are likely to see Ron Cochrane (B.Comm., '70), the University's Comptroller, and Janice Burke (B.Comm., 84), the accountant, working diligently in the background, keeping the financial side of the University's administration in order. Another place where students will have to spend a little of their cash is at the Bookstore. Don Harper (B.Sc., '72), the manager, and his assistant Judy Corkum (BA, '80), always keep the shelves well stocked with the texts required for a successful year of study.

When they finally make it to class, many of Saint Mary's students will see alumni of the University at the front of their classrooms.

Since every Saint Mary's student has to take at least one English course, it's quite likely that many of them will meet a teaching alumnus during the first week of classes. Michael Larsen, (BA, '66), Terry Whalen (BA, '65) and Alumni Association Associate Member Roger MacDonald are three profs likely to be giving an introductory English course to first year students.

Whether a student is in Arts, Science, Commerce or Education, there's a good chance that at least one of her or his professors will know what it's like to be a Saint Mary's student from first-hand experience. Students taking Arts courses will find former classmates Dr. Patricia Connelly and Dr. David Perrier (both BA, '68) in the Sociology department. Alumni Dr. Fred Crooks (BA, '75) and John Feehan (BA, '77) teach in the Political Science department, while students interested in Philosophy may take courses from Dr. Shelagh Crooks (Fred's wife, BA, '76). Father Lawrence Murphy, S.J., who graduated from Saint Mary's with an MA, teaches in the Religious Studies department.

Numerous other alumni teach in the Faculty of Commerce. In the Marketing department are June MacDonald (BA, 81, MBA, 85) and Karen Blotnicky (BA, 80, MBA, 85). In Accounting, Barry Gorman (B.Comm., 67), David Hope (B.Comm., 61, also Saint Mary's High School, 58), Greg Walsh (B.Comm., 69, B.Ed., 74, MBA, 82), and Elaine Morash (BA, 76, MBA, 78) can be found in front of a classroom, while in Finance, Karen Henderson (B.Comm., 75, MBA, 77) takes time from her full-time work at Maritime Life Assurance Company to teach a course on campus. Students taking Management courses are likely to meet alumni Ned Kelleher (Saint Mary's High School, 58, B.Comm., 62), Lissa McRae (MBA, 79), and Jeff Young (MBA, 83) in a classroom in the Loyola building. Economics professors Dr. Ervin Doak (B.Comm., 62) is also an alumni, and in the Faculty's administrative staff, Lois Wasteneys (B.Comm., 82,) is Projects Coordinator.

Three professors in the Education department are also alumni of Saint Mary's. Fred Dockrill (BA, '57, B.Ed., '61 and MA, '64), Bette Hanrahan (BA, '59, B.Ed., '60 and MA, '66) and Dr. Michael MacMillan (MA, '64) are all fulltime professors teaching prospective teachers how to teach.

In the Science Faculty, Laurie Reed (née Burgoyne, B.Sc., '83, M.Sc., '86) is the technician in the Astronomy department whom many students meet during their tour of the University's observatory. Dr. Paul Muir (B.Sc., '79), assistant professor in Computing Science, helps students keep abreast of the latest in "computerese." Prospective students visiting the campus this summer can meet several new Science alumni, as well, including Stephanie Cleary, Dave Lycon, Michael Trus, Hartford Manning and Robert Singer (all B.Sc., '86), all of whom have summer assistantships this year.

Since student life involves more than just attending classes, it's also likely that Saint Mary's students will meet alumni in other areas of the campus as well. Students living in residence, for example, can't help but meet Clay Fowler (BA, '76), the Director of Residences, or Sam Scribner (B.Comm., '81), Assistant Director of Residences for Residence Service, the man who collects the damage deposits and makes arrangements for all repairs and maintenance of the rooms.

Another area where most students end up at least once during their time at Saint Mary's is in

Lynn Andrews, another alumna (BA, '77), is on hand as a counsellor in Student Services and Barry Abbott (BA, '78) is Public Relations Officer for the Atlantic Centre of Support for Disabled Students.

Students who get involved in the sports programs at Saint Mary's will also meet some of the alumni on staff. Bruce Hopkins (B.Ed., '76) is Coordinator of Inter-Varsity Athletics; Jeff Hayes (B.Comm., '77) is Facilities Coordinator; and Kathy Mullane coordinates intramural and recreation activities. Kathy is a part-time student at Saint Mary's and is also an Associate Member of the Alumni Association.

Other alumni of the University can be found working behind the scenes. Although they do not have frequent contact with the students, the following people — Kevin Cleary (BA, '57, B.Ed., '58, MA, '61), Secretary of Senate; Bob Hayes (BA, '73), Executive Assistant to the President for the Capital Campaign; Mike Tingley (Dip.Eng., '59), Director of Computer Services; Lou Dursi (Dip.Eng., '69), Director of Physical Plant; George Somers (Dip.Eng., '42), Security Officer; Kevin Webb (B.Comm., '76), Budget Control Officer; and Heather Davis (BA, '74), Secretary to the Academic Vice-President —play an integral and important part in the day-to-day running of the University.

Two of the Association's newest members, Shirley Buckler and George Bragg, also worked on their degrees "behind the scenes." Shirley (BA, '86) is the Coordinator of the Word Processing Centre and George (also BA, '76) is the University's Postmaster.

When graduation from Saint Mary's is imminent, a student once again has contact with an alumna when he or she registers at the Canada Employment Centre on Campus. Bruna Caracristi (BA, '75, B.Ed., '76) will be on hand to help in filling out the proper forms.

Students graduating from Saint Mary's not only join the growing Santamarian family, but also have an opportunity to meet two other alumni, Don Keleher (Dip.Eng., '69, B.Sc., '70), Development Officer in charge of the University's Capital Campaign, and Tom McDonell (BA, '80, MBA, '85), Director of the Alumni Association, at the gala Alumni Reception held before the Graduation Ball. *GW*

Mr. and Mrs. Ferguson have made generous contributions to the Library. Their most recent gift provided for the acquisition of a Kurzweil Reading Machine which converts printed text electronically into spoken words, "reading" for those who, because of physical handicap, are unable to read for themselves.

Saint Mary's graduated two visually impaired students, Victor Fraser of St. John's and Bradley Power of New Waterford, who both made extensive use of the Library, at Convocation in May.

Goal set at \$50,000 for Laurie Smith Scholarship

It has taken only two months for the Laurie W. Smith Scholarship to grow from the University's lead gift of \$5,000 to over \$23,000, according to Don Keleher, Director of Development. The committee began its fundraising efforts with a mailing to alumni and friends of Laurie Smith in April.

The scholarship committee, a group of volunteers made up of alumni, clergy, community leaders and former teaching colleagues of Mr. Smith, has set a goal of \$50,000 for the fund.

"Of the thousands who knew Laurie Smith, many will have a unique memory of him — in the classroom, behind the bench, as a colleague in education at Saint Pat's and Saint Mary's, through the Alumni Office, the School Board and a host of other community activities," says Charles McGuire (BA, '59), chairman of the committee.

"The Laurie W. Smith Scholarship will honour Laurie in a most appropriate way by supporting young students, those in whom he always had a special interest.

"The scholarship fund provides an opportunity for all of us who benefited from Laurie's counsel, friendship and dedicated service to Saint Mary's to support an enduring and practical memorial to him."

Once set up, the Laurie Smith Scholarship will be awarded annually from the trust fund established by the University's Alumni Association in 1985. Saint Mary's will hold the capital of the fund in perpetuity, and only the income derived from investment of the funds will be used to finance the scholarship. The amount of the award will be determined by the amount of interest earned by the trust fund in the previous year. Several scholarships may be awarded in any one year.

Candidates for the scholarship must qualify in at least one of three categories:

A) A full-time, first year student entering Saint Mary's having graduated the previous year from Saint Patrick's High School. Consideration will be given to students who have achieved aboveaverage academic standing while displaying leadership in extra-curricular activities. B) A full-time student having successfully completed at least one full year at Saint Mary's, again with an above-average academic standing and

involved in extra-curricular activities. C) A handicapped student who has attended Saint Mary's the previous year or who has successfully completed high school. Identification of potential candidates will be made by the University's Student Services Counsellors and the Financial Aid Officer.

In addition, special consideration will be given to candidates who are relatives of Saint Mary's alumni. The element of need will also be considered where possible.

"The committee hopes to make this one of the largest, most prestigious and eagerly sought after scholarships at Saint Mary's," says Charlie McGuire. "This is a most worthy appeal deserving of widespread support."

"The initial response has been encouraging," says Don Keleher, "but we still anticipate more responses from alumni." When alumnus Allan Turner (BA, '85) received his second degree at Saint Mary's University in May (a B.Ed.), his Aunt Jane just couldn't help but mark the occasion with a special gift — a hand-made quilt with Allan's academic achievements clearly portrayed. Allan is so thrilled with the gift that he says he couldn't just spread it over his bed. "I'm going to hang it on my wall," he says proudly.

Do we have your degree?

After the years of hard work, the hours and hours of classes, the exams, the papers, and the pages and pages of readings, a university student finally reaches that illusive goal — graduation. And what do you have to show for it? That beautiful Saint Mary's degree, printed on parchment in an elegant script, emblazoned with your name and the degree you've been awarded, signed by the president, the registrar, and the dean of the faculty you studied in, and stamped with the University's official seal.

It's hard to believe, but some alumni have not even bothered to pick up those coveted degrees. Murray Wilson, the Assistant Registrar, has about 300 of them filed in his office.

"They date back to about 1959 or 1960," says Murray. "Some of them are getting a little dogeared and may have to be redone — if their owners ever come in to claim them."

A look through Mr. Wilson's stash of "leftover degrees" reveals an interesting history of the styles of the parchments through the years. There are three or four different sizes and varieties. Some are large and ornately printed, while others are modestly small, with a clear, modern type decreeing the graduate's status. Some of the older ones are written in Latin, complete with the Latinized version of the graduate's name. And they are, of course, signed by numerous different presidents, deans and registrars.

It's difficult to understand why some alumni don't bother to claim their parchments. Perhaps those who opted not to attend Convocation assumed that it meant they wouldn't receive their official degrees, and had no idea that one had been printed for them. For others, it's a simple matter of having an outstanding debt with the University which must be paid before the degree can be handed over to them.

Whatever the reason, Mr. Wilson has diligently collected the unclaimed parchments so that if a graduate ever does return to pick one up, it will still be available.

"All you have to do to get your degree is pay the graduation fee [a mere \$20]," says Mr. Wilson. John Young awarded Father Stewart Medal

Dr. John C. Young is this year's recipient of the Reverend William A. Stewart, S.J. Medal for Teaching. Dr. Young was presented with the award by Father Stewart himself at Convocation in May.

The award for teaching was established in 1983 by the Alumni Association to recognize faculty members who have made an extraordinary contribution to the education of the students at Saint Mary's. A committee of alumni, faculty, and students select the teacher to be honoured with the award, which is named for Father William A. Stewart in recognition of his own outstanding contribution to students throughout the years. It has been said of Father Stewart that his life "is a model of what a teacher should be."


Dr. John Young has taught chemistry at Saint Mary's for 16 years, and in that time has lived up to the example set by Father Stewart, according to the people who nominated him for the award. In announcing Dr. Young as the recipient of the award, Dr. Joseph Jabbra, Academic Vice-President, said at Convocation that Dr. Young is thought of by his colleagues as "an outstanding professor," who puts a great deal of effort into his teaching. As Dr. Jabbra read from the nominations Dr. Young had received, he listed Dr. Young's friendliness and the encouragement he gives to his students as two of the things that make him a great teacher, adding that his patience, whether in the classroom or in the laboratory, is admired by both his students and his peers.

As an academic, Dr. Young has introduced two new courses to the curriculum at Saint Mary's, "Environmental Chemistry" and "Marine Chemistry," Chem. 371 and 372 respectively. He has also been instrumental in introducing computer-assisted instruction techniques into the classroom and the laboratory. Since 1970, he has received more than \$250,000 in research grants, much of it going to students in the form of summer work and research experience.

Dr. Young also keeps busy with extracurricular activities. He has sat on the Board of Governors and the Senate, the Student Affairs committee, and the Finance committee, to name a few of his campus involvements. He also chaired the Senate Curriculum Committee for three years and is currently the chair of the President's Computer Policy Committee. Dr. Young is a member of the Alumni Association.

Even with all of this on his plate, Dr. Young found time in 1984 to initiate the Student Peer Counselling Program at Saint Mary's, helping many first-year students adjust to university life.*CM*

Among the medal winners were Jenine Arab and Janet Cullinan, both of whom were awarded the Science Medal donated by the Alumni Association.


Jenine Arab and Janet Cullinan both graduated from Saint Patrick's High School in Halifax.

Three retirees bid adieu to Saint Mary's

Three long-time employees of the University are retiring this summer. Many alumni of Saint Mary's will remember Stan Spicer, the electrician's assistant who was always on hand to help with electrical repairs, Leo Gargan, the Maintenance Supervisor who kept tabs on the damages and repairs in the residences, and Biology professor Dr. Alfonso Rojo, who has taught at the University since 1961.

Stan Spicer has worked at Saint Mary's since June, 1972, when he was hired as the foreman of a groundskeeping crew of young students. What was then a temporary position turned into a full-time job which lasted for 14 years.



Other pursuits on his agenda include writing (he won third prize for a story he entered in a Spanish writing contest recenly), and studying languages (he already speaks Spanish, English, French and Italian, and he is curently taking courses in Greek). *GW*

Political Science professor named Rector of Ukrainian university

After 24 years of teaching at Saint Mary's, Dr. Theodore Ciuciura of the Political Science department will be leaving the University to become Rector of the Ukrainian Free University in Munich. Dr. Ciuciura will assume his new post in September at the small, prestigious graduate school where he studied and taught before coming to Saint Mary's in 1962. As one might expect from a native of Galacia, an area that has at different times been part of Austria, Poland and the Ukraine, Dr. Ciuciura's subject specialty has been "Comparative Government of Western Europe." Although Dr. Ciuciura will be working in Munich, he will continue to call Halifax his home, returning for a few months each year. His scholarly influence will continue to be felt at Saint Mary's; he has donated 1000 of his books to the university library.*CM*

Professor Allan Sabean was awarded the rank of Professor Emeritus of the University at Convocation in May.

Many alumni of the University will remember Professor Sabean, who started teaching in the Chemistry department in 1940. When he retired last year after 53 years of association with Saint Mary's, he calculated that he had faced 27,000 pupils in his 45 years of teaching at Saint Mary's and in the airforce reserves.

Professor Sabean is himself an alumnus of Saint Mary's. He earned his B.Sc. from Saint Mary's in 1940, after which he returned to the University to teach. He also found time to study for a Bachelor of Arts degree, which he received in 1943.

As well as teaching chemistry, Professor Sabean also offered a non-credit photography course as part of the University's adult education program. He presented the course over 45 times.

According to the guidelines for the appointment of professors emeriti, "The honorary rank of professor emeritus is awarded, upon or after retirement from full-time active academic duties, to faculty members who have served the University with distinction."

The rank of professor emeritus carries no salary or honorarium, but it does offer certain entitlements, including: full use of the University library facilities; a small office or laboratory as available and on request by the professor emeritus; the right to use of faculty secretarial facilities as available; and the right to apply and be considered for University research and travel funds.

These privileges will bring Allan Sabean back on campus from time to time. After almost 55 $^{\circ}$ years of affiliation with Saint Mary's, perhaps it will be like visiting an old friend.*GW*

Dalton scholars continue success after graduation

Where are they now? Each year, Saint Mary's University awards close to 100 scholarships to its outstanding scholars. Many of these students go on to win further accolades and reach greater academic heights after graduation. **Professor Edward McBride** of the Political Science department has kept tabs on some of the alumni who received William J. Dalton Memorial Scholarships through his department. He filed the following report with The Maroon and White.

Alumni who received the Political Science department's William J. Dalton Memorial Scholarship while studying at Saint Mary's have continued to enhance the reputation of the University with their accomplishments after graduation.

Six of the Political Science department's 1986 graduates attended Saint Mary's on Dalton Scholarships this year. Jo-Lynn Durocher (BA, '85, B.Comm., '85), who completed an additional Honours year in Political Science in May, has been awarded a \$10,000 fellowship in the Master's of Judicial Administration program at Brock University.

Scott Gillis, a two-time winner of a Dalton Scholarship (1984-85 and 1985-86), also graduated in May with a BA in Political Science, *summa cum laude*. Scott was one of two recipients of the Faculty of Arts Gold Medal. He has been a sports editor of the *Journal*, a course assistant to Prof. McBride, and a research assistant for a fellow Dalton Scholar, Randall Balcome, who received the scholarship the first year it was offered. Scott has been accepted to study law at Dalhousie in the fall.

Nick Fader, who also graduated *summa cum laude* in May, will join Scott at the Dalhousie Law School in September.

Nanette Kwong, who graduated with a B.Comm., *magna cum laude*, in May, was accepted in the Bachelor of Laws programs at Oxford University and at the London School of Economics. She has chosen to attend Oxford University in September.

Heather Brown, who received her BA magna cum laude in May, will pursue a career in public administration.

Geoff Wilmshurst, who served as student representative in the Political Science department for 1985-86 and graduated *cum laude* in May, has received a Shandong Scholarship for a year of study in China as part of the University's exchange program with that country.

Cathy Smith, daughter of Kay and the late Laurie Smith and another two-time winner of the Dalton Scholarship (1979-80 and 1980-81), has graduated from the Dalhousie Law School. While a law student and an articling clerk, Cathy also served as director of the Youth Choir at Saint Thomas Aquinas parish.

Jim MacGillivray, a former Arts Gold Medal winner who also won the Dalton scholarship both in 1979-80 and 1980-81, has graduated from the Dalhousie Law School as well and has been working with the firm of Hewitt, Hewitt, Nesbitt, Reid of Ottawa. Jim's wife, Karen Patrick MacGillivray, a 1980-81 recipient of a Dalton award, was a Norman Patterson Fellow at Carleton University. Her MA thesis, "International Technological Negotiation: A Framework of Analysis," was published in the Dalhousie University Centre for Foreign Policy Studies monograph series. She is now working towards a PhD in Political Science at Dalhousie, under two scholarships.

Pamela Hutt, another 1980-81 Dalton Scholarship recipient, is also a graduate of Dalhousie Law School. She was admitted to the Nova Scotia Bar on August 9, 1985.

Among other previous years' winners, Randall Balcome has received two grants in support of a book about Canadian Supreme Court Justices, on which he is collaborating with Prof. Edward McBride of Saint Mary's, Prof. Wayne MacKay of the Dalhousie Law School, and lawyer Dawn Russell. Mr. Balcome, who practices law with the firm of Taylor, MacLellan and Cochrane, recently argued a leave to appeal hearing before a panel of judges of the Supreme Court of Canada, which comprised Chief Justice Brian Dickson, Mr. Justice Antonio Lamer, and Mr. Justice Gerald LeDain.

Camille Cameron, who along with Randall Balcome was one of the original Dalton Scholarship winners in 1977-78, practices law with Stewart, MacKeen and Covert. She graduated from the University of New Brunswick Law School as a Beaverbrook Fellow. Camille already has several legal publications to her credit.

Brian Downie, who was awarded a Dalton Scholarship in 1978-79, is now a graduate of Dalhousie Law School and is with the firm of Cox, Downie, and Goodfellow. He was among those who attended the reception held by the Saint Mary's Law Society at the Oaks in October in recognition of the cooperation between Saint Mary's and Dalhousie Law School.

Judy Redmond's interest in government and politics was whetted by a trip to Ottawa last year, in the course of which she met Prime Minister Brian Mulroney. Judy is also a 1978-79 Dalton scholar. Her interest in constitutional law was also well served by a visit to the Supreme Court of Canada while it was in session. 
