

# "Our Father Bill"

t was a typical day at the University in the early 1960s. A room full of students waited for Father Stewart to arrive and begin teach ing philosophy class. He arrived, but started out the lecture on somewhat of a different note. He went over to his desk, picked up a book he was supposed to discuss that day, looked sourly at it, and then pitched it out the window.

"I crossed it off my must read list right away," laughs Dr. Michael J. Larsen, Dean of Arts, who remembers the story as if it happened only yesterday. He was one of Father Stewart's students.

There are lots of people who can tell you stories about Father William A. Stewart S.J. After all he's been at Saint Mary's since 1950. That was the year that the Upper Canada Province of the Society of Jesus (the Jesuits) came to run the academic and administrative duties at Saint Mary's.

On January 9, a large group of Father Stewart's University friends attended an "At Home" farewell party. Father Stewart has gone to spend some time in the Jesuit home in Toronto.

"I'm going to miss everyone," says a humble Father Stewart, who sat and smiled as each person came over to shake his hand or give him a hug. At times he even held back tears, but maintained his warm smile. "I had a wonderful time at this University."

"He's a great man," says Dr. Shelagh Crooks, Philosophy Department, who also had him as a professor. "Willie, as he is also called, was a demanding, if not to say formidable teacher, who was a philosophical model, and had a wonderful sense of humour."

Dr. Larsen says that his sincere generosity was a quality that made him a successful teacher and administrator. He held the major administrative positions at the University, sometimes several at the same time. At one point, he was Acting President, Acting Vice-President, and Dean.

"In order to keep the paper work flowing, and in the interests of procedural correctness, he would send various recommendations up the line, to himself of course wearing different hats, until

he had to make a final decision as Acting President," recalls Dr. Larsen. "As Acting President in these situations, he generally tended to accept the recommendations of his Acting Vice-President and Dean. But he didn't want it to be seen as a foregone conclusion."

Many people remember him as playing many roles during his time at Saint Mary's. One was being the backbone of the drama society. For years he was involved in all aspects of drama - even down to building the sets. "It was no surprise to find him dressed in work clothes and hammering away in the final days before a play opened," says Dr. Larsen,

One distinct memory Dr. Larsen and many others have of Father Stewart is from the annual Saint Mary's Christmas party for the children of the University community. For years, he was Santa Claus, and through his passion for acting and theatre work, he played the role children love so much. Many people, both young and old, were convinced that Father Stewart was really Santa – that's how well he played the role.

"The Santa suit, the hat and beard, rouged cheeks, hearty laugh, everything was done to make the children feel that Santa was there and wanted them to have a wonderful Christmas," says Dr. Larsen. "One Christmas, not too long ago, he couldn't find his beard, looked all over for it, but had to come without it. Well, he carried it off so well that most of the children didn't notice it until some sharp eyed youngster pointed it out. He confided that Mrs. Claus had asked him to shave it off temporarily, but that it would soon grow

back."

Dr. Larsen's wife, Jean has also known Father Stewart most of her life. Her mother, Christine Gorman, was a member of the Jesuit Auxiliary for many years and during that time a close family friendship developed with Father Stewart. "Father Stewart has always been a source of great encouragement and support for us," she says. "His advice has been very helpful and his friendship very special."

Kevin Cleary, Secretary to Senate, says that after having Father Stewart as a teacher, he ended up being hired by him as his assistant 37 years ago. "He is first and above all a superb teacher who was equally enlightening for students on the metaphysics of Aristotle as he was in instructing them in the art of set design for the drama society," he says. "In the 46 years I have been fortunate enough to know him as a professor, boss, colleague and most of all a friend, I can best describe him by quoting the words spoken by Robert Whittinton: 'And as time requireth a man of marvelous mirth and pastimes; and sometimes of as sad gravity, a man for all seasons.'"

Even though Father Stewart has left Saint Mary's, a big part of him will remain. In fact, his presence will, in a sense, remain a distinct memory, frozen in time. And for all those alumni around the world, his move to the Jesuit home in Toronto doesn't change a thing. He is, and always will be Father Stewart, the one who made Saint Mary's what it is today – a first class institution.



# Insuring your in-home office: luxury or necessity?

These days, more and more people are starting up their own small business.

Statistics Canada estimates that there are 2.5 million self-employed Canadians, most of them working at home. Regardless of what prompts them to become self-employed workers (personal challenge, economic reality, etc.), it is easy to understand why they choose their home as a place of business: existing infrastructures, stimulating personal environment, more enriching family life. This protection is intended to be broader and truly corresponds to the business needs of the self-employed worker.

By choosing from a range of specific options, it is possible to insure receivables, valuable documents, personal and employee property, and to get general liability coverage against bodily injury, property damage as well as loss of revenue protection resulting from a business interruption due to a covered loss.

#### **Computer system protection**

The advantages of this type of insurance can be illustrated by a simple example; the computer system. For most self-employed workers, it represents their main work tool, without which the business could not operate. In the event of a loss, insurance would cover not only the computer equipment, but also the software, data and fees (for example, the work that went up in smoke or the contracts that could not be honored).

When you think about all the implications that a loss can have on the life of self-employed workers, it is easy to understand why many of them have looked to insurance companies for protection. They have come to realize that, as the year 2000 approaches, they cannot afford the luxury of doing without this type of insurance.


# 1973: Remember the Times?



### **International Centre Opens Here**

Education – It is almost a neglected subject at Saint Mary's – amongst students, anyway.

But then, there's the International Education Centre, a \$38,000 project with headquarters in the Academic Complex.

Aimed at giving the Halifax community some contact with other cultures and ways of living, the project is funded by the Canadian International Development Agency and Saint Mary's to the tune of \$18,000 and \$20,000 respectively.

The submission for this project was by assistant professor Denis Healy on behalf of Saint Mary's. He is the executive director in charge of operating the centre and is responsible to a board of directors picked from the community most of whom have overseas experience in education.

"The purpose is to increase awareness, for the community to gain some tangible contact with the outside world." Healy said.

The centre concerns itself mainly with Africa now. To do this it has a small library, including African novels, all books borrowable; several slide projectors with speaking programs; cassette programs on tape; and a video-tape machine. All this material is indexed. Included in the programs are debates on Africa's problems by people in a position to do something about them, lectures on African writers and reams of material on education, health, and politics on all the countries of Africa.

In essence, this is an African geography course. You learn how Africa lives.

And to help you even more, especially if you're a movie buff, there is a projection room across the hall in room 133.

Even though the emphasis has been on only Africa, there have been 10 students in to talk about volunteering for CUSO which provides some of the materials. Eventually, Healy wants to include resources on all the developing nations in Latin America and Asia as well as Africa.

The operation, though impressive, is in the primitive stage now. The centre is starting to book groups of students and interested adults from Halifax and Dartmouth this week

Healy, though, is full of ideas and hopes for the future of the project. He sees it as a tool of education that will eventually end up helping to restructure education as we know it in high school and university.

### Relic Ripped Off, Returned

Rumour has it she came back alone in a taxi but administration officials aren't talking. According to Finance and Development Vice President, Edmund Morris, "The statue was returned Friday night at 7:00."

The statue, a wooden sculpture, of the Madonna and Child, was discovered missing from the foyer of the administration building last Friday morning.

Morris circulated flyers around campus Friday informing the student body the statue was missing, and promising no questions would be asked if it were returned within 24 hours. The statue was returned from outside the University", said Morris

Morris would not elaborate any further on the statue's return and does not intend to nail the culprit(s). "Whoever sent it back lived up to their side of the memorandum," he said.

The statue, about four feet tall, weighs 20-30 pounds. Morris said it would be difficult to put a cash value on the statue. "If you had to put a cash value on it, it would be several hundred dollars he said. However, the monetary value of the statue was the least important thing, he said.

"It is the symbol of Saint Mary's", he said.

#### Categories/Criteria

#### A. Athlete/Team

- ii) Other factors which will be considered for selection include: either: the athlete's achievements in provincial, national and international athletic competitions; character; leadership; non-athletic service to the University community; and achievement(s) in later life; or: the team's achievement(s) in provincial, national and international competitions.
- iii) Normally, consideration for selection will be given to an athlete/team following a minimum ten (10) year absence from the varsity programme.

#### B. Builder

- i) A member of the University community who has made a significant contribution to Saint Mary's University athletics for a minimum of five years.
- ii) Normally, consideration for selection as a builder will not be given to an individual until ten (10) years after their initial involvement/appointment.



B oth Dave and Jim O'Connor are glowing these days. And they have a good reason to be.

They own Glow Signs and Promotions, a promotional equipment company located in Halifax. The two brothers, who are both graduates of Saint Mary's, say that their business hasn't stopped growing since opening two years ago. "Brighter

Solutions" is their motto, and it's catching on throughout Metro and the province.

Jim walked across the stage in 1980 to receive an Engineering Diploma, and in 1992 Dave received a Bachelor of Commerce degree. Just after Dave graduated, both of them tossed around the idea of running their own business.

At first, they both knew that they wanted to be their own bosses, but were unsure as to what kind of business venture to take in life. With the quest of being successful entrepreneurs, they were on the look-out for innovative business ideas that would appeal to Nova Scotians.

It turned out that Dave noticed a new type of mobile sign while on vacation. When he returned home, he told his brother Jim all about it. So, curious as to what would materialize in the mobile sign business, they took a chance and purchased ten. Almost two years later, they now own almost 150 mobile signs.

"I owe it all to Jim," says Dave, nudging his brother's arm for fun.

"No, no. I owe it all to Dave," Jim smiles.

They take a break from the hectic schedule of the mobile sign industry to meet for an interview.

While they compliment one another for the success of the business, they also point out that their areas

"Dave has a business background, and I have an engineering background," says Jim. "These two areas fit well together. Things just could not have worked out any better for us."

They both knew that their business would experience strong growth in the first year. However, they didn't expect to more than double their initial projection.

Dave says that they have grown not only in quantity of signs, but also by product line and franchise. "Initially we only had one product, but in response to market demand, we added four more types of signs to our product line," he says.

These new signs included various portable sizes and permanent installations as well as a recent popular product in Halifax - Glowie, a walkin' and talkin' sign which is receiving rave response from a number of local businesses.

Dave explains that their company's initial growth was in sales or rentals of mobile signs, and now they are expanding into a full service promotional equipment shop. He says that Glow Signs and Promotions can now accommodate any kind of promotion.

"We provide customers with on-site decoration and equipment, such as banners, sky dancers, money wind tunnel and game cards, to name a few," he says. "Essentially, we provide service and equipment for customer enticing/fun ideas not only for business but also fund raisers and parties."

The duo of entrepreneurs only want to keep growing, as they explain how their growth is driven by customer demand. "The marketplace is very competitive so our business customers have to promote themselves now more than ever to expand or simply to keep pace," says Jim.

National sales is also in the planning phase for Glowie, and they just developed an Industrial Trade mark for the walkin' and talkin' sign. They also indicate that the Saint Mary's University Business Development Centre is now completing a feasibility study on sales and distribution options.

They even have a franchise in Sydney, Nova Scotia, which opened in August 1996. They soon plan to open other franchises in the province.


"Our franchise in Sydney has been very successful," says Jim. "The success in this part of the province is from working with the right people."

# **Professor Appears on A&E**



#### Goin' Hollywood!

Dr. Stephen Davis, Anthropology Department, was seen by millions of viewers across North America and the world as he appeared on the Arts & Entertainment (A&E) channel for the "Treasure: The Money Pit of Oak Island" documentary on Sunday, January 18.

Dr. Stephen Davis, Chair, Anthropology Department, has not yet found a buried treasure. In fact, he is not sure if there even is one, at least on Oak Island anyway. But he was recently fortunate enough to appear on one of the American giant networks, Arts and Entertainment (A&E) for their

new documentary, "Treasure: The Money Pit of Oak Island."

The documentary, which aired on Sunday night, January 18, investigated a number of theories that a treasure may be buried somewhere on Oak Island. The island, located just off the coast of Nova Scotia, has attracted a number of searchers over the past two-hundred years – all hopeful to cash in on the

mysterious fortune. Some believe that Captain Kidd, a known pirate who roamed the waters back in the 1700s, buried the treasure. Others suggest that Prince Henry Sinclair, who traveled to Nova Scotia in 1398, left something on the island.

"As a documentary, I thought they did an excellent job in outlining all the efforts in explaining the projects on Oak Island over the past number of years," he says. The documentary was made through Greystone Communications, and produced by Joshua Alper. "They outlined various theories as to what's been buried on the island, something which I thought was interesting."

Dr. Davis admits however that his comments were fairly negative in the sequence he appeared in. He commented on one story about a late 19th century excavation in the "money pit." It is said that as searchers dug every ten feet, they found an oak platform. After digging 90 feet down, they found a large rock with inscriptions. At the time a professor from a Halifax University, who remained anonymous, translated the symbols as reading: "Forty feet below two-million pounds are buried."

"I simply explained that there is no solid evidence that we can study," he says. "There is neither oak platforms nor a rock indicating a message. It's hard to support a theory when there is no solid evidence." He is also skeptical that a treasure is even buried on the island.

One of the observations he made from the program is the sequence of digging on the island over the years. "There has been so much digging on the island that the actual location of where the treasure is supposed to be buried is lost."

Now that the island has been honeycombed with digs, he also feels it would be interesting to look at all the treasure hunting that has occurred on Oak Island over the years. "To study all the different excavations on the island would certainly be another interesting angle on the topic," he says.

So, for now Dr. Davis' advice is to keep on digging. And, if you should be so lucky as to find a buried treasure, you too could be featured on A&E.

### Same Day/Next Day Transcript Service

#### Same Day Transcript Service

Requests must be received at the Registrar's Office by 10:00 am for pick-up, mailing or faxing by 4:00 pm the same day.

#### **Next Day Transcript Service**

This is offered within a 24-hour period during regular business hours. For example, if the request is received by 2:00 pm the transcript(s) will be ready for pick-up, mailing or faxing by 2:00 pm the following business day.

#### Costs

There will be an additional charge for either service:

- Same Day \$12.00
- Next Day \$10.00

This fee is over and above all other regular charges, i.e. \$5.00 transcript cost; faxing and if applicable, courier charges. It is recommended that students pick up their transcripts when ready. Students who wish to have a transcript mailed should be aware that mail does not leave the University after 2:30 pm.

#### **Blackout Periods**

These new transcript services will not be operational for the first 10 working days of January or May. Next Day and Same Day Transcript Service will NOT be applicable to those individuals who attended Saint Mary's University prior to the 1973-1974 academic year.

The Registrar's /Records Office is confident that Next Day and Same Day Transcript Service will increase options for our students in addition to providing an even higher level of service.





### **Alumnus Brings World to Saint Mary's**

Saint Mary's has a great reputation on the international scene, according to a former Saint Mary's student. It's a reputation that has resulted in a new project that will see more of our graduates in prominent positions in some of the world's largest and best known international organizations.

Scot Slessor, '86 is Youth Internship Coordinator, Peace-Building and Human Development Division, Department of Foreign Affairs and International Trade. DFAIT has just introduced a new program for Canadian youth." It's called Youth International Internship Program, and will allow successful applicants the opportunity to work in other countries for terms lasting anywhere from six months to a year.

The Saint Mary's project will provide 22 university and community college graduates with internationally-focused internship positions.

The competition was rigorous among universities in Canada to receive funding for such a project, according to Slessor. He says that Saint Mary's was chosen because of its strong academic programs and its commitment to international activities.

He says that the ultimate goal of the program is to provide Canadian youth with the global management skills they need to find suitable employment. Slessor says after candidates complete professional development training, they will start on work placements within Canada or anywhere around the world.

"The project should make a world of difference for Saint Mary's and its alumni," he says. "First, the program can give graduates of Saint Mary's the international experience they need to land a job. Secondly, it gives the University the opportunity to use this kind of program to build new bridges with





many other international organizations around the world."

There are a number of fields that students can enter in this project. They include international marketing for the Atlantic Canadian private sector companies and organizations; project management on technical assistance projects in developing countries; administration, management and marketing for private sector international organizations; and project administration and policy development and policy development for government officers and other organizations in several developing countries.

Maureen Woodhouse, Project Manager, International Activities at Saint Mary's, says that such a program is a win-win situation for a number of people. "The interns will gain valuable international world experience, and Nova Scotia employers will use the interns to expand and explore international markets," she says. "Also, international employers will use the Canada-specific knowledge of the interns to improve their linkages with Canada, and Saint Mary's University, through this network of interns and employers, will increase its international profile and improve its links to the private sector both within Nova Scotia and throughout the world."

The University has received funding from both the Department of Foreign Affairs and International Trade and from Human Resources Development Canada to manage the project.

## **Great Expectations** for Women's Hockey

The Huskies' Women's Hockey Team vaulted from a relatively unknown club sport at Saint Mary's to national status over the course of one season. They will go down in history as the first ever winners of the AUAA women's hockey title and the first team from the Maritimes to compete in the first ever CIAU's.

"It's a huge development in women's hockey to be the first winners," says coach Lisa MacDonald. "To lay claim to the first ever championship."

Even though the Huskies' didn't capture a national title, nothing could dampen the spirit of this team of women who clinched the Atlantic title after playing just nine games during their regular season. What makes this accomplishment even more remarkable is that the women's hockey program at Saint Mary's operated as a club sport under the recreation program up until the championship series. They declared varsity status only recently in order to compete at the AUAA's.

The women received team uniforms just prior to leaving for the Nationals. They had been wearing old jerseys from the men's program. "They (the University) didn't want to send us to a national competition looking like the Bad News Bears," says MacDonald.

The old jerseys couldn't have been that bad though, they won an Atlantic title in them. Maybe the jerseys even brought them a little luck in each of their four games played at the AUAA's held at UNB in January. Three of their four games went into overtime, but the Huskies' still managed to win all four.

"We were very surprised. Things were looking bleak," says MacDonald. "We were short on the bench and the girls were running out of gas. But we had decided to make Saint Mary's the hotbed of women's hockey in the Atlantic provinces. That was our driving force."

MacDonald was realistic about her expectations for the team at the national level. "We are a very, very young team," she says. Many of the teams they faced have 10 and 15 years of experience at the varsity level. What she does hope came out of the tournament is some national attention



to women's hockey in the Maritimes.

MacDonald, who played five seasons with the program at Concordia, feels that support of women's hockey at the university level has increased overall in the past few years. "The exposure at the Olympics certainly helped. We will continue to build on the momentum of the Olympics.

There has also been an increase in the enrollment of young girls in hockey," she says.

"We are very pleased to know that the women's hockey team has done so well in their first year. It will certainly help us recruit for the program in the future," says Larry Uteck, Director of Athletics and Recreation. "We are very proud of them."
