# Saint Mary's Alumni Volunteers Lead the Way

The Canadian Executive Service Organization (CESO) is a not-for-profit organization that helps build independent communities. Over 3,000 Volunteer Advisers (VAs) for CESO share their professional experience by serving as mentors, advisers and trainers to CESO's clients and partners at home and abroad.

Two of CESO's outstanding volunteers are Jim Kelly, BEd'70 and Jim Ross, BA'86.

Last Fall, Jim Kelly delivered a two-week 'train-the-trainer' program to English language teachers at the State Maritime Academy in Batumi, Georgia. Batumi is Georgia's second largest city situated on the Black Sea coast, about a seven-hour train trip from the capital, Tbilisi.

Jim saw many volunteers throughout the country, providing various types of assistance to a people whose dire need is surpassed by their gratitude in receiving a helping hand. His task was to deliver an interactive program that delivered a broad range of approaches, methodologies and techniques used in the teaching of English as a second language, with emphasis on the teaching of Maritime English and its relevant technical terminology.

Jim Ross is recently retired and was looking for a volunteer opportunity where he could apply his skills and CESO offered the opportunities he was looking for. His first assignment was with Apaqtukewaq Fisheries Coop Ltd., Chapel Island First Nation. The community recently built an oyster processing plant that needed to be certified by the Canadian Food

Inspection Agency. Jim helped them prepare a Quality Management Program (QMP) and a Hazard Analysis and Critical Control Point (HACCP) documents to meet the regulatory specifications for certification. The assignment took several months to complete and in the end the client gained an in-depth appreciation of what it takes to ensure that their plant is producing a safe and healthy product.

Jim Kelly and Jim Ross are two Saint Mary's University alumni who are volunteering and making a difference in the lives of others.

Since 1967, CESO VAs have completed approximately 40,000 projects in more than 50 countries.

At a special event held at the Atlantic Centre, the University officially announced the Honourable Myra A. Freeman, the Lieutenant Governor of Nova Scotia, as the Honourary Patron of the Atlantic Centre.

The event attracted droves of students, faculty, staff, alumni and friends of Saint Mary's.

Those who spoke at the event included Dr. J. Colin Dodds, President of Saint Mary's; Dr. Martha Jodrey, Special Advisor to the Department of External Affairs and Supporter of the Atlantic Centre; Dr. David Leitch, Director of the Atlantic Centre; and the Honourable Myra A. Freeman.

"This is truly an honour to be named Patron of the Atlantic Centre," said her Honour.

"I look forward to working with everyone to help make the Centre grow, which is a benefit to students who desire a higher education in our society."

"I applaud the University's role and vision to ensure accessible education for students with disabilities and admire the commitment and support to our Canadian youth and those from communities across our globe," she added.

Dr. Jodrey stated, "We are proud to have the Honourable Myra A. Freeman join our team of people at the Atlantic Centre – all of whom are committed to ensure students reach their life goals. The Atlantic Centre has endured so much wonderful growth over the last 30 years, and today is another special step in our mission of ensuring students from around the world will always have access to earning a university degree."

The Honourable Myra A. Freeman presented a special certificate of appreciation to Dr. Leitch. In turn, Dr. Leitch presented her Honour with a special plaque acknowledging her new appointment.

Melissa Myers, a student at Saint Mary's (double major in Psychology and Sociology), presented her Honour with a gift certificate from Halifax Seed.

Accessibility for persons with disabilities has long been a cornerstone of the philosophy of Saint Mary's.

For over 30 years the University has played a leadership role in ensuring that higher education is accessible.

In 1968, the university constructed a residence with accommodations specifically designed for students with mobility impairments. In 1975, a tape library was established to serve students with visual impairments at the post-secondary level. Initiatives to accommodate students who are deaf or hard of hearing began in 1980. In 1985 the Atlantic Centre, under the directorship of Dr. Leitch, became a reality.

Today, almost 300 students rely on the Centre for a wide variety of services. Although the majority of these students attend Saint Mary's University, the Atlantic Centre helps clients throughout the province of Nova Scotia. The Centre has developed an international reputation as a leader in providing support services for students with disabilities at the post-secondary level. The Atlantic Centre was one of three centres of specialization in Canada supported by the Federal Government to enhance the full participation of citizens with disabilities in higher education.


# Professor gets top marks from alumni, students, and faculty

Dr. Edna Keeble is this year's recipient of the Father William A. Stewart, S.J. Medal for Excellence in Teaching. The award is presented annually by the University's Alumni Association to a professor who has made an extraordinary contribution to the education of students through teaching in the university tradition of quality education.

A faculty member at Saint Mary's since 1990, Dr. Keeble received praise for her outstanding work in the classroom and for her dedication to and excellence in scholarly pursuits and community outreach activities.

"I am so humbled and honoured by this award because I consider it such a privilege to be in the classroom. I take my teaching responsibilities very seriously, and every year I hope that I make the sort of impact on

students that encourages their love of learning," says Dr. Keeble.



Trained in the area of Canadian foreign policy, Dr. Keeble's research interests are broad-ranging but centre on the re-definition of security. She has researched and written on gender and Canadian foreign policy;

military prostitution and sex tourism in the Philippines; and sex trafficking in Asia. Dr. Keeble has just completed a three-year university-community collaborative research project on immigration and security; and in that capacity she was appointed to the federal government's Cross-Cultural Roundtable on Security which advises the Public Safety and Justice Ministers. Her most recent research interests centre on marine security in the post-9/11 world.

"Dr. Keeble is simply one of the best teachers in political science," says Dr. Leonard Preyra, Chair of the Political Science Department at Saint Mary's. "She is not just an exceptional teacher. She is an all-round scholar, policy maker and innovator who brings a great deal of her extracurricular work into the classroom to enhance teaching and learning for students."

## Students and alumni alike echo his views.

Andrew Creighton, a Saint Mary's alumnus, states, "Dr. Keeble always brought a positive attitude and enthusiasm to class that was infectious, but what I remember most about her classes is that she never just lectured. She facilitated discussions about course material. She encouraged us to give our opinions and to question our assumptions. I believe that Dr. Keeble embodies all of the qualities of an excellent teacher. Her encouraging attitude, knowledge and teaching style stimulated a desire in me to learn, and to this day I remain interested in issues covered in her courses."

# A Leading Vintage

The wine industry, like any other sector of society, has leaders and followers; usually the leaders are the people that take chances and see opportunities. This past winter with the assistance of **Phil Cochrane**, **BComm'72**, of Wine Vision, I had the opportunity to meet two of South Africa's great wine leaders.

Charles Back is the 3<sup>rd</sup> generation of his family to farm and make wine near Paarl in the historic Cape Region. Under the name Fairview Wines, Charles has lead the gigantic flood of South African wine into North America with his innovative, 'tongue in cheek,' Goats do Roam label. These beautifully blended wines based on Pinotage, Chenin Blanc, Syrah, and a host of other varieties were built for easy drinking with medium flavour profile foods. The result: Goats do Roam has become the largest volume selling South African wine in North America, followed by Charles' Fairview and Spice Route wines. While visiting their vineyards Spice Route Estate Manager, Charles du Plessis, brought in a backhoe to dig holes in the vineyard to show us the stony terroir that imparts the mineral tastes in his Viognier and wines. The terroir is an integral part of the grape growing process that is fascinating to any farmer.

Charles shows himself as a leader in areas other than just the vineyard. He has taken the same role of leader with his extended family of Black employees.

South African farmers have large numbers of Black families that were considered part of the land title living on their farms. Under the new post-apartheid government the employment, education and health care of the families became the legal responsibility of the landowner. Some farmers have seen this as an encumbrance, while others have recognized the social and moral obligations to these extended families and have blossomed with the new reality. Charles Back falls in the latter group; through his inclusion of Black workers as legal business partners in his new operations they have taken over a stewardship of their land and become more committed to growing the "New South Africa." In this traditional conservation society Charles' lead was seen as 'just going too far,' yet a few short years later these moves are seen as the catalyst to the South African Experience. Recently, while sharing a glass of the Goats Roti with Dave Randall, BA '74, we were speaking about the leaders we have

met during our ongoing relationship with Saint Mary's and both of us concluded that it was the leaders with a commitment to those around them that we respected the most. Charles Back is one of those leaders that leaves a lasting legacy and impression.

Michelle du Preez and her husband Roelf are part of the new dynamic leadership that is propelling South Africa forward in the world of organic wines. This inspiring couple have built their business and the role of the Black families within their farm on Roelf's mantra, 'It is my belief that we do not inherit the land from our forefathers, but that we borrow it from our children.' To this end, as a family they decided to shift their farm over to organic production in the hope that it would provide better wine, a sustainable future for their children, and a safer environment and working conditions for the Black families. Grapes in many ways are like people: the more challenges they face in their growth, the more character and depth they will show later on. This truism is evident in all the Bon Cap wines where even their blush has a lot of flavour to back up the brilliant rose colour of the wine.


Recently I had a glass of The Ruins Pinotage with my old buddy Fred Spencer, BA '73 at his St. Margaret's Bay cottage, the medium structured, youthful wine with sweet ripe berries and red and black cherry flavour is an ideal "summer lifestyle" wine for the BBQ. Our conversation lead us to reflect on some of the people we had seen as leaders while attending Saint Mary's, the usual names came forward, 'The Hen', the late Terry Donahoe and the many others that we consider icons of Saint Mary's past.

We concluded that the greatest benefit of being exposed to these leaders was they in turn inspire those around them to be leaders.





#### Warm Hearts


A comprehensive university education exposes students to perspectives and experiences from around the world.


Four of the Richardson's six children attended Saint Mary's and their daughter, son and son-in-law are

When the final horn sounded it wasn't the scoreboard that fans were focused on but centre ice.


Members of the Huskies presented the Aigles Bleus with money collected in support of Sebastian Savage, a player with the Moncton squad who was paralyzed during a game in late October.

Fans in the stands and our University community couldn't agree more.







# Steven J. Landry

Has the Drive for Success

Steven J. Landry recently had the chance to visit the Saint Mary's campus, and he was thrilled to return to his alma mater.

You see, he was on campus to take part in this year's Turning Points in Leadership Dinner and the third annual Sobey Leadership Forum on April 6th and 7th, 2006. These events were organized by the Sobey School of Business and the University's Alumni Association. Landry was the keynote speaker at both events, and everyone was thrilled to hear the 48 year-old talk about what he knows best, leadership.

Since graduating with a BComm. degree from Saint Mary's in 1982, he's been steering his way through many successes in the world of business. The road has been long, but he's certainly enjoyed the ride. He first joined Chrysler Group, Canada as a Distribution Analyst for Western Canada only a few months after crossing the stage with his degree from one of Canada's oldest and leading institutions of higher learning.

He's gone on to hold a number of prominent positions with Chrysler Group over the years. In November of last year, he was appointed President and Chief Executive Office for DaimlerChrylser Canada. Prior to this position, he was Vice President – Global Dodge Marketing in Auburn Hills, Michigan where he was responsible for the development in implementation of all aspects of the Dodge Marketing and Product Planning activities.

He holds a Master of Business Administration (Executive) degree from Michigan State University, and currently serves as Chair of the Canadian Automotive Partnership Council (CAPC) Trade Infrastructure Subcommittee and is a member of the CAPC Committee. He is also a member of the Canadian Vehicle Manufacturers' Association, University of Windsor Board of Governors and the Conference Board of Canada. As well, he is also the 2006 Honorary Co-Chair of the Great Valentine Gala which benefits the Canadian Foundation for Physically Disabled Persons.

His life has been nothing but full of success. But, as he indicates, success doesn't come easy; it's based on hard work and dedication. This is what he learned during his days at Saint Mary's, and this is what has put him in the drivers' seat.

# Do you have any memories that stick out in your mind that you would like to share during your days here in the late 1970s and early 1980s?

I had four great school semesters at SMU. While I arrived knowing only a few people from Dartmouth High School, I finished four years later with good friends from around the world. "Matt Minglewood" and "Dutchie Mason" evenings at Saint Mary's seemed to create a great social atmosphere, especially after savouring an afternoon win from our football or hockey Huskies.

# So, you headed out West in 1982 in order to take your first job with Chrysler as a Distribution Analyst. What was it like starting out in this role at such a young age?

I had three grueling interviews at the Vancouver office of Chrysler Canada Ltd., competing for the position of "distribution clerk." With only an iron and no thread and needle, I hemmed my newly bought "K-mart' slacks with scotch tape... It wasn't pretty. It was an interesting time to start a career, as Chrysler was losing sales and market share and was grappling with external pressures such as high interest rates. Those tough times gave me the opportunity to learn about the company and appreciate how far we've come.

## Can you tell me what your career was like over the years and highlights you want to note in your various roles with DaimlerChrysler?

With no formal training in the early years, I relied heavily on "watching and learning" from my peers and natural mentoring. Thankfully, management within our company was also very helpful and encouraging along the way. Some of the highlights of my career include becoming Regional Manager of Atlantic Canada at 31 years old; completing my MBA (Executive) in 2000; becoming a Corporate Vice President of DaimlerChrysler AG; taking on the role as President of Chrysler Europe all within a 60-day period; and in November of last year addressing the Canadian dealer organization in Las Vegas as President and CEO of DaimlerChrysler Canada.

## What's it like being the President and CEO of DaimlerChrysler Canada?

After spending time in the U.S. and Europe, it feels good to be back at DaimlerChrysler Canada. As an automotive company in an extremely competitive industry, there is an important balance between sales volume and net profit. To manage this balance, I am now utilizing a very wide range of skills I have developed through experience and time. We also have approximately 12,000 employees and over 470 dealers across Canada. With a focus on products and sales, we also have corporate image to promote and protect. Being involved in public relations, community relations and government affairs is new and exciting for me.

## What sort of leadership skills have you learned over the years that have led you to such great success?


Over time, I have learned equally how "not" to do things as well as how "to" do them. There is no replacement for hard work. There is no such thing as a 40-hour work week. You need to learn as much as possible about your industry and always keep current. As a leader, you also need to be open to new ideas and continuous development. I am still developing my "listening" skills that when applied properly, produce great benefits.

## How has Saint Mary's University played a role in your big achievements?

Saint Mary's University has a good reputation for developing "hard workers." In my mind, SMU is like the "Dodge" brand — bold, powerful, gritty, a sort of 'underdog' that people want to root for.

## What advice would you offer Santamarians who want to go on and be CEOs/Leaders?

Develop five-year plans. In the corporate world, count on changing jobs every two years, but have a good idea where you want to be in five years. As well as supporting your boss at 110% level, make sure you are also there for his/her peers as well. And, always accept extra curricular assignments as you will get credit behind the scenes.

It's a new chapter in the storied history of the Saint Mary's Huskies football team. Steve Sumarah has been named the head coach of the Huskies football team.



He was named an Academic All Canadian by the CIS while attending university.




