A BASIS FOR EXECUTIVE ACTION

September 1975 marked the 10th anniversary of the beginning of a period of unparalleled growth and development at Saint Mary's. September was also the month when this year's Alumni Executive began an in-depth study of the short and long range goals of the Association. This study brought to light some very interesting questions which have developed as a result of the University's expansion.

A number of these questions are of a technical nature. How is contact maintained with existing Alumni? How is contact established and retained with an ever increasing body of new Alumni? What type of record system will best provide an accurate reflection of the cosmopolitan, educational, cultural and geographical nature of today's Alumni.

Of much greater importance, however, are the questions of a more personal and philosophical nature. What is the role of an Alumnus in today's University? How do Alumni, who attended before its apparent metamorphic development, identify with a Saint Mary's which, for many of them, appears to be a new and almost alien institution? What of Alumni who attended Saint Mary's during its more changing years? What common bonds do they have with those who attended before or after them?

The technical questions the Executive has left mostly to Mike Tingley and the competent staff of the Computer Center of the University. It is concentrating its efforts on bringing as many of the Association's resources as possible to bear on the more vital philosophical question. The President, Bob Ruotolo, has taken, as the basis for Executive action, the premise that Saint Mary's University is a community and Alumni are full and continuing members of that community. This membership is based on the earliest traditions of the University and indeed is given legal expression by the Saint Mary's University Act of 1970 which states in Article 4 — MEMBERSHIP — Subsection 1: "The University shall consist of the Board and officers of the University and of all who are entitled to elect members of the Board".

As continuing members of the University community, Alumni not only enjoy certain rights and privileges, but because of the benefits they have derived from their early membership in the community, they must accept a proportionately greater responsibility for its continued good health; moral, educational and social.

The Executive is confident that the secret to a vital Alumni Association lies in providing the means whereby all Alumni can share in the exercise of this communal responsibility. Its work this year has been directed towards providing these means.

ANNUAL DINNER DECEMBER 8, 1975



The Class of 1950 played a prominent role in this year's celebration of the University's feast day. A reunion luncheon was held at noon. Class President, Edward Murphy, was joined by classmates Kenneth Butler, Roger LeFrank, William Russell, Bernard Kline, James Hemon, Thomas Nickerson, Jim Fitzgerald and Arnie Patterson.

Special guests for the occasion were Father M.J. O'Donnell, S.J., Deans Emeriti Dr. Harold Beazley, Dr. James L. Ryan, Professor Allan T. Sabeau and Dr. D. Owen Carrigan, President of the University.

"Moments to Remember" was the order of the day. They ranged from Roger LeFrank's description of a private tutoring session in foot drill with the R.S.M. of the C.O.T.C., through stories of "Bucks" English and debating classes to Al Sabeau's story of the totally engrossed photographer who walked up and over a step ladder in his efforts to get just the right angle for his shot.

An afternoon tour of the University led to a comparison of present day facilities with those of twenty-five years earlier. This comparison, unlike T. S. Eliot's "April", evoked pleasant memories which prompted a spate of anecdotal stories concerning the Saint Mary's of Windsor Street days. The afternoon was topped off by a visit to Father M. W. Burke-Gaffney, S. J., at the St. Vincent's Guest House.

In the evening the scene shifted to the Ignatius Loyola Building and the Annual Alumni reception and dinner. The members of the Class were introduced to the over two hundred guests and were presented with mementos to their reunion. Ed Murphy made a presentation to Allan Sabeau on behalf of the Class of 1950. Ken Butler toasted the University and then the 25th year Alumni sat back to enjoy the 1975 Alumni Dinner.

The Dinner Chairman, Dick MacLean, kept the evening moving in spite of early technical problems and a very long agenda. Halifax Mayor Edmund Morris, former Vice President of the University, inducted the guest speaker into the Ancient and Venerable Order of the Sou'Wester. Father J. J. Hennessey, S.J., was



presented with a scroll in recognition of his long service and devotion to Saint Mary's. The document was signed by another old Jesuit boy Pierre Elliot Trudeau.

Angus MacFarlane, M.P. for Hamilton Mountain, Ontario, in his address on the War on Inflation, stressed the government's determination to have the anti-inflation program succeed. He also predicted that the real heroes of any generation — the Common People — would face up to the challenge and overcome the materialism of the world.

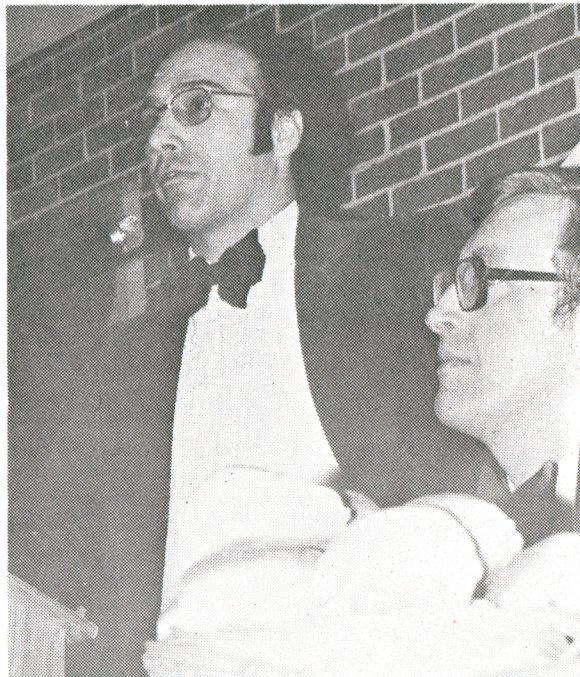

OLYMPICS '76

Associate Alumnus BRIAN HEANEY who is on leave from Saint Mary's University to coach the Canadian Women's Olympic basketball team, was interviewed earlier this year by Alumnus Heather Harris.

Your selection as a coach for an Olympic team certainly was greeted with pride and enthusiasm by Santamarians. It's going to involve a tremendous amount of travelling, which we can follow in the news media — what is your anticipated schedule for the next few months?

We begin with a European five week stint which will take us into Bulgaria, Hungary, Yugoslavia and Czechoslovakia. We will be participating in several tournaments and, as well, joint training sessions, which will provide an opportunity for exchanging ideas and methods of coaching with other national teams. In September, we head for the World Championships in Bogata and from there to Mexico City for altitude acclimation for the Pan-Am Games in October. We have a short break then and in November we head for China for a three-week exchange program. We then return to home base here in Halifax and prepare to head for Cuba at Christmas time for an exchange tournament there. From January things are still rather up in the air, but hopefully South America, Korea and Brazil may be included in the early part of the year. Spring, hopefully will see us in Western Europe for more top calibre competition.

You brought Saint Mary's the CIAU National Championship — who will be taking care of the team this year?

We were very fortunate to be able to obtain the services of Ed Hall. Having worked so closely with the players and program, I couldn't have made the decision to accept this appointment unless I knew the team would be in good hands. Any coach has a responsibility to his players — many will eventually go on as players or coaches and their program shouldn't be interrupted. Ed's background in coaching at the University of Tennessee and Old Dominion in Norfolk, Virginia, as assistant coach and Ed's working with two of the most outstanding coaches of today, Sonny Allen and Ray Mears, rate him as a man able to keep our team at championship level.

You've been instrumental in tournament organization in this area — are you going to have any time for involvement there?

It would be impractical to thrust some of these things on Ed's shoulders. My responsibilities with the national program are complete, but I will be available to offer any advice and suggestions I can. It is disappointing that this year when the national championship games will be in Halifax I won't be able to participate, but I know that we have an excellent chance of being in the finals again. Saint Mary's is the only school in the country that has competed in the finals for three straight years. Also, the National Basketball Festival will expand this year. Four local high school teams, and four intercollegiate teams have been invited to participate and we are very hopeful that an international women's section will take place this year. We are seeking commitments from several countries such as

Brazil and Hungary and this would perhaps take place the 8th and 9th of January. This would give the festival national and international stature.

Back to Olympic talk — what kind of setup are you working with as you make this drive for the Games?

The Olympic movement with C.A.B.A., our basketball governing body, intends to maximize our efforts to do as well as possible. In order to do this we have to be together for the year. This involves a great deal of personal sacrifice from everyone involved. People have had to give up jobs, be separated from their families for a number of months and things of that nature. We have to do a great deal of work each day. Right now we have been practicing twice a day, which is about 4 1/2 hours on the court and that is a tremendous physical drain. In administrative terms provision is made for a Head Coach. We are very fortunate to have people involved at the local level, which is a tremendous asset for expediency's sake. Frank Baldwin, the Provincial coach has been assisting. Dr. Jim Logue from Wolfville, a personal friend and one time coach of mine, and Doug Wright, my assistant coach from the University, have also been assisting. We are hoping to have Doug participate as much as he can with the team being based in Halifax and also make some of the trips throughout the year.

You touched briefly on the sacrifice involved. TIME MAZAGINE and CANADIAN WEEKEND have devoted space to situations with athletes — what about yourself as a coach?

The biggest sacrifice for me will be the time spent away from my family. Our children are four, three and one and Liana will have to almost totally handle everything at home. As with the athletes, there is this total disruption in family life. Also being away from the SMU team with which I have been so involved is another sacrifice, although that is alleviated by having Ed at the helm. On the other hand the experience that I will receive on every level of coaching techniques, administrative handling of the team, meeting and exchanging views on the international scene, certainly will enable me to bring back a great deal. A parallel is, perhaps, a sociologist doing a Ph.D. at local university. This is in a way, my opportunity to a Ph.D. in basketball, with my "university" being the world basketball courts. It's going to be a tremendous learning and sharing opportunity.

On last question, Brian, where do you expect your toughest competition?

I think right now at the women's level, Russia is certainly outstanding. They've got big, strong players and in Russia a great deal of time is spent keeping their national team together. Eastern European countries should be excellent. Korea and Japan have had a great deal of success in world competition, probably because of their great speed and quickness. They utilize that to great advantage. Cuba is an excellent basketball country. Fidel Castro is a very big basketball fan and he'd like to see his country do well.

This is going to be an interesting year for us to be able to watch a SMU coach in world wide competition. BEST OF LUCK!

RICHARD BISHOP, B. Comm. '73, B.Ed. '75, is Brian Hearney's in-town trainer and was anticipating an interesting year when he talked with Heather Harris a few weeks ago.

You've been selected to be a trainer for the Olympic team. What kind of experience have you gained here at Saint Mary's?

There is one trainer here, Gerry Walsh, but I have four years experience with both hockey and football. For the last couple of years I've been helping out with special injuries with basketball.

What kinds of injuries?

Well, for instance, Lee Thomas had a bad back from a game against Acadia and I treated that with back rubs and a brace. Several other players would need an ankle tape job and fingers and thumbs might need special attention. This past year I became more involved with the basketball team and Coach Heaney called me when the women's team was coming into town and asked me to help out.

You are going to be teaching full time this year, aren't you?

Yes, I will be. I'll be available to assist when the team is here and will be going on the initial European trip.

What kind of preparation does a trainer make for a five week trip. What kind of check list do you make? What do you have to anticipate?

Up-to-date medical files on all the players are a must when you play anywhere away from home base. First the trainer inquires about medical facilities — where is a doctor, will he be in attendance at the games etc.

What will you take with you for international travel jaunts?

You want to come fully prepared. We will be taking more than enough tape to supply us because you don't know what facilities are like. We take plenty of Vitamin C and B+ tablets to supplement their diet. The girls are experienced travelwise and know what to expect in the way of food — where you can and can't get what they would want — any problems with milk, water etc. I have a list of all the training supplies I need and I'm confident with that we can take care of most problems that might arise.

How many girls are on the team?

Twelve — this is what provision is made for — and they are top-notch. Twenty-five of the best in the country were selected and then the final twelve participants. They have made a lot of personal sacrifices, but are a really dedicated group and will do a great job representing Canada.

What is the provision for trainers at the Olympics?

As I understand it at the moment, you make application to be a trainer and if you are chosen you are then assigned to a particular team. You might not necessarily get the team you've worked with. That seems to be the arrangement at the moment, but it might change.

Are you pretty excited about the whole thing? I am!

Oh yes — this kind of thing is great for stronger ties in the country. Also, with Olympics the emphasis is on physical fitness — a sort of awareness of Roland Michener's theme of keeping Canada fit. I think at its best the Olympics promotes good will among nations and is a really nice kind of "people" thing — sort of a large scale edition of the feeling and spirit here at Saint Mary's.

BASKETBALL BOOSTER CLUB

Those of you who have been following the basketball Huskies for the past two years now realize that they have quite a following in the form of a booster club. This club is a group of interested basketball fans who gather together after every home game of the Huskies and thoroughly enjoy the atmosphere that gatherings such as these produce. The general format is that after every home game facilities are available at the University — a master of ceremonies is obtained, normally a member of the broadcast media. The special speaker is generally the coach of the Huskies, Ed Hall; then comments on the progress of the team; then, if there is time, a basketball film may be shown; at times the film of the actual game that was played that evening. Refreshments are available and basketball literature and information is distributed. All in all the gatherings are most interesting and enjoyable. The membership has grown from 62 members last season to 108 this season and we are striving to have the club

grow even stronger. Any person wishing to become a member of the Huskies Basketball Booster Club need only come to the home games, drop in after the game at the gatherings and enjoy the fellowship. There are no commitments as such for membership, but the club does have fund raising projects from time to time, and in turn, use the gains from such efforts for the benefit of the club and do what they can to assist the basketball team in order to assure the team that they do indeed have the full support of not only the University but many of the Alumni and interested friends.

This season the Booster Club has taken on the project of brightening up the basketball dressing room, and we might add, that after a new rug was installed on the floor, new stools were purchased for each individual player, name plates placed on their lockers, the room completely painted, we were quite proud of our efforts. Needless to say the members of the team, coach Ed Hall, and our assistant coach, the great

Mickey Fox, are more than grateful for the efforts of the Booster Club.

The Booster Club now finds itself busily preparing for the A.V.A.A. Playoffs along with the C.I.A.U. National championships, which are to be hosted by Saint Mary's this year. So if you find yourself in town, or are planning to attend the games, please feel free to inquire about the fan club and its activities and come along and enjoy the fellowship. Discussions have taken place with a view of obtaining an Alumni Room or area in the University where material relating to the history of the University can be displayed. The Executive is also very conscious of the need for continued use of the traditional insignia and colors of the University in publications, advertisements and on the playing field. It is also examining a proposal for the establishment of a Founder's Day. This will provide an opportunity to acknowledge the contribution made by Bishop Edmund Burke, Archbishop McNally, the people of the Archdiocese of Halifax, the Irish Christian Brothers and the Jesuits and others in the development of Saint Mary's.

Efforts to develop a relationship between present day students and Alumni have been met with enthusiasm by the Students Representative Council. At the request of the Council, members of the Executive attend regular council meetings. A Student-Alumni Dance was successfully co-sponsored with the Residence Students' Society. A continuing liaison is maintained with the representatives of the Senior Class and plans are underway for Alumni participation in at least one of their social functions.

The Executive maintained a very close interest in the union negotiations last fall. It held discussions with the faculty. Subsequent to the signing of an agreement, it reviewed with a number of the Alumni who are faculty members, the bargaining process and the various situations which had developed during the course of it. It is sponsoring a Faculty-Board of Governors social evening in order to provide an opportunity for the two bodies to become better acquainted.

A committee has been set up to examine all facets of the production of the Maroon and White. The work of this Committee will result in a publication which will be reflective of, and of interest to, all generations of Alumni.

The Finance Committee has been charged with the responsibility of reviewing the dues system with a view to changing to a contribution system. In addition, the Committee has been asked to prepare a proposal which will enable the Alumni to aid, in a direct monetary way, the development of the University.

The Executive invites all Alumni to join with it in its efforts to fulfill the responsibility incumbent on all Santamarians. Their planning and work is already producing tangible evidence of success in the maintenance and development of the community of Saint Mary's; your involvement will assure that success.

FLORENCE FOLEY

The many friends of Florence Foley were saddened to learn of her death at home in Halifax on Sunday, January 25. Florence arrived at Saint Mary's in 1942 and was a devoted member of staff for the following twenty-two years. At the beginning she served in many different capacities, as bookkeeper, accountant, records officer and registrar, and finally as a librarian.

It is as librarian, perhaps, that she is best remembered by so many students and members of faculty. She was always ready and willing to give what help she could and she spent endless hours in gathering materials for a student's essay or a professor's research. More than that, she was interested in the students as individual persons and concerned about all their problems, including those not of an academic nature.

Florence's efforts to help others were not confined to the University. In 1956 the late Archbishop Berry bestowed on her the medal Pro Ecclesia et Pontifice for her outstanding work at the School for the Blind. She was a member of St. Theresa's Catholic Women's League, the Convent of the Sacred Heart Alumnae and Children of Mary, The St. Vincent Guest House Auxiliary, and Civic Hospital Auxiliary. She was truly a "woman for others".

Her long final illness she bore with an admirable Christian spirit, still helping others by the power of example. Saint Mary's was the richer for her presence and is much in her debt. The University's sympathy goes out to her relatives and friends, and especially to her devoted sister, Ethel. While the pain of loss is naturally there, there is also comfort in the thought that heaven has gained a new saint.
